SUBJECT: 2009 Annual Report on Council Remuneration and Expenses

RECOMMENDATION

THAT Council receive this report for information.

COUNCIL POLICY

Council has enacted Bylaws 7465, 8904 and 8999 under Section 196 of the Vancouver Charter to provide remuneration to members of Council and reimbursement of expenditures made or expenses incurred while representing the City, engaging in City business or attending related meetings.

PURPOSE

Section 196A of the Vancouver Charter requires:

1. At least once a year, Council must have prepared a report separately listing for each Council member by name
 - a. The total amount of remuneration paid to the Council member
 - b. The total amount of expense payments made under section 196.
2. The report must be considered by Council at a Council meeting that is open to the public and a copy of the report must be made available for public inspection at City Hall during its regular office hours from the date when it is considered by Council until one year after that date.
