RECOMMENDATION

- A. THAT Council approve a total of \$643,000 in 125th Anniversary Grants—Largescale Component—to 25 organizations as listed in **Appendix A**. Source of funds to be the \$400,000 balance of the Cultural Tourism Product Investment Grant Program, \$70,000 from the New Cultural Grants budget and \$173,000 from the Cultural Tourism Strategic Planning Reserve.
- B. THAT Council approve a total of \$268,000 in 125th Anniversary Grants—Smallscale Component—to 37 organizations as listed in **Appendix B**. Source of funds to be the Cultural Tourism Strategic Planning Reserve.

COUNCIL POLICY

Approval of grant recommendations requires eight affirmative votes.

PURPOSE

The purpose of this report is to recommend grants to 62 not-for-profit organizations for a total of \$911,000.

BACKGROUND

Council approved the creation of the 125th Anniversary Grants program on July 6, 2010. The large-scale and small-scale components of the grant program provide a point of access for community members to help the City celebrate its 125th anniversary of incorporation in 2011. The grant program forms a key part of a year-long celebration framework and is designed to

provide direct financial support to new events or initiatives or (enhanced) existing events or initiatives which incorporate a 125th anniversary celebration component.

The grant program goals were informed by the Vision Statement of the 35-member Celebrate Vancouver's 125th Advisory Committee who, over the spring and summer of 2010, set a high-level vision and framework for the City's year-long celebration, which is:

Building on the momentum, energy and spirit generated during the Olympics, and through a growing awareness and understanding of our identities, first nations' heritage and cultural diversity, the people and neighbourhoods of Vancouver feel excitement, pride and enthusiasm for a celebration in recognition of Vancouver's 125th with activities that engage and enrich our society through the celebration of art and culture.

Significant awareness-building about the funding opportunity was undertaken between August and September 2010: multiple public information meetings were held, e-newsletters were sent to community members, and paid (multi-lingual) ads were placed in several local papers. Over 250 community members attended five information meetings leading to 143 applications (including 31 new applicants) to the program.

The second and final deadline of the 125th Anniversary Grants Program (for both large-scale and small-scale components) will be in February 2011.

DISCUSSION

Program Description and Objectives

The 125th Anniversary Grants Program has been established to support the growing excitement, pride and enthusiasm for Vancouver's upcoming 125th anniversary in 2011. This program is a time-limited opportunity intended to foster awareness and understanding of Vancouver's identities, first nations' heritage and cultural diversity. This program will support activities that enrich our society through civic engagement and the celebration of art, culture and heritage. The specific program objectives are as follows:

- To support a spectrum of arts, culture, heritage and civically-focused activities which create excitement, pride and enthusiasm for the City's 125th anniversary;
- To facilitate new or expand upon existing cultural and community partnerships;
- To celebrate the creativity of Musqueam, Squamish, Tsleil-Waututh peoples and Vancouver's urban aboriginal population;
- To celebrate the creativity of diverse communities^{*1} in a way that meaningfully represents Vancouver's current demographics^{*2};
- To foster dialogue about civic issues that recognizes our City's built and cultural heritage and provides thoughtful planning for its future;
- To maximize opportunities for neighbours to celebrate in all of Vancouver's geographic neighbourhoods and distinct cultural communities; and
- To support high levels of creative merit and/or public community benefit.

The program is open to City of Vancouver-based, not-for-profit societies that demonstrate the capacity to produce, present, exhibit, or convene the initiative(s) during the months of January–December 2011.

Assessment Committee

As is consistent with all of its granting assessment practices, Cultural Services invites independent peer community members to participate in the assessment process to review grant application requests. Committee members are sought through an ongoing public call for nominations. For this intake the following independent peer members were:

Assessment Committee members join staff in reviewing grant requests against very specific evaluation criteria and form a consensus around priorities and recommendations for funding.

Please see Appendices C & D for program information and evaluation criteria.

Summary of Recommendations

For this deadline, 143 applications were received for a total request of \$ 3,466,619. The recommendations in this report reflect a thorough review of each application in the context of merit, community impact and capacity. Not all organizations meet the criteria at the same level as their peers and therefore, in a very competitive process with finite resources, not all requests are being recommended for support. As such, the Assessment Committee is recommending support for 62 projects.

FINANCIAL IMPLICATIONS

On July 6, 2010 (RTS 8271) Council approved funding for the 125th Anniversary Celebration. In this current report, Council is requested to allocate a portion of the 125th Anniversary program funding by approving grants to 62 not-for-profit organizations for a total of \$911,000.

There will be no unallocated balance left in the Cultural Tourism Product Investment Grant Program and in the New Cultural Grants budget. A balance of \$594,000 will remain in the Cultural Tourism Strategic Planning Reserve to be allocated to the second and final grant deadline in February 2011. Portions of the Reserve will also be used for a range of City initiatives in support of Vancouver's 125th anniversary. The total high-end budget estimate for the 125th Anniversary Grant Program over two intakes is expected to be \$1,700,000 (per RTS 8271) which is dependant upon the outcomes of two grant applications submitted to the Department of Canadian Heritage as well as private sector fundraising, currently in process.

CONCLUSION

The wide-spread outreach and awareness-building of this new, time-limited program has resulted in many new groups applying for grants for the first time. The Assessment Committee's expertise, insight, and carefully balanced evaluation has informed the recommendations in this report which propose to support a wide-range of projects which foster awareness and understanding of Vancouver's identities, first nations' heritage and cultural diversity. These recommendations will support the Celebrate Vancouver's 125th Advisory Committee's Vision Statement to support activities that enrich our society through civic engagement and the celebration of art, culture and heritage.

The program will provide grants to not-for-profit organizations to commission and create works, to produce or present events or exhibits, to host one-time conferences or symposia, or to devise and implement anniversary legacy projects.

Program Objectives

- To support a spectrum of arts, culture, heritage and civically-focused activities which create excitement, pride and enthusiasm for the City's 125th anniversary;
- To facilitate new or expand upon existing cultural and community partnerships;
- To celebrate the creativity of Musqueam, Squamish, Tsleil-Waututh peoples and Vancouver's urban aboriginal population;
- To celebrate the creativity of diverse communities^{*3} in a way that meaningfully represents Vancouver's current demographics^{*4};
- To foster dialogue about civic issues that recognizes our City's built and cultural heritage and provides thoughtful planning for its future;
- To maximize opportunities for neighbours to celebrate in all of Vancouver's geographic neighbourhoods and distinct cultural communities; and
- To support high levels of creative merit and/or public community benefit.

Eligible Applicants

- Must be a City of Vancouver-based, not-for-profit society, and registered in BC.
- Should have on-going paid professional leadership and administrative management.
- Must demonstrate a history of public presentation, production, exhibition or publication or the convening of large-scale events or conferences.
- Must demonstrate capacity to produce, present, exhibit, or convene the initiative(s) during the months of January December 2011.

Eligible projects and activities

If your eligible organization has a project that doesn't seem to be included in this sample list of eligible activities, contact a Cultural Planner to see if the project does meet the program objectives.

Performing art, studio art or writing and publishing commissions or creations: these are anticipated generally to be new works created for or inspired by the City's 125th anniversary or on themes of significant historical, contemporary or projected relevance to Vancouver's identity.

Production or presentation of new or expanded events or exhibits: these are anticipated generally to be temporary events or feature exhibits which are curated on the theme of the City's 125th anniversary or specifically expanded to include themes of significant historical, contemporary or projected relevance to Vancouver's identity.

Presentation of festivals or celebrations: these may be new events organized around the themes of Vancouver's 125th anniversary or they may be existing events which are significantly expanded or specifically themed in 2011 around the 125th anniversary.

Hosting of conferences, symposia or public dialogue series: these are anticipated generally to be new events or annual events that, in 2011, are convened to mark or celebrate the City's anniversary or themes of significant historical, contemporary or projected relevance to Vancouver's identity.

Anniversary legacy projects: these may be self-defined by an organization but are expected to be completed or installed before the end of December 2011; however, more complex projects may be considered if they are completed in early 2012.

All proposed events, activities and initiatives must take place in the City of Vancouver.

More than one project may be submitted by one organization, but separate applications will be required. Successful applicants may be required to submit a final report that highlights qualitative and quantitative performance indicators gauging the impacts of the project.

If an organization is already receiving core funding or project funding through other civic programs (i.e. Cultural Grants or Community Services Grants), the proposed project must demonstrate significant expansion of on-going programming and the grant request should focus on the expanded component of the initiative.

Ineligible projects and expenses

- Demonstrations, marches, and rallies.
- Marketing, promotional or commercially-oriented events.
- Activity occurring prior to January 2011 or after December 31, 2011.
- Deficit reduction or fundraising events.
- Capital costs of projects.
- Ongoing or core activity already funded by the City of Vancouver.

Use of Grant funds

Programming: fees* for artists, speakers and key creative or community contributors, production staff fees, exhibition costs, venue and equipment rental, design, display and decoration, documentation.

Administration: planning, co-ordination, event or project management, fundraising, audience surveys or other data collection, and office expenses.

Publicity and marketing: development and implementation of publicity and marketing strategies, and advertising and promotional expenses.

* Industry-standard fees for key personnel, including speakers' fees, are encouraged. The payment of artist fees is also encouraged. Refer to these groups for guidelines:

Successful applicants may be required to submit a final report which provides both qualitative and quantitative performance indicators gauging the impacts of the completed project.

Grant Fund Amounts

The minimum grant is expected to be no less than \$10,000. The level of grant will depend on the proposed budget and scope of the project and how well it supports the program objectives and meets the evaluation criteria. The minimum project budget is expected not to be less than \$40,000 and all City contributions towards the project will generally not exceed 50% of the proposed budget.

Evaluation

Members nominated from the community participate on an Assessment Committee along with staff. Community members will have relevant expertise and experience in one or more of the following: commissioning, creating, producing, presenting, curating, publishing, or organizing significant public events. The Assessment Committee makes their recommendations based on how well the proposal meets and supports the program objectives, using the specific evaluation criteria outlined below. The proposals that best meet the program objectives will be given the top priorities for funding. All recommendations are considered, and given final approval, by Vancouver City Council.

Evaluation Criteria

Merit

- Clarity of intent and vision of the project as it relates to the City's 125th anniversary program objectives;
- Strength and rationale of project partnerships, if they are proposed;
- Experience of the key creative personnel involved and quality of their work as demonstrated through past projects, training or experience;
- Level of creative merit and/or public community benefit; and
- Distinctiveness of the project in the spectrum of arts, culture, heritage and civically-focused activities proposed for the City's 125th anniversary.

Impact

- Degree to which the proposal maximizes opportunities for citizens and visitors to celebrate in Vancouver's geographic neighbourhoods and/or distinct cultural communities;
- Degree to which the proposal facilitates new or expands upon existing cultural and/or community partnerships;
- Degree to which the proposal provides opportunity for celebration of the creativity of Musqueam, Squamish, Tsleil-Waututh peoples and Vancouver's urban aboriginal population;
- Degree to which the proposal provides opportunity for celebration of the creativity of diverse communities in a way that meaningfully represents Vancouver's current demographics; and
- Degree to which the proposal fosters dialogue about civic issues that recognizes our City's built and cultural heritage and provides thoughtful planning for its future.

Capacity

- Project producers have the skills and expertise to implement the project as demonstrated through previous projects, training or experience;
- Evidence of commitment of all partners/key participants to the project;
- Evidence of competent administration, a functional board and appropriate governance structure;
- Evidence of financial accountability; proposed budget is achievable, diversified and balanced; and
- Noting the short timeline to implement new projects or expand existent ones before December 2011, that realistic planning is in place.

In addition to the above criteria, because the Celebrate Vancouver's 125th Advisory Committee envisioned celebrations taking place in all of Vancouver's neighbourhoods, geographic distribution of the proposals may come into consideration when assessing the requests. Program Description

The 125th Anniversary Grants Program has been established to support the growing excitement, pride and enthusiasm for Vancouver's upcoming 125th anniversary in 2011. This program is a time-limited opportunity for not-for-profit organizations to undertake activities that celebrate Vancouver's 125th anniversary.

The 125th Anniversary Grants Program is intended to foster awareness and understanding of Vancouver's identities, first nations' heritage and cultural diversity. This program will support community-focused activities that enrich our society through civic engagement and celebration through art, culture and heritage.

What is the program hoping to achieve?

- To support a range of arts, culture, heritage and civically-focused activities which create excitement, pride and enthusiasm for the City's 125th anniversary;
- To facilitate new or expand existing cultural and community partnerships;
- To celebrate the creativity of Musqueam, Squamish, Tsleil-Waututh peoples and Vancouver's urban aboriginal population;
- To celebrate the creativity of diverse communities^{*5} in a way that meaningfully represents Vancouver's current demographics^{*6};
- To foster dialogue about civic issues that recognizes our City's built and cultural heritage and provides thoughtful planning for its future;
- To maximize opportunities for neighbours to celebrate in all of Vancouver's geographic neighbourhoods and distinct cultural communities; and
- To support high levels of creative merit and/or public community benefit.

What organizations can apply?

- Must be a City of Vancouver-based, not-for-profit society, and registered for more than six-months in the Province of British Columbia.
- Should have a history of organizing community events or initiatives.
- Must demonstrate the capacity to complete the initiative(s) during the months of January December 2011.

Examples of organizations that can apply include neighbourhood houses, residents' associations, community service groups, ethno-cultural societies, arts and cultural organizations, heritage and museum organizations, service organizations, community policing centres, school organizations, libraries, business improvement associations, civic community centre associations and cultural community centres.

What types of activities are eligible?

If your eligible organization has a project that doesn't seem to be included in this sample list of eligible activities, contact a Cultural Planner to see if the project does meet the program objectives.

Festivals or celebrations: these may be new events organized around the theme of Vancouver's 125th anniversary or they may be existing events which are significantly expanded or specifically themed in 2011 around the 125th anniversary.

Community-engaged dialogue events: these are anticipated generally to be new events or annual events that, in 2011, are convened to mark or celebrate the City's anniversary or themes of significant historical, contemporary or projected relevance to Vancouver's identity.

Creative work in the performing, studio or literary arts: these are anticipated generally to be new works created for or inspired by the City's 125th anniversary or on themes of significant historical, contemporary or projected relevance to Vancouver's identity.

Heritage walks, talks or exhibits: these are anticipated generally to be temporary events or feature exhibits which are curated on the theme of the City's 125th anniversary or specifically expanded to include themes of significant historical, contemporary or projected relevance to Vancouver's identity.

Anniversary legacy projects: these legacy projects can be defined by the interests of a particular organization or community, but they are expected to be completed or installed before the end of December 2011; however, more complex projects may be considered if they are completed in early 2012.

All proposed events, activities and initiatives must take place in the City of Vancouver.

More than one project may be submitted by one organization, but separate applications will be required.

If an organization is already receiving core funding or project funding through other civic programs (i.e. Cultural Grants or Community Services Grants), the proposed project must demonstrate clear expansion of on-going programs and the grant request should focus on the expanded component of the initiative.

What types of projects and expenses are not eligible?

- Demonstrations, marches, and rallies.
- Marketing, promotional or commercially-oriented events.
- Activity occurring prior to January 2011 or after December 31, 2011.
- Deficit reduction or fundraising events.
- Capital costs of projects.
- Ongoing or core activity already funded by the City of Vancouver.

What can grant funds be used for?

Programming: fees* for artists, speakers and key creative or community contributors, production staff fees, exhibition costs, venue and equipment rental, design, display and decoration, documentation.

Administration: planning, co-ordination, event or project management, fundraising, and office expenses.

Publicity and marketing: development and implementation of publicity and marketing strategies, and advertising and promotional expenses.

What grant amount can be expected?

The grant recommendations will range from \$1,000 to \$10,000. The level of grant will depend on the proposed budget and scope of the project and how well it supports the program objectives and meets the evaluation criteria. All City contributions towards the project will generally not exceed 50% of the proposed budget.

Will every application get funded?

No. While the program does intend to support a wide-range of arts, culture, heritage and civically-focused activities throughout Vancouver, the application process is a competition for a limited amount of funding. Successful grant applications will clearly demonstrate how they meet the program objectives and the evaluation criteria.

Who evaluates the applications?

Members nominated from the community participate on an Assessment Committee along with staff. Community members will have relevant event management expertise and experience in one or more of the following: creating, producing, presenting, curating, publishing, or organizing community events. The Assessment Committee makes their recommendations based on how well the proposal meets the program objectives, using the specific evaluation criteria outlined below. The proposals that best meet the program objectives will be given the top priorities for funding. All recommendations are considered, and given final approval, by Vancouver City Council.

How will the applications be evaluated?

Merit

- Clarity of project's intent and vision as it relates to the City's 125th anniversary program objectives;
- Strength and rationale of project partnerships, if they are proposed;
- Experience of the key creative personnel involved;
- Level of creative merit and/or public community benefit in the programming; and
- Uniqueness of the project within the range of arts, culture, heritage and civicallyfocused activities that the City receives for its 125th anniversary.

Impact

- Degree to which the proposal maximizes opportunities for citizens and visitors to celebrate in Vancouver's neighbourhoods and/or diverse cultural communities;
- Degree to which the proposal promotes new or expands existing cultural and/or community partnerships;
- Degree to which the proposal provides opportunity for celebrating the creativity of Musqueam, Squamish, Tsleil-Waututh peoples, Vancouver's urban aboriginal population, or Vancouver's diverse communities, if it is proposed;
- Degree of community support and involvement—for example, expected public attendance, volunteers, participants or donation levels; and
- Degree to which the proposal fosters an exchange of ideas about our City's built or cultural heritage or provides thoughtful planning for its future.

Capacity

- Evidence of the organizers' skills and expertise to carry out the project;
- Evidence of commitment of all project partners and key participants;
- Evidence of competent administration, a functional board and appropriate governance structure;
- Evidence of financial accountability; proposed budget is achievable, diversified and balanced; and
- Evidence of realistic planning and achievable timelines to carry out new projects or expand existing ones before December 2011.
