1. **2011 Stanley Cup Riot - Internal Review Report
September 1, 2011**

The Deputy City Manager provided an overview of the report, and along with the General Manager of Engineering Services, responded to questions.

Council also received presentations from the following:

- Dr. Patricia Daly, Chief Medical Health Officer and Vice President, Public Health for Vancouver Coastal Health, who spoke on alcohol consumption.
- David Guscott, President and CEO, E-COMM, who spoke on E-COMM's role during the riot of June 15, 2011.

Council heard from six speakers, one who spoke in support of the report recommendations, and five who expressed a variety of concerns.

MOVED by Councillor Meggs

- A. THAT Council approve the recommendations contained in the "City of Vancouver, Internal Review of the 2011 Stanley Cup Riot", attached as Appendix A to the Administrative Report dated September 1, 2011, entitled "2011 Stanley Cup Riot - Internal Review Report".
- B. THAT Council approve and endorse the recommendations contained in the report dated August 31, 2011, entitled "The Night the City Became a Stadium: Independent Review of the 2011 Vancouver Stanley Cup Playoffs Riot", authored by John Furlong and Douglas Keefe.
- C. THAT Council direct staff to report back on a comprehensive major event management policy that incorporates the findings and recommendations of the two reports (the Administrative Report dated September 1, 2011, entitled "2011 Stanley Cup Riot - Internal Review Report", and the report dated August 31, 2011, entitled "The Night the City Became a Stadium: Independent Review of the 2011 Vancouver Stanley Cup Playoffs Riot"), before the next Stanley Cup finals, taking into account:
 - The input of key stakeholders consulted through a round table or similar process;
 - The advice of civil liberties experts, crowd control experts and the Vancouver Police Department on the closed-circuit television (CCTV) policy referenced in recommendation 10.3.2.2. of Appendix A to the Administrative Report dated September 1, 2011, entitled "2011 Stanley Cup Riot - Internal Review Report";
 - Steps necessary to establish a municipal alcohol policy;
 - The best practices in other cities for the direction, funding and maintenance of volunteer initiatives like the "everyday heroes" proposal contained in the report dated August 31, 2011, entitled "The Night the City Became a Stadium: Independent Review of the 2011 Vancouver Stanley Cup Playoffs Riot".
- D. THAT Council approve up to \$1,000,000 from the Contingency Reserve Fund to cover those expenses that cannot be absorbed by City departments related to the 2011 Stanley Cup Playoff Live Site activation, policing of the public realm, and the incremental costs associated with the riot that took place on June 15, 2011.
