1. Property Tax Exemptions - 2011 February 15, 2012

The Committee received the Administrative Report dated February 15, 2012, entitled "Property Tax Exemptions - 2011", for information.

## 2. 2012 Property Taxation: Land Assessment Averaging February 17, 2012

Grace Cheng, Manager, Financial Policy and Projects, gave a presentation on land assessment averaging taxation policy, and, along with Patrice Impey, General Manager, Financial Services Group/Chief Financial Officer, responded to questions.

The Committee heard from four speakers, all of whom spoke in opposition to land assessment averaging.

MOVED by Mayor Robertson THAT the Committee recommend to Council

- A. THAT Council approve the continuous application of the three-year land assessment averaging program in 2012 for the purpose of calculating property taxes for Residential (Class 1), Light Industrial (Class 5), and Business & Other (Class 6) properties.
- B. THAT Council instruct the Director of Legal Services, in consultation with the Director of Finance, to prepare a by-law authorizing the use of three-year land assessment averaging that reflects Council's decision on A above, and bring it forward to Council for consideration on March 27, 2012.
- C. THAT, subject to adoption of the by-law on March 27, 2012, Council instruct the Director of Finance to make appropriate arrangements with BC Assessment for the production of the 2012 Average Assessment Roll at an estimated cost of \$24,000; source of funding to be 2012 Operating Budget.
- D. THAT staff report back to Council prior to consideration of the 2013 budget on ideas raised by speakers at the Standing Committee on City Finance and Services meeting on February 28, 2012, and how to achieve a fairer property tax system recognizing the current challenges.

CARRIED UNANIMOUSLY (Councillor Meggs absent for the vote)
