SUBJECT: Annual Procurement Report

RECOMMENDATION

THAT Council receive the report for information.

REPORT SUMMARY

This annual procurement report covers the period from January 1, 2011 to December 31, 2011 and documents the City of Vancouver's procurement activities and performance. The scope of this report includes departmental achievements, procurement statistics, the application of sustainable and ethical procurement standards, and major objectives for 2012.

COUNCIL AUTHORITY/PREVIOUS DECISIONS

In December 2009 City Council approved Procurement Policy number AF-015-01 with an implementation date of April 2010. The policy provided direction from City Council with respect to contract approval authority limits, contract signing authority, establishment of the Bid Committee, and incorporation of sustainable and ethical procurement policies into the procurement process.

CITY MANAGER'S/GENERAL MANAGER'S COMMENTS

The General Manager RECOMMENDS that Council receive the foregoing for information. This report is the 2nd annual summary of procurement activity since the implementation of the City's new procurement policy. The policy changes and the subsequent organizational, process and system changes to support the new policy are all significant steps in moving the City toward a best in class supply chain management structure. Non-salary spend represents

approximately 30% of city expenditures. Through this new and continuously improving supply chain management structure, the city will benefit by more strategic decision making on significant expenditures, leveraging of city-wide spending, access to city-wide information, standardized systems and controls, with overall benefits of improved pricing, increased compliance to policies, improved transparency and increased ethical and sustainable procurement. Under the leadership of the VSR program, the City negotiated contracts for goods and services with an estimated \$4 million in savings in 2011 primarily through consolidation of citywide spend, competitive bidding and negotiation processes. Throughout 2011, contracts were entered into by the City that we expect will bring additional future estimated savings in the range of \$7 million over the multiple year terms of the contracts, many of which extend up to 5 years.

The evolution to a best in class structure is an ongoing process and the Supply Chain team is committed to this continued improvement. With this 2nd annual report, a number of significant accomplishments have been highlighted and we look forward to reporting on additional improvements in future reports.

The City Manager RECOMMENDS that Council receive the foregoing.

REPORT

Background/Context

Under Section 10 (Monitoring and Review) of the Procurement Policy (AF-015-01), the Chief Purchasing Official will annually report to Council on policy implementation progress.

Strategic Analysis

1. Departmental Achievements

2011 was a year of unprecedented transformation and progress for the procurement department. Following are highlights of the major activities and achievements by the procurement department in 2011:

- By September 2011 completed the deployment of the centrally managed and decentralized staffing of the procurement department that conduct all procurement activities for the City. Fifteen of the buying staff have been located in the departments they service.
- Under the leadership of the Vancouver Services Review Procure-to-Pay program:
 - Implemented the streamlined and automated purchase processes across the City including development of the electronic SAP purchase request (shopping cart), electronic catalogue and bid and contract management system which are streamlining and automating the purchasing processes
 - Trained over 400 City staff on the new procurement and accounts payable processes
 - Developed and published uniform procurement procedures, bid documents and contracts that align with the procurement policy and best procurement practices
 - Developed and launched the new Supply Chain Management intranet web site for communicating important information and news to department staff

- Established the framework for service level agreements with each department
- Completed several strategic sourcing initiatives as detailed later in this report
- Negotiated contracts for goods and services with an estimated \$4 million in savings in 2011 primarily through consolidation of citywide spend, competitive bidding and negotiation processes. Through 2011, contracts were entered into by the City that we expect will bring additional future estimated savings in the range of \$7 million over the multiple year terms of the contracts, many of which extend up to 5 years.
- Executed on key sustainable and ethical procurement initiatives that are detailed later in this report
- Incorporated evaluating vendor sustainability leadership as a proponent evaluation criteria in the City's requests for proposals process
- Concluded the expedited Federal Infrastructure Stimulus Fund procurement activity
- In conjunction with Accounts Payable, initiated ongoing monitoring of procurement activities in departments across the City to ensure compliance with the procurement policy
- Relocated the Vancouver Police Department Stores to Graveley Street
- Attained \$407,303 in revenue for the City through the orderly disposal of surplus assets and \$984,000 in revenue through cemetery plot sales.

2. Procurement Statistics

Following are the major procurement statistics for the period from January 1, 2011 to December 31, 2011:

a. Bid Committee

In 2011 the Bid Committee authorized the award of 41 contracts at a total value of \$61,072,998. This includes contracts processed by central Procurement on behalf of City departments and contracts processed by the Board of Parks and Recreation. The Bid Committee is authorized to award contracts up to \$2,000,000. City Council approval is required for contracts with a value greater than \$2,000,000.

Of the 41 contracts approved by the Bid Committee, 36 contracts were at a contract value range between \$500,000 and \$2,000,000. Five contracts were at a contract value in excess of \$2,000,000 as follows:

The banking services contract with Moneris Solutions valued at \$5,357,315 was approved by both Bid Committee and Council in July 2011.

Three contracts over \$2,000,000 were time sensitive capital works and computer technology contracts approved by the Bid Committee on behalf of Council in August during summer recess as permitted under the Procurement policy. The 3 contracts were reported to Council on September 20, 2011.

The fuel contract valued at \$17,395,103 awarded to Chevron Canada was approved by the Bid Committee on behalf of Council during recess for the election (as permitted under the Procurement Policy) because the old contract was set to expire in November 2011. This contract award was promptly reported to Council at the first City Council meeting following the election on November 29, 2011.

Chart 1 in Appendix A to this report provides a breakdown of the total value of the 2011 Bid Committee approvals by City department.

b. Summary of Contracts Awarded

The central Procurement department in Financial Services Group processed a total of \$80,086,119 in contracts. Of that value, \$74,621,016 (93.2%) was awarded using the competitive bid process and just \$5,440,103(6.8%) was awarded to bids on a sole source basis under the procurement policy and of the 6.8% sole source, 4.5% was awarded following the public posting of a notice of intent to contract.

The competitive award ratio demonstrates that the City is successful in achieving on its core procurement objectives of conducting a competitive and open process while maximizing the value of goods and services received for money spent.

The list of all awarded contracts of \$100,000 or greater is attached in Appendix B to this report. All bid results contract awards are posted on BC Bid and on the City of Vancouver web site at http://vancouver.ca/fs/bid/bidopp/contractAward.htm

c. Strategic Sourcing

In April 2010 the City of Vancouver implemented the use of strategic sourcing methodology to reduce the cost of purchased goods, services and construction. In 2011 a total of 91 strategic sourcing initiatives led to the award of a total value of \$68,384,297 in contracts on behalf of City departments resulting in an estimated savings of \$4,000,000 for 2011, primarily through consolidation of citywide spend, competitive bidding and negotiation processes. We also expect these contracts to result in additional estimated future strategic sourcing savings in the range of \$7,000,000 over the multiple year terms of the contracts which can be up to five years. Chart 2 in Appendix A to this report provides a breakdown of the number of strategic initiatives, total contract value and total procurement savings for each major spend category.

d. Sole Source Contract Awards

The Procurement policy provides circumstances by which a contract may be sole sourced. Chart 4 in Appendix A to this report provides a breakdown of the types of approved sole source contracts, the number of transactions of each type and the total spend. Of the 6.8% of the value of contracts awarded on a sole source basis under the procurement policy, 4.5% of the value of awards followed the public posting of a notice of intent to contract and just 2.3% were urgent and/or highly specialized and awarded prior to issuance of a public notice. In all instances a public notice of the sole source award was issued on the City of Vancouver web site. The complete list of sole source contract awards for 2011 is attached in Appendix C to this report.

e. Surplus Asset Disposal

The procurement policy provides for the orderly disposal of any materials owned by the City that are declared to be surplus to present and future department requirements. In 2011 a total of \$407,303 in revenue was generated through the orderly sales disposal of surplus assets. A further \$984,000 in revenue was generated through procurement managing the public offer sale of cemetery plots at the Mountain View Cemetery. Chart 5

in Appendix A to this report provides a breakdown of the major category of assets sold and the revenue generated for each category.

3. Sustainable and Ethical Procurement

The Procurement policy aligns the City's approach to procurement with its sustainable and ethical procurement objectives.

A Sustainable and Ethical Procurement (SEP) steering committee has been established at the City to provide strategic oversight and direction regarding the most effective ways to integrate sustainable and ethical procurement into high impact procurement opportunities.

Membership of the SEP committee consists of the Deputy City Manager (chair), Director of Sustainability, Director of Supply Chain Management, representation from Financial Services and departments whose purchase requirements have been identified for strategic sustainable and ethical procurement.

In 2011 the following major sustainable and ethical procurement initiatives were completed by the Procurement department:

- Office supplies product supply (environmentally preferred products that reduce greenhouse gas/carbon footprint, third-party eco labelling, waste reduction) and corporate leadership (workplace practices, health & safety, compliance with City's supplier code of conduct)
- Enabled implementation of City of Vancouver policy to use only 100% post consumer recycled paper, becoming the first municipality in Canada to make it a policy
- Implemented use of reusable tote containers for delivery of office supplies from Grand
 Toy in lieu of traditional disposable cardboard boxes
- PC monitor replacement to energy efficient monitors for the purpose of saving money and protecting the environment. Old computers and monitors are donated to reBoot, a national charity, which provides computer hardware, training, and technical service to other charities, non-profit organizations and individuals with limited access to technology
- Negotiated purchase of B5 and B20 bio-diesel from Chevron under new fuel contract
- Four revenue generating contracts valued at approximately \$1 million per year to collect recyclable materials from the Vancouver Landfill and Vancouver South Transfer Station as part of zero waste city goal
- Office printer strategy reduction in number of desktop printers, less printing, reduction in consumption of paper and toner
- Incorporated Sustainability Leadership Questionnaire as a mandatory requirement in all City bid documents and evaluation criteria
- Collaboration with the City of Edmonton on application to receive Urban Sustainability
 Directors Network (USDN) Innovation Opportunity Fund grant to develop measurement
 and reporting tools for sustainable procurement. The USDN is a network of municipal
 sustainability leaders, including the City of Vancouver, which has been organized to
 accelerate the achievement of common sustainability goals
- Major participant in the following sustainable procurement collaborations:
 - Vancouver Economic Commission (VEC) on Green Neighbourhood Showcase and green technology
 - University of British Columbia collaboration on best practices in sustainable and ethical procurement

 Municipal Collaboration for Sustainable Procurement (MCSP) committee which is comprised of 15 municipalities across Canada and is growing monthly

The committee has targeted several opportunities for 2012 including food, fleet vehicles, waste management, facilities materials, uniforms and uniform cleaning.

4. Objectives for 2012

Following are major planned activities for 2012:

- Complete the transition of the Procure-to-Pay project into long term sustainment
- Implementation of the Supply Chain Shared Services Warehouse, Distribution and Inventory Control project through the Vancouver Services Review
- Develop and execute strategic sourcing initiatives that have been identified for 2012
- Execute on the sustainable and ethical procurement initiatives that have been identified for 2012
- Establish formal policy on how to manage unsolicited proposals received by the City
- Implement partnership agreements between Procurement and key City departments
- Optimize the use of Purchasing card program
- Establish formal structure and process for monitoring and reporting on compliance with the procurement policy
- As part of business continuity planning, ensure that the new Supply Chain structure is appropriately provisioned to provide critical support in the event of an emergency
- Conduct warehouse operations projects:
 - Central stores projects
 - Business continuity plan
 - Disposition of surplus assets

Implications/Related Issues/Risk (if applicable)

Financial

As part of the Vancouver Services Review Supply Chain management program, the department has been tracking the impact of the strategic sourcing activities. In 2011, the City negotiated contracts for goods and services with an estimated \$4 million in savings, primarily through consolidation of citywide spend, competitive bidding and negotiation processes. Throughout 2011, contracts were entered into by the City that we expect will bring additional future estimated savings in the range of \$7 million over the multiple year terms of the contracts, many of which extend up to 5 years. This continued focus on bringing savings through strategic procurement benefits the organization financially, as well as bringing together different parts of the organization in establishing standards and performance criteria that improve vendor services city-wide.

CONCLUSION

The new procurement policies which were adopted by City Council in April 2010 have driven transformation, savings and a shift in culture in both the City and within the vendor community. City departments are utilizing the expertise of procurement staff for their requirements at unprecedented levels. As such they are receiving financial as well as business benefits through contracts that preserve the best interests of the City and its citizens and reduce contractual risks. Formal structures and processes will continue to be built and

information will be used to track compliance with policy to maximize open and transparent opportunities while minimizing sole source purchases.

The vendor community recognizes that the City is striving to achieve on its principles of achieving *best value* on its purchases through the procurement process while incorporating sustainable and ethical procurement policies. Going forward we will continue to develop processes that make it easier for our valued vendor community to do business with the City without compromising on our core principles.

On the basis of the information provided herein, the adoption of this report is recommended.

Chart 1: Bid Committee Approvals by Department

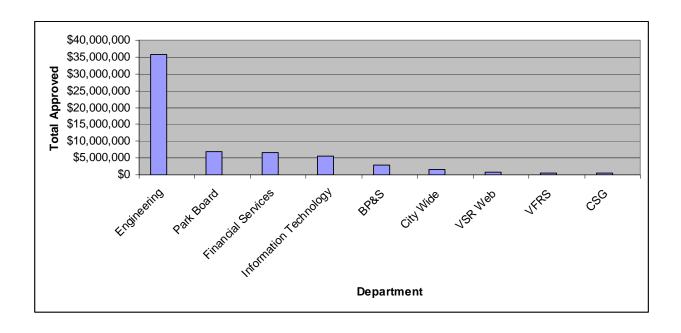


Chart 2: Strategic Sourcing by Major Product/Service Category

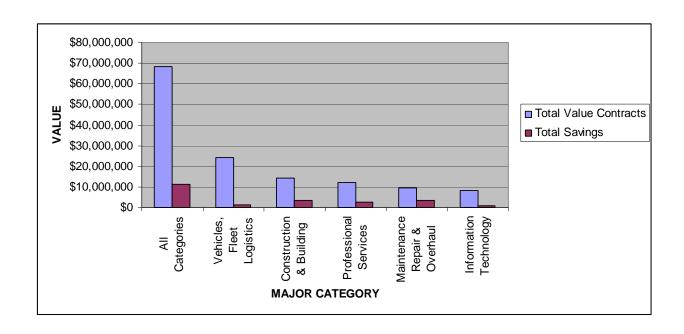


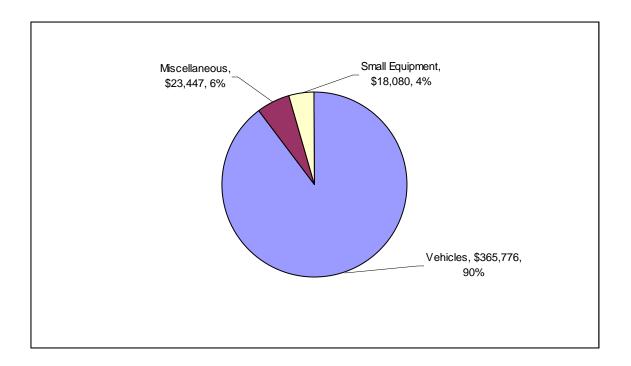
