Dear Mayor Robertson and Council Members,

I appreciate the opportunity to speak today with regards to the proposed rezoning of Oakridge Centre in Vancouver.

I support the recommendation in principle of the General Manager of Planning and Development Services being debated today. I will let the consultants, architects and city staff sort out the finer details involving building heights, floor plates, shadowing, transportation, etc. Hopefully, most people's requests will be satisfied but I realize you cannot please everyone.

I am here today speaking as a Board Member of Tikva Housing Society. Tikva is a non-profit society, which works towards accessing opportunities for safe, affordable housing primarily for working-age low-income adults and families. Tikva and our various housing partners are very excited about the 290 Social Housing Units which are included in the rezoning application being discussed today. Our Society has a strong focus on families and it is especially nice to see that 50% of the units would be 2 and 3 bedrooms. I do hope these units will be liveable 2's and 3's with square footages of <u>AT LEAST</u> 800 SQ FT for 2 bedrooms and 1000 sq ft for 3 bedrooms.

It is also nice to see another 290 market rental units as part of the application. The more rental units built ultimately adds to the pool of rental apartments in the city which provides more options for renters. Many of our community members on our rent subsidy program (which provides a subsidy and gives the individual the ability to choose where they want to live) will hopefully have the opportunity to live in some of these market rental units.

While the remainder of the 2900 apartments will be market condo units, it is very likely that during the first several years as many as 50% will be rented out as market rental units providing even more rental supply to the neighbourhood.

I am also here today as a member of the community who frequents Oakridge on a regular basis. My in laws live only a 10 minute walk away and my family and I live a short 10 minute drive away. We visit the mall, nearby stores and neighbourhood community centres a few times each week. Oakridge is in the heart of the city and is on the most important high-speed transit line connecting downtown to the airport. I cannot think of a more logical location for a major redevelopment to satisfy the needs of all community members. Personally, I am excited about the new retail and new community amenity spaces that I know my family and I will use. I believe the additional retail and office development will bring thousands of new jobs to members of our community, which is very positive.

I understand many people have concerns about the traffic and transit congestion and rightfully so. At the same time, the rezoning application is recommending further improvements for Vehicular traffic in the vicinity of the redevelopment, which I think is very important. Congestion on the Canada Line is the other debated issue I've been reading about, however, the application provides a lot of detail on how future capacity can be met with an increase in trains, frequency and/or structural upgrades to the stations. I do hope the proper planning is done and the necessary capital is set aside to ensure line capacity does not become an issue.

Once again, thank you for the opportunity to speak on this important development for our community and I wish everyone a good evening.
