SUBJECT: 2013 Council Remuneration and Expenses

RECOMMENDATION

THAT Council receive this report for information.

REPORT SUMMARY

Section 196A of the Vancouver Charter requires:

- 1. At least once a year, Council must have prepared a report separately listing for each Council member by name
 - a. The total amount of remuneration paid to the Council member
 - b. The total amount of expense payments made under section 196.
- 2. The report must be considered by Council at a Council meeting that is open to the public and a copy of the report must be made available for public inspection at City Hall during its regular office hours from the date when it is considered by Council until one year after that date.

COUNCIL AUTHORITY/PREVIOUS DECISIONS

Council has enacted Bylaws 7465, 8904 and 8999 under Section 196 of the Vancouver Charter to provide remuneration to members of Council and reimbursement of expenditures made or expenses incurred while representing the City, engaging in City business or attending related meetings. Financial Implications

Council remuneration and expenses are provided for in the annual Operating Budget.

The amount of transportation allowance paid in 2013 to Councillor Kerry Jang included a retroactive amount of \$11,795 for the period December 2008 to December 2012. As noted in the prior year's 2012 Council Remuneration and Expenses report (RTS 9949), this was to correct an administrative oversight resulting in Councillor Jang not receiving the transportation allowance since being elected to office in December 2008.
