SUBJECT: 2014 Community Services and other Social Grants

#### **RECOMMENDATION** \*

- A. THAT Council approve 130 Community Services Grants totaling \$5,038,100 and including any recommended Conditions on the grants, as listed in Appendices B-1 to B-4, and 1 Access to Nature Capital Grant totaling \$10,000. Sources of funding are the 2014 Community Services Grants budget and 2014 Capital Budget Access to Nature.
- B. THAT Council approve 1 grant of \$50,000 for capacity building of non-profit organizations. Source of funding is the 2014 Community Services Grants budget.
- C. THAT Council approve 14 Social Responsibility grants for a total of \$302,000 from the Social Responsibility Fund, as listed in Appendix C. Source of funding is the Edgewater Casino Social Responsibility Reserve.
- D. THAT Council approve 3 Rent Subsidy Grants totaling \$78,356. Source of funding is the 2014 Operating budget for Rent Subsidy Grants.
- E. THAT Council approve 13 Social Policy Small Capital Grants totaling \$117,545, as listed in Appendix D. Source of funding is 2014 Capital Budget.
- F. THAT Council approve 2 Childcare Administration Grants totaling \$355,032, as listed in Appendix E. Source of funding is 2014 Operating budget for Civic Child Care Grants.
- G. THAT Council approve 19 Childcare Reserve Grants totaling \$614,395, as listed in Appendix E. Source of funding is the Childcare Reserve.

#### REPORT SUMMARY \*

This report recommends 182 grants to non-profit organizations in Vancouver for a total of \$6,565,428 and consolidates five Social Grant streams under one report.

The purpose of this funding is to enable the provision of priority services, build capacity of the non-profit sector, and mitigate conditions that cause vulnerability for marginalized populations throughout the city. Social Grants leverage significant funding from other sources and are an important tool for the City in achieving Council priorities and strategic initiatives as outlined in Table 1.

Social Grants also align with the policy objectives of the Social Grants Program and include:

- Meeting basic needs;
- Building capacity;
- Enhancing belonging;
- Supporting inclusive neighbourhoods.

This report also contains, in Appendix A, analyses on how the recommended Community Services Grants support different population groups and an assessment of some emerging trends in 2014.

#### COUNCIL AUTHORITY/PREVIOUS DECISIONS \*

Community Services (CS) Grants: On March 7, 1978, City Council established the Community Services Grants program. On October 9, 2003, City Council approved revisions to the Community Services Grants program, including three funding streams: Neighbourhood Organizations, Direct Social Service, and Organizational Capacity Building.

Childcare Administration and Reserve Grants: Council established the annual Civic Child Care Grants Program on October 23, 1990, as part of the 1990 Civic Child Care Strategy. In May 1991 Council approved the creation of the Childcare Endowment Reserve (now referred to as the Childcare Reserve) and on December 15, 1994, Council approved the Reserve's terms and conditions, including eligibility criteria.

Rent Subsidy Grants: On June 8, 1993, City Council decided that rent subsidies to social service or cultural organizations, occupying City-owned property held in the Property Endowment Fund, will be funded from the Community Services or Cultural Grants budget, and that these budgets will be adjusted to accommodate any new or renewed subsidies approved by Council.

Social Responsibility Fund (SRF) Grants: On July 20, 2004, as part of the rezoning conditions for the Plaza of Nations, Council accepted a public benefit offering from Edgewater Casino including a donation of \$200,000 annually, towards the Social Responsibility Fund. Council approved funding guidelines in October 2006.

Sustainable Food Systems (SFS) Grants: On April 7, 2009, Council approved the establishment of the Greenest City Neighbourhood grants with allocations of \$100,000/year.

Social Grants Increase: On March 13, 2013, Council approved an increase of \$1 million to the Social Grants budget and on July 24, 2013 Council approved an allocation model for 2014 allotting \$800,000 to program grants and \$200,000 to project grants.

Social Policy Small Capital Grants: On December 18, 2013 Council approved a policy change to the SPC Grant program to include organizations in facilities owned, leased or rented by the City, to allow the City to contribute up to 50% of the grant and to allow up to a maximum of 15% for depreciable assets.

Recommendations A through G above authorize grants and require eight affirmative votes for approval.

#### REPORT

#### Background/Context \*

This report combines recommendations for five Social grant streams, provides comprehensive information to Council under one report, and helps streamline administrative work. The purpose of this funding is to provide services in the social sector and build organizational capacity and resilience among populations experiencing vulnerability throughout the city.

Social Grants help to address Council priorities including:

- i. The Healthy City Strategy by funding programs that support key goals including Cultivation Connections, Being and Feeling Safe and Included, Healthy Human Services and A Good Start:
- Ending street homelessness by funding services to address the needs of street populations, providing access to basic services and supporting those at risk of becoming homeless;
- iii. Social inclusion and safety by providing funding to neighbourhood based services, and city wide services supporting the integration of new immigrants, services for seniors, women, persons with disabilities, and youth at risk;
- iv. The Mayor's Task Force on Mental Health and Addictions by assisting people with mental illness and addictions with peer support and other programs to enhance social connections and crisis prevention;
- v. Supporting the goals of the **Year of Reconciliation** by funding programs for Aboriginal peoples that provide opportunities to build relationships, and investing in learnings that help our understanding of historical and contemporary Aboriginal issues;
- vi. Supporting the recommended policy directions of the **Downtown Eastside Local Area Plan** to improve the quality of life, community security and a sense of belonging and inclusion for residents of the Downtown Eastside;
- vii. Facilitating the achievement of the Vancouver Food Strategy and the Greenest City 2020 goals and targets through grants supporting coalitions of community organizations, agencies and businesses who work collaboratively to achieve food systems goals;
- viii. Building capacity in the childcare sector to support Early Care and Learning by providing funding to help offset the high cost of infant and toddler care in facilities located in high density and emerging neighbourhoods and aid in the creation of new spaces to help in achieving the Council's benchmark of 500 new spaces.

# Strategic Analysis \*

This report streamlines five funding streams in one report to improve efficiencies. This approach is in keeping with streamlining granting processes across the City, and ensuring our granting strategy aligns with Council priorities while continuing to leverage funding from other levels of government, foundations and other sources.

# Summary of Applications from each of five grant streams:

# A) Community Services Grants - \$5,098,100

The Community Services (CS) Grants stream is the largest of Social Policy's Grant streams. The purpose of the CS grants is to provide services and supports to vulnerable populations within 4 categories:

- Neighbourhood Organization (NOG) Grants
- Organizational Capacity Building (OCB) Grants
- Direct Social Service (DSS) Grants
- Sustainable Food Systems (SFS) Grants

Information on the application process, additional funding from the \$1 million increase, and recommendation highlights and capacity building to the non-profit sector follows. (See Appendices B-1 to B-7 for a complete list of all Community Service Grant recommendations)

#### i) Application process for Community Services Grants

The application deadline was October 18, 2013:

176 grant applications were received and 130 are recommended for funding.

All applications were reviewed by a Social Policy staff team using a range of criteria including:

- Meeting Council priorities;
- Program feasibility and impact;
- Organizational capacity;
- Performance outcomes (if funded in previous year).
- 46 applications either did not meet criteria or were not ranked as highly as others and are not recommended (See Appendix B-6). If a grant is not recommended, staff provide rationale to the applicant and suggest other funding opportunities when applicable.
- 4 programs are recommended for decreases. Decreases to 2 CS grants are based on reduced grant requests from the organization and two SFS grants are recommended for decreases to create equity among Neighbourhood Food Networks and other grant recipients involved in similar food initiatives across the City.

#### ii) New funding from the \$1million increase to Social Grants

On March 13, 2013, Council approved an increase of \$1 million to the Social Grants budget and on July 24, 2013, Council approved an allocation model. The model for 2014 calls for the allocation of \$800,000 to core program funding and \$200,000 to Social Innovation Project grants. Of the \$800,000 designated to fund core programs in 2014, this report recommends a total of \$755,000 in Table 2 below (the balance of \$45,000 will come as a recommendation for Woodwards Childcare in a report to Council later this year):

# iii) Community Services Grants recommendation summary

The following table summarizes the 2014 Community Services Grants recommendations which include funding to 10 neighbourhood houses, 10 grants to organizations that help build the capacity of the non-profit sector and 97 Direct Social Services grants. Also recommended are 14 grants to support sustainable food systems to enable equitable food access and to build community capacity at the neighbourhood level.

Community Service Grants leverage funding from other sources at a 4:1 ratio (see Appendix A for CS grants in relation to other granting sources)

For a detailed list of all Community Service grant recommendations, conditions and comments as well as a list of recommendations for new grants and increases to existing grants see Appendices B-1 to B-6.

All applicants have been informed, in writing, of Social Policy's recommendations and in some cases, staff have placed conditions on recommendations subject to Council's final approval.

#### iv) Capacity building funding to support the non-profit sector

Social Policy sets funding aside each year to build the capacity, stability and sustainability of non-profits by providing learning opportunities for staff and boards on sound fiscal management, governance and executive leadership. In March 2011, Social Policy and Cultural Services piloted a partnership with Vantage Point, a non-profit specializing in developing excellence in organizational governance and leadership, to provide workshops to build the capacity of non-profit staff, and the ability of their organizations to fulfill their mission.

55 organizations attend 120 intensive multi day labs and half day workshops over 18 months. An independent evaluation by the Howe Group determined that the pilot was successful in supporting non-profits and their staff to:

- Build their capacity in strategic planning and organizational transitions;
- Enhance their leadership skills to lead their organizations more effectively;
- Provide guidance with board processes and role clarity with new executive directors;
- Shared learning in a group setting with fellow staff and board members;
- Learn from and network with other organizations in similar situations;
- Affirm good work practices.<sup>1</sup>

Based on the success of this pilot it is recommended that the initiative be continued and that an increase to \$50,000 (from \$30,000 in 2013) be approved to continue funding capacity building work through Vantage Point to help support the ongoing stability and strength of the non-profit sector in Vancouver.

#### B) Neighbourhood Based Grants

Social Responsibility Fund (SRF) Allocations - \$302,000

The Social Responsibility Fund supports projects located within neighbourhoods surrounding the Edgewater Casino, including the DTES/Strathcona, Mount Pleasant, and Downtown.

Through the 2014 Community Services and the Social Innovation Project grants processes, staff identified 14 projects that support food security, low barrier employment, community safety, and align with Council priorities. Each project meets the funding criteria of the Social Responsibility Fund and amounts to a total of \$302,000. The projects are described in Table 5 below.

SRF Grants leverage funding from other sources at a 5:1 ratio.

#### C) Rent Subsidy Grants - \$78,356

Council has a policy of considering rent subsidy grants for non-profit agencies that qualify for a Community Services Grant and lease in a City-owned property held in the Property Endowment Fund. The City charges market rent for these properties and groups may request a subsidy to offset this market rent. Staff recommendations for such grants are based on the criteria and priorities used to assess Community Services grants.

Three organizations are being recommended for rent subsidy grants to assist in the provision of programs or office space.

#### D) Social Policy Small Capital Grants - \$117,545

Social Policy Small Capital Grants improve the safety, accessibility and operational needs of non-profit social service and child care organizations. On December 18, 2013, Council approved a policy change to this grant program to include organizations located in facilities owned, leased or rented by the City, to allow the City's contribution to be a maximum of 50% of the grant; and to allow up to a maximum of 15% for depreciable assets. This report recommends 13 projects related to health and safety upgrades, renovations or construction to improve or expand services, and planning or feasibility studies. Twenty-two applications were received and 13 projects are recommended for funding. Nine applications are not recommended. The submissions that are recommended are summarized below (for a more detailed description of each project see Appendix D).

# E) Childcare Grants - \$969,427

# i) Childcare Administration Grants - \$355,032

Staff recommend two annual operating grants to Westcoast Child Care Resource Centre and the Vancouver Society of Children's Centres (VSOCC). These organizations are unique compared to other service providers: VSOCC was created by the City to operate and steward City-owned childcare amenities in the downtown core, and is the preferred operator of new downtown childcare developments. Westcoast is an umbrella organization that provides training and resources to child care staff as well as parent information and referral available to child care.

Childcare Administration Grants leverage funding from other sources at a 3.5:1 ratio.

# ii) Childcare Reserve Grants - \$614,395

The Childcare Reserve was set up in 1991 to provide funding to help offset the high cost of infant and toddler care in facilities located in high density and/or new and emerging neighbourhoods.

On December 13, 2011, Council passed a motion renewing its commitment to increasing the number of child care spaces, setting a target of 500 new child care spaces over the next three years. Childcare Reserve Grants aid in the creation of new spaces as well as supporting the sustainability of Infant/Toddler spaces, which are limited in number, have the highest demand and require the most resources to operate due to higher child-to-teacher ratios for very young children.

In December 2012, Council passed a resolution to allocate an additional \$5 million to the Childcare Reserve to increase the long term viability of the Reserve and the increased demands resulting from new spaces and facilities.

# Two Types of Childcare Reserve Grants

Operating Start Up Grant - Start Up funding is provided up to \$2,000 per space and is prorated over 24 months. This grant supports the soft costs associated with opening a new facility, including project management during the construction phase, costs associated with hiring and training staff, developing policies and procedures, and gradual enrolment.

Infant/Toddler Grant - The Infant/Toddler grant offsets the higher cost of staff-to-child ratios required for very young children. Funding is provided for up to \$1,650 per space on an annual basis. The Vancouver Society of Children's Centres (VSOCC) operates a total of 755 spaces, including the largest number of infant/toddler spaces in Vancouver. VSOCC has 192 infant/toddler spaces to be funded through this grant.

# i) Community Services Grants

The 2014 budget for the Community Services (CS) Grants approved by Council December 17, 2013 is \$4,222,900 (Note in Table 11 below this amount has been divided into \$4,192,900 for Community Services Grants and \$30,000 for Capacity Building Funding).

In addition to this base amount of \$4,222,900, the total CS Grants budget has been increased to \$5,088,100 through the following additions:

The Community Services Grants recommended in this report total \$5,088,100 leaving no remaining balance.

# ii) Access to Nature Capital Fund

This report recommends one grant to be funded from the Access to Nature Capital Fund totalling \$10,000. As of February 6, 2014, the unallocated balance in the Access to Nature Capital Fund is \$145,755 Upon the recommended allocation in this report, there will be \$135,755 remaining unallocated in the Access to Nature Capital Fund.

#### iii) Social Responsibility Fund (SRF)

This report recommends 14 grants to be funded from the SRF totalling \$302,000. As of February 6, 2014, the unallocated balance in the Edgewater Social Responsibility Reserve was \$304,365. Upon the recommended allocation in this report, there will be \$2,365 remaining unallocated in the Edgewater Social Responsibility Reserve.

#### iv) Rent Subsidy

This report recommends 3 grants to be funded from the 2014 Rent Subsidy Grants Budget totalling \$78,356. The 2013 Rent subsidy budget for 2014 is \$95,600. Upon the recommended allocation in this report, there will be a balance of \$17,244 in the 2014 Rent Subsidy Grants Budget.

# v) Social Policy Small Capital Grants

This report recommends 13 grants to be funded from the 2014 Capital Grants for Social Service and Child Care Facilities Budget totalling \$117,545. The 2014 Capital Grants for Social Service and Child Care Facilities Budget is \$170,662. Upon the recommended allocation in this report, there will be a balance of \$53,117 in the 2014 Capital Grants for Social Service and Child Care Facilities Budget.

#### vi) Childcare Administration

This report recommends 2 grants to be funded from the 2014 Civic Child Care Grants Budget totalling \$355,032. The 2014 Civic Child Care Grants Budget is \$1,200,200. Upon the recommended allocation in this report, there will be a balance of \$845,168 in the 2014 Civic Child Care Grants Budget.

#### vii) Childcare Reserve Grants

This report recommends 19 grants to be funded from the Childcare Reserve totalling \$614,395. As of February 6, 2014, the unallocated balance in the Childcare Reserve was

\$16,422,942. Upon the recommended allocation in this report, there will be \$15,808,547 remaining unallocated in the Childcare Reserve.

# **CONCLUSION** \*

All the grants outlined in this report provide an important contribution to the delivery and sustainability of social services in Vancouver, to a wide range of population groups serving marginalized and at-risk citizens. The grants also support City livability and social development objectives and thus contribute to our city's overall urban health.



# Primary Population/Issue Areas Supported by Funding Recommended in this Report

The City's Social grants are a tool to support work being undertaken by non-profit groups addressing a range of key policy areas impacting Council priorities, including:

- Healthy City Strategy
- Social Inclusion & Safety
- Ending Street Homelessness
- Mental Health & Addictions Task Force
- DTES Local Area Plan
- Vancouver Food Strategy
- Greenest City 2020

Grants recommended in this report support a wide range of population groups and issue areas. The chart below reflects the *primary* populations served or issue area by each program.



Community Service Grants - Recommended Allocations by Population or Issue Area (total allocations for 2014 - note: there are 5 grants identified as "other" in the chart above that do not fall into any of the categories and are not accounted for below - these grants are identified in Appendix B-7):

# • Children, Youth and Families (36 grants totalling \$1,455,042)

With children and youth (0 to 24) representing 2% of Vancouver's population (BC Stats 2011), the support of a continuum of services and programs for children, youth and families is strongly supported by City policy and priorities. City funding in the area of children and families is targeted at programs that provide support for early and middle years development for those most at risk of falling behind and at providing and coordinating child care for working families. A similar early intervention and prevention approach is taken with programs supporting youth at risk.

# Neighbourhood Services (10 grants totalling \$927,824)

The city is committed to supporting strong, vibrant communities through the support provided to 10 neighbourhood houses located throughout the city. Neighbourhood houses are volunteer driven organizations that respond to the needs and aspirations of its local community members by providing services, programs, special events, facilities and information to meet the changing needs of diverse populations. They are a place where people of all ages and backgrounds can come together to address their personal, social and community development needs.

# Seniors (16 grants totalling \$551,600)

12,500 seniors currently residing in Vancouver (15%) are living below the poverty line and in the next 20 years the number of seniors living in Vancouver is expected to double. Seniors from a visible minority also make up 26% of the total seniors population in Vancouver. The effects of low income, isolation and cultural barriers are compounded by issues of the high cost of living in Vancouver and the absence of any provincial funding support for community based seniors' programs. City funding is targeted at programs working with vulnerable seniors that enhance cultural inclusion, focus on peer support and ensure access to basic services and supports.

#### • Immigrants and Refugees (8 grants totalling \$382,576)

Immigrants, particularly recent immigrants and refugees, are presented with a variety of challenges to adapt and integrate into the city's everyday life. Community Services grants provide support to 8 programs focussed on providing services to isolated immigrant seniors, at-risk immigrant youth, immigrant women preparing for employment, and other locally identified needs.

#### Women (7 grants totalling \$309,184)

Support for programs and activities related to women's issues has been a priority for the Community Services Grants ever since their inception more than 30 years ago. The City works actively to promote the safety and inclusion exclusion of women and girls.

# Promote Safety for Sex Workers and for Communities Impacted by Sex Work (6 grants totalling \$235,896)

One of the most vulnerable populations in Vancouver involves those engaged in sex work and in particular those involved in survival sex work. Often victims of abuse, violence, and poverty, they require specific levels of support. Further, neighbourhoods and residents in Vancouver may also be impacted. The Community Services grants include services for health and safety for both women and men, particularly those involved in survival sex work. Funding is also recommended to support the prevention of youth sexual exploitation and exiting supports for those choosing to leave sex work.

# People with Disabilities (6 grants totalling \$147,802)

While Vancouver has made significant strides in making the city an inclusive place to live for people with physical and developmental disabilities, there continues to be considerable work required to ensure that those with disabilities are able to live with dignity, independence and as equal and full participants in society. City funding in this area supports programs that work directly with people to build their capacity for skill development and access to services and supports.

# Equitable Access to Justice (3 grants totalling \$105,236)

Fair and equitable access to justice goes well beyond the significant cuts to legal aid in the province over the past few years. Access to justice begins with ensuring that the most vulnerable in our city have the information, support and guidance to navigate through and beyond the justice system. Grants from the City go toward supporting programs that link those who are most marginalized to the resources they need to facilitate this process.

# Support to Non-profits (5 grants totaling \$122,608)

Funding supports programs that build the capacity of other non-profits to fulfill their mission. These supports range from providing workshops and in-depth training in board governance and executive leadership to the provision of IT and computer systems supports.

# Food Systems (14 grants totalling \$180,000)

Funding supports organizations who build coalitions of community members and organizations, agencies or businesses to work collaboratively to achieve food systems goals. Successful organizations use food as a tool to promote inclusion, participation, celebration, skill-building and community capacity, including programs such as community gardening, multicultural cooking clubs, and seniors cooking classes.

# Urban Aboriginal People (7 grants totalling \$278,578)

Urban Aboriginal people are among the most significant group to experience marginalization on many different levels of civic life. Aboriginal people have a significantly lower quality of life than non-Aboriginals. While representing 2% of the overall population in Vancouver, Aboriginal people account for an estimated 32% of people experiencing homelessness (CoV Social Indicators & Trends 2009). With 60% of the Aboriginal population under the age of 24, City grants for this sector are largely focused on building the capacity and strength of Aboriginal youth to meet challenges and thrive in their communities.

#### Mental Health & Addictions (7 grants totalling \$219,480)

With 93% of people experiencing homelessness having a current mental illness and 83% exhibiting a substance abuse disorder<sup>2</sup> the issue of mental health and addictions is an important one in both the prevention of homelessness and in supporting people to find housing. Funding in this area is targeted toward programs that build social connections and support to avert crisis and that support people at risk of losing their housing as a result of a mental illness or addiction.



# 1) Impact of grants for key funding areas


The population and issue areas described in this Appendix are for the *primary* group identified. This means that if the percentages for each group are added together it will equal 100%. Though useful for some purposes, this method underestimates the impact that CS grants have for most groups because most funded programs serve more than one population or issue. For example a program for Aboriginal youth would only be counted once, either as youth or as Aboriginal. Similarly, a significant amount of work done by neighbourhood houses also supports seniors.

To address this the 2014 application for CS grants asked programs to estimate the percentage of the people they served who would identify as being part of each population or issue group. In doing so, staff are able to report more accurately how City grants are impacting various groups across all funded programs.

For example, based on self-reporting by grant applicants, 18% of people served in programs receiving Community Services grants are Aboriginal. This translates into an investment in CS grants of \$908,396, or more than three times \$278,578 allocated to Aboriginal organizations indicated in this Appendix.



This broader assessment similarly allows staff to estimate the impact of CS funding on areas like homelessness that cut across many populations. In 2013, 15% of people served in programs receiving CS grants were experiencing homelessness. This translates into an investment in CS grants of \$740,889.



# 2) People with Serious Addictions and Mental Illness

In September 2013 the Vancouver Police Department released *Vancouver's Mental Health Crises: An Update Report* which was followed in November by a Ministry of Health report titled *Improving Health Services for Individuals with Severe Addiction and Mental Illness.* These reports underscored the critical need for additional supports for people with serious addictions and mental illness and are strongly supported by the UBC Department of Psychiatry's *Hotel Study* in which researchers found:

- 95% of SRO tenants in the DTES have a substance dependence;
- 74% have a mental illness;
- 70% were receiving inadequate care or no care at all.

The statistics are equally concerning for people experiencing homelessness with the 2011 *BC Health of the Homeless Survey* reporting:


- 93% of people experiencing homelessness having a current mental illness
- 83% exhibiting a substance abuse disorder

The City has responded to a critical need for more supports for people with mental illness and addictions through a Mayor's Task Force that will recommend key actions and metrics to address this crisis.

Social Grants also play an important role in supporting programs for people with mental illness and addictions. The link between social isolation and mental health is clearly established<sup>3</sup> and points further to the critical role of early intervention. Social Grants to programs that build social connections and avert crisis in this area have increased by 118% since 2012.

In addition, based on self-reporting by non-profit organizations, 26% of people served in programs receiving Community Services grants have a mental illness or addiction. This translates into an investment in CS grants of \$1,324,249.

# 3) Loss of funding across the social non-profit sector

As outlined in previous reports to Council, the last several years have seen considerable cuts to programs in the non-profit sector in Vancouver. These funding challenges are further exacerbated by increased demand on services coupled with rising costs that non-profits must address with unchanged or reduced revenues.

In 2014 non-profits in Vancouver will continue to experience funding cuts and uncertainty as other levels of government continue to make policy and funding changes and other funders reduce their funding allocations.


# i) Repatriation of Settlement Funding from the Province to the Federal Government

For the past 14 years the Province of BC has administered \$100 million (2013) in settlement services in BC through the Ministry of Jobs, Tourism and Skills Training. On April 1, 2014 the responsibility for administration of the settlement programs will return to the Federal government under the supervision of Citizenship and Immigration Canada (CIC). CIC funds services that help newcomers settle and adapt to life in Canada, including language training, information and referrals, help finding employment that matches newcomers' skills and education, and help integrating into Canadian society.

As a result of this transition, there is a concern among service providers that a significant number of newcomers will no longer be able to receive services by CIC funded programs. Due to significantly tighter admission requirements under CIC the following groups will be explicitly excluded from services: temporary foreign workers (and their families), student permit holders (and their families), refugee claimants (other than Government Assisted Refugees), naturalized Canadians (landed immigrants who become citizens) including Canadian Citizens by birth (children of immigrant parents), and permanent residents that have been in Canada more than 5 years. As of March 3, 2014, the Province has indicated that it is considering some level of funding support to clients who are currently ineligible for service by CIC.


All programs that received Provincial settlement funding in the past must now re-apply to CIC. The total funding envelop for 2014-15 will remain around \$100M. Due to the tightened admission requirements outlined above, a number of previously funded programs will likely not receive renewed support. The final number of organizations that will be funded for settlement services will not be announced until after April 2014.

The City of Vancouver has a long standing commitment to supporting immigrant and refugee serving organizations through the provision of grants and other collaborative initiatives. Based on self-reporting by non-profit organizations, 38% of people served in programs receiving Community Services grants are immigrants or refugees. This translates into an investment of \$1,926,097 into work with immigrants and refugees in Vancouver. Staff will continue to monitor the impact of this change in funding and work with affected programs to identify alternative supports.



# ii) City provides crucial core funding and 4:1 leverage from other funders

Staff will continue to work in partnership with other funders to build the capacity of organizations to address funding shortfalls. CS grants represent, on average, 19% of revenue for programs. This 19% is usually in the form of core funding that enables the support of key staff positions and leadership and supports programs to function and remain viable in the face of funding constraints from other sources. Building on this core funding, programs are also frequently able to leverage the City's commitment to seek support from a range of other funding sources. This translates into a 4 to 1 ratio with \$4 leveraged for every \$1 invested by the City.
