## 2. New Park - Yukon Street at West 17th Avenue January 21, 2015

- \$350,000 for park construction to be from the 2015 Capital Budget for the Conversion of Streets to Mini Parks;
- \$150,000 for speed humps and curb bulges to be from the 2015 Capital Budget for Traffic Calming, specifically CAC from the rezoning at 357, 376 and 391 West King Edward Avenue.
