Connor Fesenmaier was escorted to City Hall to speak by private security firm Kaban Security as group warned of potential danger in attending to speak by Private Investigators. SAM Canada is boycotting the hearings because of the level of risk to individuals who oppose the proposal that would see licenses issued to illegal businesses. After making his speech our 18 year old was making his way out of City Hall when an infuriated individual begansays to follow both he and Pamela McColl and security detail. A confrontation was stopped with the assistance of the Kahan security person and two members of the VPD. Global News was on the scene.

Pamela McColl says that people who are scared to come and speak at the public hearings have reason to be so. The VPD has confirmed organized crime's interest in the illegal dispensaries.

Dr. Ballem would give demerit points in the application to any illegal dispensaries seeking a license that had existing bad business operations or had been subject to a warrant execution.

Dr. Ballem also presented a comparison the number of robberies that have taken place in pharmacy which at least out number the number of dispensaries by half. The lesser number of robbers in dispensaries she proports support her proposal. What Dr. Ballem fails to consider is people are not as read to rob the from the Hell's Angels or organized crime.

Dr. Ballem also suggested that part of the monies raised from the license fee - the \$30,000 would go to education. It is our understanding that it is against municipal law to take monies for licenses for any reason other than the cost of enforcement.

The decision from the Supreme Court today defeats Dr. Daly and Dr. Ballem's proposal. As these products pose a very real risk of overdose and accidental use by children they should not be allowed to be sold in a retail store model. The city should not take on this liability.

Dr. Daly presented remarks at City Hall on June 10th. at the Public Hearing that were out right dangerous to the well being and safety of the public. She should be called out by the medical community and addiction specialists. She has no authority as a paid employee of the BC Government to make a speech to advance full legalization of marijuana "advocate for legalization". No place whatsoever discussing the benefits or harms of marijuana and she admitted she is not an "expert". Her use of a graph that is not peer reviewed speaks to her

lack of credibility and her biased and incorrect statements were a disservice to the listening public.

Public statements at this level should be made by those qualified to do so and report to the major medical and health prevention agencies of this country. Dr. Daly would see all drugs legalized including heroin, which puts her at odds with the government of Canada and all 190 of our partner countries in the United Nations with whom we have treaties that

say we have agreed not to move to more permissive drug policies. Dr. Daly and Dr. Ballem pose a threat to public safety and they should be challenged by the medical community for their willingness to promote the sale of untested product through retail outlets, to promote and use of drugs for purposes that have are not supported by science. Dr. Daly was "not concerned about no studies", and the medical community needs to come to this conversation immediately to protect the public from being spoon fed misinformation.

#### Additional information:

Most of you are aware of the several deaths in Colorado attributed to 'marijuana overdose' after the drug was legalized in that state. We often find stories from around the world relating to deaths attributed to marijuana abuse that don't make the national or international news cycle.

However, the world was given warning regarding suicides linked to marijuana abuse in November 09, 2009 when James Cook University researcher Alan Clough wrote the article "Cannabis takes toll on Aborigines", excerpt:

"After 15 years of a cannabis epidemic we're really starting to see the chronic mental effects appearing," Professor Clough said. "We've seen acute psychosis that is irreversible, as well as depression and dependence. Unfortunately we also have the situation where suicide is linked not just with cannabis use but also through withdrawa

Perhaps, if the world had taken notice and would have heeded the warnings of researcher Clough, in 2009, young Tyler Smith [and many others] would still be alive today and a functioning member of society......unfortunately, we will never know......and now we should fully expect that the world will suffer many more tragic deaths attributed to marijuana abuse; as presaged in 2009 by Alan Clough.
