- 1) Mail out services- We have many patients that are unable to leave their homes to pick up their medication. One lady lives in Cortez and she is suffering from Multiple Sclerosis and cancer. She lives on her own and has limited resources for receiving her canna caps that are high in CBD/low THC. If we are unable to provide mail out services she and 1900 other Buddha Barn patients will suffer.
- 2) Community Centres- When revising this issue please keep in mind that all community centres are not created equil. We are almost directly accross the street from the Russian Community centre (which we have sponsored events at for wrestling). RCC hosts a number of adult events and do not have a playground attached to them, they opperate more like a Hall rather than a community centre. We close our doors between 7pm and 8 pm and are willing to work with the city to find a solution that will make everyone happy... Please do not make us move our location.
