

PUBLIC HEARING MINUTES

JUNE 10, 11, 13 AND 22, 2015

A Public Hearing of the City of Vancouver was held on Wednesday, June 10, 2015, at 6:25 pm, in the Council Chamber, Third Floor, City Hall. Subsequently, the meeting was recessed and reconvened on Thursday, June 11, 2015, at 6:06 pm, on Saturday, June 13, 2015, at 10:05 am, and on Monday, June 22, 2015, at 6:08 pm.

COMMITTEE OF THE WHOLE

THAT this Council resolve itself into Committee of the Whole, Mayor Robertson in the Chair, to consider proposed amendments to the Zoning and Development By-law, the Downtown Official Development Plan, and the Downtown-Eastside/Oppenheimer Official Development Plan.

1. Text Amendment: Regulation of Retail Dealers - Medical Marijuana-Related Uses

An application by the Chief License Inspector and the General Manager of Planning and Development Services was considered as follows:

- Summary: To amend the Zoning and Development By-law, the Downtown Official Development Plan and the Downtown-Eastside/Oppenheimer Official Development Plan to:
 - create a new use and definition: "Medical Marijuana-related Use";
 - establish minimum distancing requirements for Medical Marijuanarelated Uses from sensitive uses and from other Medical Marijuanarelated Uses; and
 - allow the use in the following districts in the city: C-1, C-2, C-2B, C-2C, C-2C1, C-3A, C-5, C-5A, C-6, C-7, C-8, FC-1, HA-1, HA-1A, HA-2, HA-3, and in portions of the Downtown District (DD) and the Downtown-Eastside/Oppenheimer District (DEOD).

The General Manager of Planning and Development Services recommended approval.

Council also had before it a Memorandum dated June 8, 2015, from the Acting General Manager of Community Services, and the General Manager of Planning and Development Services, which clarified the proposed regulations as they pertain to minors and put forward housekeeping corrections to the proposed amendments to the Zoning and Development By-law as well as corrections and changes to the proposed amendments to the License By-law.

Opening Comments

Dr. Penny Ballem, City Manager, provided an overview of the proposed regulations, including a review of the changes put forward in the Memorandum dated June 8, 2015.

Dr. Patria Daly, Chief Medical Officer, Vancouver Coastal Health, provided a presentation regarding Vancouver Coastal Health's perspective on the regulation of medical marijuana retail outlets and reviewed their public health recommendations in this regard.

Dr. Ballem and Dr. Daly, along with Andreea Toma, Chief Licence Inspector, and Iain Dixon, Assistant Director of Legal Services - Enforcement and Prosecutions, responded to questions.

Summary of Correspondence

Council received the following correspondence regarding this application since referral to Public Hearing on April 28, 2015, to 15 minutes following the close of the speakers list on June 22, 2015:

- 21 letters and emails in general support
- 55 letters and emails in general opposition
- 63 emails opposed from one individual
- 85 letters and emails related to other matters, plus 5 petitions containing a total of 975 signatures (unaudited)

Speakers

The Mayor called for speakers for and against the application.

Council heard from speakers on June 10, 11, 13, and 22, 2015.

The following speakers expressed general support regarding medical marijuana dispensaries and many were in favour of some form of regulation. The majority expressed concerns regarding one or more of the proposed regulations, such as the ban on edible products, the \$30,000 business license fee, the location and distancing restrictions, the ban on ATMs, and the restriction regarding minors on premises. Several of the speakers expressed opposition to regulating dispensaries, and many speakers expressed support for the Compassion Club and other non-profit dispensaries.
