Modo is a two-way carsharing co-operative, founded in Vancouver in 1997, which now has more than 15,000 drivers sharing 450 vehicles throughout Metro Vancouver and Greater Victoria – including more than 60 in Mount Pleasant alone. Our mission is to provide drivers with an affordable alternative to car ownership that supports livable communities. Two-way, or round-trip, carsharing is part of a multimodal transportation network, supported by walking, cycling and transit infrastructure: an environment in which people can walk or cycle to work, neighbourhood amenities, and take transit or a carshare vehicle to go farther afield. Research on round-trip carsharing has identified that every (round-trip) carsharing vehicle can take 10 or more privately owned vehicles off the road.

Mount Pleasant is one of the most popular carsharing neighborhoods in Vancouver, and working with PC Urban, we are delighted to be part of a redeveloped office building whose tenants will not need to own a car of their own.
