THAT Council, having considered the opinion of local area residents and business operators as determined by neighbourhood notifications, site signs, noise impacts and relevant Council policy as outlined in the Administrative Report dated February 11, 2016, entitled "1161 West Georgia Street - 1052072 BC Ltd - New Liquor Primary Licence Applications - Liquor Establishment Class 2 - Lobby Lounge (Main Floor) - Liquor Establishment Class 3 - Bar/Nightclub (3<sup>rd</sup> Floor)", endorse the request by 1052072 BC Ltd for a new 150 person Liquor Primary liquor licence (Liquor Establishment Class 2 - Lobby Lounge) in the newly constructed hotel at 1161 West Georgia Street subject to:

- i. Limiting Standard hours of operation for the first year to 11 am to 1 am, Sunday to Thursday and 11 am to 2 am, Friday and Saturday; after which time the requested hours of operation of 9 am to 2 am, seven days a week may be considered;
- ii. A maximum total capacity of 150 persons;
- iii. Acoustic report to be submitted certifying that the establishment meets Noise Control By-law requirements;
- iv. Signing a Good Neighbour Agreement with the City prior to business licence issuance;
- v. A Time-limited Development Permit; and
- vi. Food service to be provided while minors are present up to 10 pm.

- vi. Signing a Good Neighbour Agreement with the City prior to business licence issuance;
- vii. A Time-limited Development Permit; and
- viii. Food service to be provided while minors are present as well as on the patio when open.

## 2. 2390 West 10th Avenue - Meraloma Club New Liquor Primary Licence Application and Outdoor Patio Liquor Establishment Class 7 - Private Club March 29, 2016

- i. A maximum total capacity of 107 persons inside and 114 persons outside;

- iv. No music or entertainment permitted on the patio;
- v. A Time-limited Development Permit;
- vi. An acoustic report to be submitted certifying that the establishment meets Noise Control By-law requirements;
- vii. Food service to be provided while the establishment is operating as well as on the patio when open; and
- viii. Signing a Good Neighbour Agreement with the City prior to business licence issuance.

#### 4. Expansion to 2016 Street Cleaning Grants April 28, 2016

Engineering Services staff responded to questions.

The Committee heard from two speakers in support of the report recommendations.

MOVED by Councillor Reimer THAT the Committee recommend to Council

THAT Council approve an expansion to the 2016 Street Cleaning Grant Program totalling \$235,000 to the following recipients for programs that support improvements to street cleanliness, as detailed in the Administrative Report dated April 28, 2016, entitled "Expansion to 2016 Street Cleaning Grants", with funding from the 2016 Street Cleaning Operating Budget:

- Mission Possible Enterprises Society MP Maintenance (\$110,000),
- Coast Mental Health Foundation Employment Services Program (\$75,000),
- Family Services of Greater Vancouver Street Youth Job Action (\$9,000),
- The Kettle Friendship Society SEED Employment Program (\$6,000), and
- The Binner's Project (\$35,000).

## 5. Contract Award for Asphalt Milling Services April 22, 2016

THAT the Committee recommend to Council

- A. THAT Council authorize City staff to negotiate to the satisfaction of the City's General Manager of Engineering Services, City's Director of Legal Services, and the City's Chief Purchasing Official and enter into three separate contracts with the following contractors:
  - B.A. Blacktop as Contractor A (primary contractor) to provide two meter grinders for asphalt milling services; estimated contract value \$2,119,104;
  - Lafarge Canada as Contractor A (primary contractor) to provide one meter grinders for asphalt milling services; estimated contract value \$98,595; and as Contractor B (secondary contractor) to provide two meter grinders for asphalt milling services; to be used only when Contractor A for two meter grinders is unavailable; and
  - Tarmac Grinding as Contractor B (secondary contractor) to provide one meter grinders for asphalt milling services; to be used when Contractor A for one meter grinders is unavailable.

The contracts with the above vendors will be for a term of three years, with the option to extend for two additional one year terms, with an estimated combined contract value of \$2,217,699 plus applicable taxes over the initial three-year term, to be funded through the annual Operating Budget and street paving capital budgets. (Operating 25% and Capital 75%)

- B. THAT the Director of Legal Services, Chief Purchasing Official and General Manager of Engineering Services be authorized to execute on behalf of the City the contract contemplated by A above.
- C. THAT no legal rights or obligations will be created by Council's adoption of A and B above unless and until such contract is executed by the authorized signatories of the City as set out in A and B above.
