This email is in support of the removal of 3738 Cypress Street from the First Shaughnessy Protected Heritage Property List.

I am familiar with First Shaughnessy and the Vancouver Heritage Register. Having been renovated substantially in 1980 - predating the First Shaughnessy ODP -this house has no heritage value whatsoever and never should have been included in the original list of heritage properties in FSD, let alone the Heritage Conservation Area. It should have been removed in the mid 1990's after a review I undertook of the FSDOPD for the Shaughnessy Heights Property Owners Association, but was overlooked. Prior to the creation of the Heritage Conservation Area, I had appealed to city heritage staff and its heritage consultant to have this house removed from the list. It was added anyway and should now be removed.

There are no records of its original appearance and thus no evidence to guide any possible "restoration". This site is ideal for a good, modern new house and garden which will better suit the evolving character of Shaughnessy.
