Dear Mayor and Council,

My husband, Ken Peterson and I live at s.22(1) Personal and Confidential east of the site under discussion. We purchased our house about 26 years ago and have always taken a keen interest in the neighbourhood.

I wish we were in town so that we could attend the public meeting. I send this email in lieu of our appearance.

We are in favour of higher density on the eastside and are also great supporters of heritage houses. Our house was built in 1910 and over the years we have restored it in a way to maintain the original character of the building. We are part of a series of five heritage house on the south side of Confidential

So, in theory we support the redevelopment in question. However, what is objectionable about this plan is the proposed infill house of four units. A square, modern flat roofed 1950's style building is not in keeping either with the Brookhouse Residence or with other houses in the immediate neighbourhood.

I attended an open house several months ago at Brookhouse. There was a model of an attractive, pitched roof design. This would be a style more in keeping with the prevailing architecture.

I urge you not to approve this design as presented. Grandview Woodlands should maintain its heritage character especially on a corner lot on a highly visible street such as Victoria.
