## 1. HOUSING

## a) Presentation - Homelessness Action Week 2016 Update

Kathleen Llewellyn-Thomas, General Manager, Community Services, and staff from Housing Policy and Projects, provided a presentation on "Homelessness Action Week 2016 Update", and responded to questions.

## b) Presentation - Urban Native Youth Association - Native Youth Centre and Housing Project Update

Mukhtar Latif, Chief Housing Officer, and Ginger Gosnell-Myers, Aboriginal Relations Manager, provided an update on the Urban Native Youth Association - Native Youth Centre and Housing Project and, along with Dena Klashinsky, Executive Director, Urban Native Youth Association (UNYA), Tracey Wolsey, Suncor Energy, and the City Manager, responded to questions.

The City Manager acknowledged Debbie Anderson Eng, Senior Social Planner, Social Policy and Projects Division, who will be departing the City, and thanked her for her contributions to the project.

## c) Regulating Short-Term Rentals in Vancouver September 28, 2016

Kaye Krishna, General Manager, Development Services, Building and Licensing, and Mayna Vancaillie, Project Manager, Vancouver Services Review, provided an update on "Regulating Short-Term Rentals in Vancouver" and, along with Andreea Toma, Director, Licensing, Property Use Inspections and Animal Services, and the City Manager, responded to questions.

The Committee heard from twelve speakers in general support of staff's recommendations on regulating short-term rentals. Some speakers offered suggestions on how to strengthen this approach while some expressed concerns related to permitting and licensing aspects, enforcement processes and compliance, and other issues such as the increasing shortage of affordable, long-term rental housing.

MOVED by Councillor Meggs THAT the Committee recommend to Council

A. THAT Council endorse the approach described in the Administrative Report dated September 28, 2016, entitled "Regulating Short-Term Rentals in Vancouver", to allow short-term rentals in principal residences, subject to a business licence.

B. THAT Council direct staff to engage key stakeholders and the public to refine the proposed policy approach, and report back with the by-laws required to enact these regulations and a plan, schedule and resourcing proposal for implementation.

## AMENDMENT MOVED by Councillor Carr

THAT B be amended to add the words "including possibly placing a cap on the number of short term rental nights per year per unit, and allowing the short term rental of a secondary suite without separate permit if the suite is used part time by the principle residence owner," after the words "policy approach,", so that the amendment would read:

# 3. Year 2017 Vehicles for Hire Inflationary Fee Increase September 8, 2016

THAT the Committee recommend to Council

- A. THAT Council approve a 2 percent inflationary increase to compensate for increases to the City's costs for all Vehicles for Hire fees, in accordance with Appendix A of the Administrative Report dated September 8, 2016, entitled "Year 2017 Vehicles for Hire Inflationary Fee Increase".
- B. THAT the Director of Legal Services be instructed to bring forward for enactment the necessary amendments to Vehicles for Hire By-law No. 6066, as shown in Appendix A of the Administrative Report dated September 8, 2016,

entitled "Year 2017 Vehicles for Hire Inflationary Fee Increase", to be effective January 1, 2017.

## 4. Heritage Amenity Bank and Transfer of Density Update October 4, 2016

At the Regular Council meeting on October 4, 2016, Vancouver City Council referred this matter to the Standing Committee on Policy and Strategic Priorities meeting on October 5, 2016, in order to hear from speakers.

The Committee heard from two speakers who expressed concerns regarding rezoning conditions for density bank purchase and completing requirements for enactment.

THAT, effective November 15, 2016, Council authorize the City to accept cash payments in lieu of the purchase and transfer of heritage density for all rezoning applications that have been approved in principle following a public hearing up to July 31, 2016, which included, as part of the offered public benefits, the purchase and transfer of heritage density as a condition of rezoning enactment and for which the applicant has not yet provided a Letter A, Letter B and receipt to the City;

FURTHER THAT all such cash payments be set aside in a reserve for citywide heritage conservation purposes.
