SUBJECT: Cultural Infrastructure Grant Program Review

#### RECOMMENDATION

- A. THAT Council receive for information a summary report on the 2015-16 Review of the Cultural Infrastructure Grant (CIG) Program.
- B. THAT Council authorize a new Critical Assistance Grant category within the CIG Program to assist Vancouver-based non-profit and charitable cultural organizations with unforeseen facility emergency situations and urgent lifesafety improvements, as outlined in this report; and that Council hereby deems any organization meeting the criteria specified in Appendix A of this report to be to be eligible for funding because it contributes to the culture of the City.
- C. THAT Council approve a maximum of \$100,000 for the new Critical Assistance Grant category to provide up to \$25,000 to any single organization, source of funds being the 2017 CIG budget; to be disbursed to organizations meeting the criteria outlined in this report and specified in Appendix A, as approved by the General Manager of Community Services.

Approval of Recommendation C requires eight affirmative votes by Council.

#### REPORT SUMMARY

The CIG Program supports Council's goals for safe, livable neighbourhoods through community based spaces for creation, production and presentation activities, and supports economic development in the creative sector through retention and investment in cultural facilities.

Goals of the CIG Program are:

- To support a robust and diverse ecology of cultural spaces
- To enable the planning, development, renovation and acquisition of cultural spaces
- To strengthen the community's ability to develop, operate and sustain cultural spaces

Staff are submitting for Council's information an update on the CIG Program Review undertaken to determine the strengths and weaknesses of the Program and recommended improvements to ensure its continued/ increased effectiveness. This report also seeks approval of a new Critical Assistance Grant category within the CIG Program for Vancouver-based not-for-profit and charitable cultural organizations that face costs associated with unforeseen facility emergency situations and urgent life-safety improvements.

#### COUNCIL AUTHORITY/PREVIOUS DECISIONS

Since 1975, the City of Vancouver has offered a Capital Grants program supporting infrastructure related projects by Vancouver-based social and cultural organizations.

In 2008, Council adopted Phase I of the 2008 - 2023 Cultural Facilities Priorities Plan, which outlined strategies and tactics for enabling the sustainable creation and operation of cultural infrastructure. One of the key recommendations of the Facilities Plan was the introduction of the Cultural Infrastructure Grant (CIG) Program.

In 2013, Vancouver's Culture Plan: Strategic Directions for the Next Five Years was presented to Council providing a framework to support a diverse, thriving cultural ecology. This was further enhanced in 2014, with the 2014 - 2018 Directions for Cultural Spaces, which reaffirmed the importance of the CIG Program.

In 2015, Council approved a new Permit Fee Assistance Grant within the CIG Program, to assist Vancouver-based non-profit and charitable cultural organizations with their development and building permit fees associated with improving cultural facilities.

#### CITY MANAGER'S/GENERAL MANAGER'S COMMENTS

The City Manager and General Manager of Community Services support the recommendations in this Report.

#### REPORT

#### Background/Context

Established in 2009, the CIG Program supports investment in existing cultural facilities and the planning and creation of new spaces.

The Program provides a model for the delivery of capital grants that enables the arts and culture community to build capacity through the development of facility projects including leveraging investment from other sources of funding. The program is intended to support a

broad range of cultural capital projects located in Vancouver involving planning or feasibility studies, facility purchase, construction, renovation or expansion. It is not designed to provide operating support.

Currently there are four categories of Cultural Infrastructure Grants:

- Planning Projects to a maximum of \$35,000
- Minor Capital Improvements to a maximum of \$35,000
- Major Capital Improvements to a maximum of \$150,000
- Permit Fee Assistance to a maximum of \$1,500 (annual budget \$10,000)

The CIG Program is one of the primary ways in which the City works with cultural not-forprofit organizations to create, maintain and improve cultural infrastructure in Vancouver.

CIG Facts 2009 - 2016: (see Appendix B)

- 251 applications received since introduction in 2009
- 195 infrastructure projects funded with 83 directed to planning /feasibility and 112 directed to minor / major capital projects including real estate purchases
- 64% of projects for improvements to existing spaces
- 36% of projects towards study and development of new spaces
- Over \$7M in funds have been granted for a total of \$35.7M in project activity
- On average, CIG has leveraged a 1:4 ratio of civic investment to external resources.


After 7 years of granting funds to support the planning, renovation, upgrade and acquisition of cultural spaces, a review of the Cultural Infrastructure Program was needed. The Review began in the fall of 2015 and ran through early 2016 with improvements/ alterations to be implemented in the 2017 grant year. Details regarding the Review and associated recommended changes are outlined below.

#### STRATEGIC ANALYSIS


#### 2009-2016 Cultural Infrastructure Grant Program Review

Since its inception in 2009, CIG applications have generally held to the following patterns:

- Average of approximately 33 applications received per year
- Average of approximately \$1.5 \$1.6M in requests annually for approximately \$800,000 in available funds
- Average of 20% of requested funding for planning projects and 80% for capital projects



While the City undertakes selected investments in cultural facilities through its Capital Plan/Budget, the annual CIG Program provides consistent and accessible funding options for arts and culture non-profits with capital needs. The Program has had a significant impact on mitigating the Key Gaps in cultural space identified in the 2008 – 2023 Cultural Facilities Plan (See below and Appendix C).

- Chinese Cultural Centre new roof and renos to Hall and washrooms

- Russian Hall major renos to high-use community space

- Artspeak Gallery Residency/Programming Space purchase of satellite space
- Beaumont Studios artist studio and event spaces
- Green Thumb Theatre conversion of Heritage Schoolhouse to rehearsal space
- Left of Main (Plastic Orchid Dance) renovation to Chinatown space to dance rehearsal space
- O'Brien Centre renovations to consolidate Vancouver Opera's operations
- Progress Lab 1422 creation of collaborative performing arts hub

#### Cultural Infrastructure Grant Review: Fall 2015 - Summer 2016

#### Goals/Purpose:

The purpose of the CIG Review was to assess strengths and weaknesses of the Program and to identify and implement improvements that will ensure the program's ongoing/improved effectiveness.

#### Methodology:

- Research scan of 32 infrastructure grant programs across Canada and the US
- On-line survey strategically directed to over 200 arts and culture organizations in Vancouver as well as broad on-line and social media circulation
- Workshop with Federal, Provincial and local infrastructure funders including VanCity Foundation, Central City Foundation and Tides Canada
- Comments solicited from all prior CIG peer review Assessment Juries since 2009
- Workshop with Cultural Services and Social Policy and Projects staff
- Two joint Arts & Culture Policy Council and Spaces Subcommittee workshops
- Community workshop with 20 cultural organizations

The Review timeline and copy of the survey questions can be found in Appendices F and G.

#### Findings:

From the results of the consultations described above, high level findings included praise for the Grant Program's content and management; support for the continuation of current processes; as well as appreciation of the value CIG contributions have made to organizations and the ecology of cultural spaces in Vancouver. Satisfaction was emphasized in the following areas:

- High degree of satisfaction with the existing program
- Appreciation for the leveraging potential of the program (with other funders)
- Appreciation of the leveraging potential of Program to secure longer term leases (minimum 10-years)
- Support for evaluation criteria co-created with the community in 2008

Suggestions were received for the following:

- Increase overall budget
- Emphasize investment in existing spaces first, then strategic new spaces
- Encourage flexibility and innovation in all categories of the Program
- Address needs city-wide and in neighbourhoods
- Improve / streamline application, processing and grant payments
- Seek greater rigor from organizations and projects re: long term sustainability, public value and organizational fundraising ability

From the Review, Program Recommendations fell into three categories: a) no change, b) encouragement to improve, but not over all change and c) change.

- a) & b) No Change to Existing Program:
- Program Goals
- Program Categories of "Planning" & "Minor and Major Capital"
- Evaluation Process (blended community/staff juries)
  - Emphasize diversity and capital project expertise<sup>1</sup>
- Assessment Criteria
  - Emphasize net benefit to community & operational sustainability
  - Tie into Update to Key Gaps / Criteria for Evaluation (study underway)
- Eligible items
  - Emphasize what is eligible/ineligible
  - Seek additional funds in 2019 2022 Capital Plan for an equipment component to the Grant Program
- Grant Intake Cycle (1x per year)
- Matching funding levels (50%, with 25% of project budget eligible as in-kind)
- c) Changes to Existing Program:
- Add new Program Category Critical Assistance Grant
  - Max \$25,000 per grant, total annual budget \$100,000 (criteria and budget pre-approved by Council, grant assessment and

distribution at staff discretion according to specific criteria, subject to approval by the General Manager of Community Services)

- Increase Funding levels
  - Minor Capital from \$35,000 to \$50,000
  - Major Capital from \$150,000 to \$250,000
- Reduce Quote Requirement
  - Projects up to \$10,000 one quote
  - Projects \$10,001 -\$ 50,000 two quotes
  - Projects \$50,001 \$250,000 three quotes
- Enhance Payment Schedule
  - Grants up to \$50,000 payments in increments of 80%/20%
  - Grants \$50,001 \$250,000 payments in increments of 50%/30%/20%

These proposed changes were seen as having the greatest impact on the accessibility of funds and the ability for organizations to more effectively improve the environment for cultural space development in Vancouver.

#### Critical Assistance Grant

Since the inception of the Program and reaffirmed through the Review, it has been recognized that a single annual intake did not allow for time-sensitive facility-related emergency situations or urgent life-safety issues that organizations might encounter throughout the year. As such, a new Critical Assistant Grant has been recommended to be available throughout the year on a rolling intake basis, subject to criteria detailed in Appendix A, and evaluated and disbursed by staff subject to approval by the General Manager of Community Services.

Grants of up to a maximum of \$25,000 will be awarded within a total maximum annual budget of \$100,000. Grants will be awarded on a first-come, first-served basis until the annual budget is depleted. Evaluation of the applications will be undertaken by staff and subject to approval by the General Manager of Community Services.

With this report, staff seek Council's approval of the a new Critical Assistance Grant category and authorization to allocate \$100,000 from the 2017 CIG budget to the 2017 Critical Assistance Grant.

#### FINANCIAL IMPLICATIONS

This report seeks approval to create a new Critical Assistance Grant category within the CIG Program to assist Vancouver-based non-profit and charitable cultural organizations with unforeseen facility emergency situations and urgent life-safety improvements.

In addition, Council approval is requested to provide grants under this new Critical Assistance Grant category to a maximum of \$100,000, and up to \$25,000 to any single organization.

The increase in funding levels for minor and major capital and the new Critical Assistance Grant will take effect in January of 2017 and will be funded through the 2017 Cultural Infrastructure Grant Capital Budget; the Critical Assistance Grant to be disbursed to organizations meeting the criteria outlined in this report and specified in Appendix A, as approved by the General Manager of Community Services.

#### CONCLUSION

Implementation of the Cultural Infrastructure Grant Review including the new Critical Assistance Grant supports the successful continuation of the Grant Program and establishes improvements and efficiencies that will benefit the community in their goal to create relevant, sustainable cultural spaces in Vancouver.

#### CRITICAL ASSISTANCE GRANT - ELIGIBILITY CRITERIA

#### 1. ORGANIZATIONAL ELIGIBILITY

To be eligible for assistance, the applicant must:

- 1. Be a Vancouver-based non-profit society or community service cooperative legally registered and in good standing with the BC Registry Services, or a First Nations Band Council, or a registered charity with the Canadian Revenue Agency (CRA), with an active volunteer board of directors, that has operated for at least one year and has a clear arts and culture mandate;
- 2. Demonstrate financial stability and sound administration and the capacity to undertake the proposed project; and
- 3. Own the space where the project is located, or have a minimum 10-year lease for the space.

#### PROJECT ELIGIBILITY

#### To be eligible for assistance, the project must:

- Be unforeseen facility repairs, replacement or clean up resulting from 1) loss or failure of existing infrastructure or 2) urgent life / safety requirements, this may include water or fire damage, vandalism, post-disaster emergency cleaning, or replacement of building systems; and
- 2. Be sufficiently urgent that project cannot wait until the next CIG intake as failure to remediate could lead to further major system or structural failure or threaten life-safety.

#### INELIGIBLE PROJECTS

#### Funding is not available for:

- 1. Projects/items covered by insurance, and/or expenses for which funding has already been granted by the Cultural Infrastructure Grant;
- 2. Regular / scheduled maintenance;
- 3. Programming, operational, or administrative expenses;
- 4. Movable equipment repair or replacement; and
- 5. Legal costs

### NINE KEY GAPS IN CULTURAL INFRASTRUCTURE 2008-2023 Cultural Facilities Priorities Plan:

- Development of live presentation facilities that address demand in the 400-seat to 600-seat range.
- Addressing the demand for high-quality, dedicated performance spaces under 250 seats to ensure ongoing incubation of emerging organizations.
- Strategic public space improvements to address outdoor festival demand.
- Improvements to existing performance spaces including enhancements to key multi-functional facilities with potential to deliver high quality presentation opportunities.
- Stabilization and enhancement of key collections through modernized preservation, exhibition, and engagement infrastructure.
- Development of co-location facilities that are accessible, safe, and stable for large format storage/production workshop activities.
- Development of organizational co-location facilities that integrate multiple functions in one location (e.g. rehearsal/ production/administration activity).
- Development of multi-tenant, artist workspaces that provide supportive opportunities for cross-fertilization, collaboration and incubation through a mix of cultural, civic, and entrepreneurial uses and tenures.
- Maximization of opportunities to maintain and develop affordable Artist Live/Work Studios in the core neighbourhoods.

#### ARTSPEAK

Artspeak has had the opportunity to purchase a second space in our neighbourhood of Gastown, with the steadfast support of the Cultural Infrastructure Grant. The acquisition of the second space opens up new possibilities for our office, library and archives, and also an increased ability to diversify our programming and outreach activities in support of artistic practices in the city, as well as enabling the flexibility of our current space. Having been funded through multiple phases of this expansion plan, we are a testament to the importance and impact of the Cultural Infrastructure program.

#### ASSOCIATION OF BOOK PUBLISHERS OF BC

The Association of Book Publishers of BC has been working methodically for several years on a project to realize a Literary Arts Centre for Vancouver. The funds we have received through the Cultural Infrastructure Grants were absolutely crucial to focus our thinking on the purposes of the building, determine our space needs, and identify areas of the city that would be appropriate for the users of the space, among many other factors. We now feel prepared for the next stage of our project.

#### CONTEMPORARY ART GALLERY (CAG)

Funds secured through the [CIG] toward the renovation of the reception area, the initiation of a visitor resource area and establishment of an in-house bookstore has impacted [CAG] positively in terms of audience development, visitor numbers and engagement as well as increased our potential to secure finances through earned revenue. [Further] support from CIG helped support both a feasibility study and the repurpos[ing] of a storage room into an events space for educational activities, for families, children and donors. This has proved invaluable in gaining a greater flexibility of function, and securing a dedicated space from which to deliver key learning and educational work for a diverse breadth of Vancouver's communities.

#### **GREEN THUMB THEATRE**

With the assistance from the Cultural Infrastructure Grant program, Green Thumb Theatre was able to repurpose and renovate 2 buildings that are now our facility, housing administrative offices and 2 rehearsal halls. We have a space that is secure for the next 16 years, we have creation space that can be used not only by our organization, but also by the rest of the arts community in Vancouver and at the same time we have lowered our operating costs and increased our revenue potential.

#### MAISON DE LA FRANCOPHONIE


The Cultural Infrastructure Grant program (CIG) give access to local infrastructure funds as well as careful listening, advice, and expertise. It's a tremendous support. With the CIG program support, we were able to carry on a feasibility study focused on implementation process, land's assemblage, and exploration of a relocation option [which] helped us to get a clear picture of each scenario and gave us guidelines and recommendations. It [also] allowed us to better coordinate collaboration and ideas exchange, therefore enhancing participation of the stakeholders.

#### PLAYWRIGHT'S THEATRE

CIG made it possible to transform an old pork roastery into a superbly-located 4000 sf centre for new theatre creation. With 10 theatre companies sharing the space, and over 50 studio users over the course of the year, PTC's HUB and Test Kitchen Studio have created a home for the many companies who make inventive and challenging work on a shoestring. Collaborations between companies, resource sharing, and a welcoming space for independent writers have all been made possible through investment from the City, Province of BC, and the many artists whose low cost rental fees keep the doors open.

#### PLASTIC ORCHID FACTORY

Support from the city of Vancouver's cultural Infrastructure Program has been immensely impactful on Plastic Orchid Factory's growth and ability to realize its mission. We have gained the confidence and knowledge needed to move our dance space project into reality. It's incredible to be able to say that after only three short years, we have taken possession of a collaboratively spirited, artist-run space and renovations are imminent! But beyond our gain as an organization, the cultural landscape of Vancouver will benefit. The dance community in particular will be transformed




