## AGENDA ITEMS

#### 1. Electric Vehicle Ecosystem Strategy October 19, 2016

Gil Kelley, General Manager, Planning, Urban Design and Sustainability, and staff from the Sustainability Group provided an overview of the report and, along with the City Manager, Doug Smith, Acting Director, Sustainability Group, and staff from Parking Management, responded to questions.

The Committee heard from four speakers in support of the strategy.

THAT the Committee recommend to Council

- A. THAT Council adopt the *Electric Vehicle Ecosystem Strategy*, as presented in Appendix A of the Administrative Report dated October 19, 2016, entitled "Electric Vehicle Ecosystem Strategy", and direct staff to begin implementation of the priorities therein. Staff will seek subsequent Council approval as necessary on specific initiatives in the Strategy as well as programs and projects that require regulatory changes or significant financial investments that cannot be accommodated in the capital request included in Appendix A of the above-noted Administrative Report.
- B. THAT Council approve a multi-year project budget of \$500,000 to support the initial implementation of the *Electric Vehicle Ecosystem Strategy* as a pilot project, to be funded from Emerging Priorities in the 2015-2018 Capital Plan as follows:
  - \$250,000 from the unallocated cash Community Amenity Contribution (CAC) associated with the rezoning of 999 Seymour Street in 2008 for new Electric Vehicle infrastructure in the Metro Core; and
  - \$250,000 from the Gas Tax Fund Community Works Reserve for new Electric Vehicle infrastructure located outside the Metro Core;

FURTHER THAT expenditures will be managed within the City's overall Annual Capital Expenditure Budget.

- C. THAT Council direct staff to pursue funding and partnership opportunities with senior levels of government and private sector partners to advance the *Electric Vehicle Ecosystem Strategy.*
- D. THAT Council direct staff to report back in 2017 and annually until 2021 on the status of the *Electric Vehicle Ecosystem Strategy*.

- C. THAT the MOU be on such terms as are generally described in the Administrative Report dated October 18, 2016, entitled "The Greenest City Fund: Updates and Revisions", and such other terms as are approved by the City Manager.
- D. THAT the Director of Legal Services be authorized to sign the MOU on behalf of the City but that no legal rights or obligations will be created unless and with such MOU is executed and delivered by the Director of Legal Services and the Vancouver Foundation.

#### 4. 39 Smithe Street and 45 Smithe Street - Parq Holdings Limited Partnership Application to Relocate and Amend Liquor Primary Licences September 23, 2016

The Committee heard from two representatives of the Applicant, Parq Holdings Limited Partnership, who spoke in support of the application.

Andreea Toma, Director, Licensing, Property Use Inspections and Animal Services, along with Mary Clare Zak, Managing Director, Social Policy, and representatives of the Applicant, responded to questions.

MOVED by Councillor Deal THAT the Committee recommend to Council

> A. THAT Council, having considered the opinion of local area residents and business operators as determined by neighbourhood notifications, site signs, open house, noise impacts and relevant Council policy as outlined in the Administrative Report dated September 23, 2016, entitled "39 Smithe Street and 45 Smithe Street - Parq Holdings Limited Partnership Application to Relocate and Amend Liquor Primary Licences", endorse the request by Parq Holdings Limited Partnership for an increase in person capacity for the Liquor Primary Licence (#302500) from 2494 persons to 5000 persons (Liquor Establishment Class 6-Casino/Entertainment Venue) and relocate from 760 Pacific Boulevard to 39 Smithe Street subject to:

- i. A maximum total capacity of 5000 persons to include three restaurants, two lounges, patio, casino and private gaming salons located over two floors;
- ii. No increase in slots and gaming tables;
- iii. Acoustic report to be submitted certifying that the establishment meets Noise Control By-law requirements;
- iv. The outdoor patio ceasing all liquor service and vacated by 11 pm nightly;
- v. No music or entertainment permitted on the patio;
- vi. Signing a Good Neighbour Agreement with the City prior to business licence issuance; and
- vii. A Time-limited Development Permit.
- B. THAT Council, having considered the opinion of local area residents and business operators as determined by neighbourhood notifications, site signs, open house, noise impacts and relevant Council policy as outlined in the Administrative Report dated September 23, 2016, entitled "39 Smithe Street and 45 Smithe Street Parq Holdings Limited Partnership Application to Relocate and Amend Liquor Primary Licences", endorse the request by Parq Holdings Limited Partnership to reduce the person capacity for the Liquor Primary Licence (#303909) from 405 persons to 125 person interior lounge with a 225 person courtyard patio located on the 6<sup>th</sup> floor of the Douglas Hotel (Liquor Establishment Class 2 Hotel Lounge) and relocate from 750 Pacific Boulevard to 45 Smithe Street subject to:
  - i. A maximum total capacity of 125 persons inside and 225 persons on the patio(reduction of 55 persons) located on the 6<sup>th</sup> floor;
  - ii. Acoustic report to be submitted certifying that the establishment meets Noise Control By-law requirements;
  - iii. Signing a Good Neighbour Agreement with the City prior to business licence issuance;
  - iv. The outdoor patio ceasing all liquor service and vacated by 11 pm nightly;
  - v. No music or entertainment permitted on the patio;
  - vi. A Time-limited Development Permit; and
  - vii. Food service to be provided while minors are present as well as on the patio when open.

### 6. Encouraging Homes for Renters: Recommended Approach for Taxing Empty Homes November 6, 2016

Staff from Housing Policy and Projects, along with Heidi Granger, Assistant Director, Lawyer Administration, Legal Department, and Patrice Impey, General Manager, Finance, Risk and Supply Chain Management, responded to questions.

The Committee heard from three speakers in support of the recommendations and five speakers who were opposed.

THAT the Committee recommend to Council

- A. THAT Council approve the program to impose and collect a tax on empty homes as set out in the Administrative Report dated November 6, 2016, entitled "Encouraging Homes for Renters: Recommended Approach for Taxing Empty Homes", with all net monies raised from the tax to be used for the purposes of affordable housing initiatives.
- B. THAT Council approve, in principle, and instruct the Director of Legal Services to bring forward a by-law to impose and collect a tax on empty homes generally as set out in Appendix A of the Administrative Report dated November 6, 2016, entitled "Encouraging Homes for Renters: Recommended Approach for Taxing Empty Homes", for enactment.

## AMENDMENT MOVED by Councillor De Genova

THAT the motion be struck and replaced with the following:

- A. THAT Council direct staff to explore approaches and options that provide incentives to homeowners who choose to rent vacant homes, secondary suites or laneway homes for the purposes of increasing the most affordable rental stock and encouraging affordable housing initiatives and report back to council with recommendations within 60 days.
- B. THAT Council direct staff to consider a grant or property tax reduction for homeowners who choose to rent a secondary suite, laneway home or a portion of their residence, and give consideration for offering additional incentives to homeowners providing rental below the Housing Income Limit rates.
- C. THAT Council direct staff to consult with property owners and real estate developers and consider ways to increase rental housing stock offered for fixed lengths of time. Furthermore, that staff consider offering greater certainty for timelines surrounding the City of Vancouver's Development Application process as an incentive for applicants who participate in providing rental housing during the application process and/or before demolition of existing homes.

C. THAT staff do further analysis with the Canada Mortgage and Housing Corporation and other organizations as needed to assess the number of homes in the city that are subject to the 2017 Empty Homes tax, including those frequented for family purposes, and report back to Council in advance of the 2018 Empty Homes Tax period.

The City Manager clarified that on page 6 of the report, the last sentence in the second paragraph, "An owner and their spouse may only designate one principal residence between them." be removed.

THAT Council instruct staff to develop criteria to exempt secondary homes that are used for a significant portion of the year by the owner or owner's family for the 2017 tax period and on an interim basis until the review of data has been completed to inform possible changes for the 2018 tax year.

# 7. Support for a Democratically Elected Board of Education

At the Regular Council meeting on November 15, 2016, Vancouver City Council referred this matter to the Standing Committee on City Finance and Services meeting on November 16, 2016, to hear from speakers.

The Committee heard from three speakers in support of the motion and one speaker who, while in support of the return of a democratically elected Vancouver Board of Education, spoke in opposition to the motion.

The Committee agreed to sever the vote on parts A and B of the motion.

# MOVED by Councillor Reimer

THAT the Committee recommend to Council

## WHEREAS

- 1. On November 15, 2014, nine individuals were democratically elected to the Vancouver Board of Education (VBE) for a term of four years by a process certified by the City of Vancouver and Elections BC;
- 2. On October 17, 2016, the provincial government's Minister of Education dismissed the VBE and replaced them with one appointed individual;
- 3. The City has a number of resident advisory committees and other bodies in which it reserves a spot for a VBE trustee with the assumption that the individual appointed by the VBE has a direct mandate from Vancouver residents;
- 4. Several advisory committees have expressed confusion or concern about having an individual with no mandate from Vancouver residents act in any capacity on an advisory committee established to empower resident voices;
- 5. The BC School Trustees Association (BCSTA) passed a motion calling on the provincial government to hold an election to fill vacant trustee positions no longer than six months from the date of dismissal of a democratically elected board and as soon as is feasible;

6. Residents of Vancouver deserve the same right as residents of every other municipality in the Province of BC to independent and democratically elected School Trustees to represent their interests in regard to education, school facilities and related matters.

# THEREFORE BE IT RESOLVED

A. THAT, interim to the provincial government requiring an election to allow for a democratically elected Vancouver Board of Education (VBE), the terms of reference for City of Vancouver Type A and B committees be amended to remove a request to the VBE to appoint a "liaison trustee" and instead invite the most recently democratically elected individuals to the office of School Trustee to apply to be a non-voting "special representative".

B. THAT Vancouver City Council write to the Minister of Education and the Premier to state unequivocal support for the return of a democratically elected Vancouver Board of Education as soon as is feasible and no later than six months from the date of dismissal.

CARRIED (Vote No. 01590) (Councillors Affleck, Ball and De Genova opposed) (Councillor Jang absent for the vote on Medical Leave) (Mayor Robertson absent for the vote)
