After two weeks I landed at Vancouver, my baby was found stillbirth. I could not image if I didn't get to know the church members before it happened. They helped me to go through my hardest period of time. What they offered were more than I expected they visited me, cooked for me, introduced job for my husband and prayed with me. I could feel the warmth and love given by the brothers and sisters at the church.

Besides that, I was invited to be a part-time staff at LLH in 2006 December. That was the time I truly witness the beauty of this Christian based non-profit organization. LLH never hire a full-time staff, as they wanted to lower their cost to benefit more people. But all part-time staff usually worked over-time voluntarily. I could say what I learn from the value of LLH was "Making a difference to one's life is more important than earning more money." Therefore, it was not hard to find many free or low fee programs and activities at LLH. We had many summer day camp and tutorial class children continuously registering with us every year from G1 all the way to G8. That can really show even LLH services are low cost, but still has high quality.

I really glad to see that City of Vancouver is getter more prosper. However, we could not neglect the needs of ethic and moral development. LLH and the church of God in Vancouver are using love and care to create a better community and bonding people together. Their aim is to make a lovely world for us and to our next generation. I hope that City of Vancouver can appreciate their hard works through out these 17 years and consider helping them to continue their services in Vancouver.

## Dear Mayor Gregor Robertson and council for the City of Vancouver,

My name is Christina, and I have been living in this beautiful city since 2009. I decided to move here to further my education at one of the top universities in the country and learn to be a global citizen, while making an impact in the local community I live in. I am writing to you concerning the rezoning project of the Mount Pleasant Industrial Area, east of Quebec Street.

Although I am sure you have and are receiving many letters concerning this project with seemingly similar content, I wanted to exercise my responsibility as a citizen to ensure that my voice was graciously heard. I trust you also agree with my belief that the unique and diverse people of different backgrounds, education levels, skillsets and lifestyle choices are the very people that make Vancouver so special- it is each and every individual that brings the vibrancy and evolution that builds the beautiful world-class city that you and I call home.

When I first heard about the rezoning of the Mount Pleasant area in October 2016, I was left curious and anxious. I am deeply affected because although I do not live in this neighbourhood, I do spend at least 3 days every week in this unique area to volunteer and teach children English and cooking skills, to support immigrant families and newcomer students, to uplift seniors who would otherwise be isolated, to come together with the people I call family at my Christian church, as my blood- related family is over a thousand kilometers away. I do this all outside of my regular day-job hours where I work to better the health of Vancouverites affected by mental illness, poverty, drugs, chronic diseases and acute medical emergencies.

The Mount Pleasant area is a unique space, now with new digital and creative businesses thriving in recent years, in close vicinity to Olympic Village, one of the world's best seawalls, and some of the city's finest coffee shops and ethnic eateries; it is evidently a flourishing neighbourhood. However, all this could be "just another busy place" where people go to work, grab coffee, and go for a run. It's nice, but what makes a neighbourhood a community is undoubtedly the people who care and love, the people to give with any resource they have- time, skill, heart, the people who have a heart to help others to grow, those who think of their neighbours before themselves, those who work and play with one another in laughter and with purpose.

This is what concerns me: losing the opportunity to contribute and connect to and help others in the Mount Pleasant area and from all of Vancouver due to lack of space in the neighbourhood. Yes, we can continue to try to help and reach out to those who need it, but what enables our actions is having the space and resources to do so-not only having the people who are willing to help. Willing hands need a place to station, just like all the dozens of non-profits and churches in the city that bring meaning to people's lives.

I agree with the city- I want this neighbourhood to grow, and that's why new developments are exciting; rezoning is exciting. I applaud the city for investing in infrastructure, as this lays the groundwork for growth. Another necessary pillar for the

We have rented the building for more than 18 years, but we did not receive sufficient notice about City's rezoning plan. I go to this place for gatherings/meetings more than three days a week. This is my home and family. I was disappointed that City ignored our needs and concerns.

My biggest concern is where I can get help and supports from our church \& LLH in the future if we can no longer have meetings here. I have received physical helps and mental health supports from our Church \& LLH since I first landed in Vancouver and lived in Mount Pleasant area 13 years ago. I got the sense of belonging to Canada due to their services. My second concern is about the community service in the neighborhood expecially in the areas of China Town \& Mount Pleasant. In the past, LLH organized a lot of programs, events, and meetings for kids, students, workers, adults, families, new immigrants and different interests/ages groups.

If we cannot keep to stay in this location, our members and the residents in the neighborhood are going to miss us and our services because we caused many people to have life changing experiences. They see light and love in this world.

Our Church and LLH are most important to my life. What affect them concerns me. I was frustrated with City's rezoning plan because City did not consider our needs and concerns. These are the reasons motivated me to attend all the City's open houses and rally to City Hall in October and November 2016.

Therefore, I strongly request City of Vancouver to address to the needs of our Church and LLH. We are contributing our time, energy and money to the community services in the neighborhood but City did not support us with providing a good meeting place with sufficient facilities. We strongly recommend City to keep us either in the same place with more facilities or providing a better place in the same neighborhood.
