Paul Mochrie, Deputy City Manager, provided an update on the funds allocated toward initiatives to address the Opioid Crisis. Dr. Perry Kendall, Provincial Health Officer, and Dr. Patricia Daly, Vice President, Public Health and Chief Medical Officer, Vancouver Coastal Health, reviewed actions taken by the Province and Vancouver Coastal Health with regard to the Opioid Crisis. * * * * *

Following the presentations, at the request of the Mayor, a moment of silence was observed in the Council Chamber, in respect of the loss of life that has resulted from the Opioid Crisis.

2. Contract Award for ITT PS20161666 Vancouver Landfill -Phase 3 Southeast Closure and Gas Works March 11, 2017

Engineering Services staff responded to questions.

MOVED by Councillor Carr THAT the Committee recommend to Council

- A. THAT Council authorize City staff to enter into a contract with BD Hall Constructors Corp., for Phase 3 Southeast Closure and Gas Works, for a term of six (6) months, with an estimated contract value of \$7,338,645, plus applicable taxes over the term, to be funded through the 2015-2018 Capital Plan.
- B. THAT the Director of Legal Services, Chief Purchasing Official and General Manager of Engineering be authorized to execute on behalf of the City the contract contemplated by A above.
- C. THAT no legal rights or obligations will be created by Council's adoption of A and B above, unless and until such contract is executed by the authorized signatories of the City as set out in A and B above.

THAT the Committee recommend to Council

- A. THAT Council approve the amendments to the Water Works By-law, generally as set out in Appendix B of the Administrative Report dated March 31, 2017, entitled "Prohibition of Non-recirculating Uses of Water and Enhanced Water Efficiency Requirements to Support Water Conservation", to expand the prohibition of non-recirculating uses of drinking water, including certain commercial air conditioners, coolers, ice machines, and liquid ring vacuum pumps, in support of the Greenest City Action Plan.
- B. THAT Council approve the amendments to the Vancouver Building By-law, generally as set out in Appendix C of the Administrative Report dated March 31, 2017, entitled "Prohibition of Non-recirculating Uses of Water and Enhanced Water Efficiency Requirements to Support Water Conservation", to enhance water efficiency requirements pertaining to plumbing fixtures and equipment in support of the Greenest City Action Plan, and to create consistency with the 2015 National Plumbing Code.
- C. THAT Council direct staff to review opportunities to further strengthen performance requirements beyond the 2015 National Plumbing Code for commercial and household fixtures and appliances to support improved water efficiency and receiving water quality, considering full life cycle costs.
- D. THAT Council instruct the Director of Legal Services to bring forward for enactment amendments to the Water Works By-law as set out in Appendix B of the Administrative Report dated March 31, 2017, entitled "Prohibition of Non-recirculating Uses of Water and Enhanced Water Efficiency Requirements to Support Water Conservation", to take effect upon enactment.
- E. THAT Council instruct the Director of Legal Services to bring forward for enactment amendments to the Vancouver Building By-law as set out in Appendix C of the Administrative Report dated March 31, 2017, entitled "Prohibition of Non-recirculating Uses of Water and Enhanced Water Efficiency Requirements to Support Water Conservation", to take effect January 1, 2018.

6. 2017 Community Services and Other Social Grants March 28, 2017

Source of funding is the 2017 Community Services Grants budget.
- B. THAT Council approve 9 Social Responsibility grants totaling \$172,000 from the Social Responsibility Fund (SRF), as listed in Appendix D of the Administrative Report dated March 28, 2017, entitled "2017 Community Services and Other Social Grants". Source of funding is the Edgewater Casino Social Responsibility Reserve.
- C. THAT Council approve 18 Childcare Reserve Grants totaling \$577,995, as listed in Appendix F of the Administrative Report dated March 28, 2017, entitled "2017 Community Services and Other Social Grants". Source of funding is the Childcare Reserve Grant budget.
- D. THAT Council approve 2 Childcare Administration Grants totaling \$374,906 as outlined in Table 6 of the Administrative Report dated March 28, 2017, entitled "2017 Community Services and Other Social Grants". Source of funding is the 2017 Childcare Grants budget.
