Dear Mayor and Councillors:

As a long-time resident of Chinatown, Strathcona and the Downtown Eastside since 1974, I write to register my strong objection to the proposed development at 105 East Keefer and Columbia by the Beedie Development Group.

Vancouver's Chinatown is a municipal, provincial and national treasure. Designated a National Historic Site of Canada in June 2010, Vancouver's Chinatown is "one of the oldest and largest Chinatown's in the country....the heritage value of Vancouver's Chinatown lies in its ties to the development of the social and cultural life of Chinese immigrants to British Columbia and Canada..."

Chinatown is the heart of Vancouver's Chinese Canadian community. It is also the heart of Vancouver. Vancouver's Chinatown is a defining feature of Vancouver. It is one of the pillars of what makes Vancouver who we are. What makes Vancouver different. Special. Unique.

Sadly and tragically, Chinatown's distinctive identity is being degraded by overly rapid, too large, and culturally insensitive development that is diluting and undermining Chinatown's value as a national historic site appreciated by locals and tourists alike.

I agree with the headlines in today's Vancouver Sun (May 23, 2017), that 'Preserving Chinatown Should Be of Local and National Importance'. I also agree with the assertion that the recent two large condo towers built on Main at Keefer in 2014, rather than improving Chinatown, have altered Chinatown for the worse.

With these massive developments, low income residents and businesses are being displaced at an alarming rate. Chinatown is losing its soul and being turned into a hip place to live for those with money; a Yaletown North. In the process, Vancouver is selling its soul.

I object to this proposal on the following grounds:

- This project will accelerate the displacement of Chinatown's low income community and dramatically contribute to the gentrification sweeping across our national historic treasure;
- The building is too large, monolithic and dwarfs the surrounding gardens, museums and street life;
- The 'affordable' rental rates for the seniors units are too few and unaffordable for low income residents of Chinatown.

I am also very concerned that, if built as proposed, the 'affordable' units for seniors will be resided in by seniors who currently do not live in the neighbourhood: middle income seniors will displace local low income resident seniors. It is vital that the housing on this location, in the heart of Chinatown, be for those most in need: the low income seniors of Chinatown.

I urge Council to reject Beedie's 105 Keefer Rezoning application.

I urge Council to be visionary.

I urge Council to take leadership. Work with the federal government to acquire and develop this property as a site for local low-income seniors' social housing, and community cultural activity that supports the seniors and respects the scale, heritage, culture and social context of Chinatown.

I am writing to state my opposition to the proposed development and rezoning at 105 Keefer Street. The proposed development does not reflect the intent of the HA-1A zoning, the characteristics of this culturally sensitive and significant area, and does not consider input given by a city council-appointed group Chinatown Historic Area Planning Committee (CHAPC) nor other groups deeply engaged in Chinatown's preservation and revitalization.

The proposed development's height and density is excessive and will have a long lasting negative impact on the immediate neighbouring buildings, gardens and recreational facilities as well as Chinatown as a whole. This particular building will "stick out like a sore thumb". As well, upon learning that the second floor will contain 25 units of social housing along with amenity space, it made me wonder how livable those low income units could possibly be.

I have never lived in Chinatown, but as a family we would go there every week to buy groceries and purchase items that were culturally unique. We would meet with friends, enjoy meals and parties, and celebrate Chinese new year and other significant Chinese holidays. When we went to Chinatown, I felt a strong bond with my cultural heritage and I still do today. It may not be the same Chinatown as it was when I was growing up but there are countless people who care about it and are willing to put energy into revitalizing it. I am one of those people and Chinatown matters to me.

The history of Chinese people in Vancouver and Chinatown are well known. People of Chinese descent were racially discriminated against and subjected to mobs, the head tax and segregation. These decades of oppression had dismissed the rights and dignities of Chinese people. Despite significant difficulties, Chinatown and Chinese people thrived and helped build Vancouver, contributing to our society in many ways and fought for our country during the horrific world wars. So I pose these questions:

- How could Chinatown be given the National Historic Site of Canada designation and also be put on the "endangered list"?
- Why must generations of Chinese-Vancouverites and its many supporters still need to fight for its rights and the preservation of this significant area?
- Why have the voices of CHAPC and Chinatown's advocates been ignored?

There still seems to be a considerable disconnect between the City and the understanding of the cultural significance of Chinatown. Vancouver cannot be considered a model city if it intentionally dismisses the voices of the very people who are its long standing citizens.

Apologies from governments over their actions in discriminating against the Chinese people are affirming and its now up to you, Mayor and Councils to consider that your actions will speak louder than words when considering the preservation of Chinatown and the history of the Chinese people. Any building that is built on the 105 Keefer lot or in any area of Chinatown and Strathcona should consider the cultural importance of these areas first and foremost. We must bring honour and relevance to early Chinese settlers and indeed the Chinese people here today.

I ask that you consider a moratorium on any new developments in Chinatown and Strathcona and further revisions made to the zoning by-laws to further protect these culturally rich areas and in particular in regards to height and density/FSR. I am sure that there are many innovative ideas collected by CHAPC, advocate groups and generations of Chinese-Vancouverites for the preservation, restoration and revitalization of Chinatown. They should be considered and in fact a priority to be heard first.

Re: 105 Keefer Public Hearing

Over the past year and a half, we have commented on three iterations of the proposal for 105 Keefer and have repeatedly questioned what the proposed development does for the context of Chinatown as a place for people with distinct ways of life. As the proposal goes to public hearing on May 23, we maintain our strongest opposition.

For almost 20 years, international policy and principles for sustainable cities have emphasized that new development in historic districts should fit into the physical place, and contribute to the everyday lives of people who work and live in these areas. We are gravely concerned about the lack of a meaningful relationship between this proposed development and the built and human environment in Chinatown, and the consequent threat to the integrity of the cultural landscape. Parks Canada Standards and Guidelines for Historic Places defines cultural landscape as "any geographical area that has been modified, influenced or given special cultural meaning by people, and that has been formally recognized for its heritage value. Cultural landscapes are often dynamic, living entities that continually change because of natural and human-influenced social, economic and cultural processes."

As pointed out previously, while visual relationships are important and the various iterations of this proposal have tried to address them, the pattern of land use and how people live their lives in this area are significant character defining elements that the proposal fails to address. New development needs to respect the values that have shaped the cultural landscape and are integral to its significance for all Vancouverites. The rapid socio-economic change and displacement the proposed development will unavoidably bring, especially taken together with the three large scale developments nearby along Main (developments on 129 Keefer and 134 Keefer are upcoming), directly threaten the integrity and values of the cultural landscape. UNESCO's Vienna Memorandum is a useful basis for these views. Now twelve years old, the memorandum marked an important milestone in understanding that historic districts must be approached holistically with an emphasis on the compatibility of contemporary architecture with all aspects of cultural landscapes, including cultural

practices, and new development must not harm local ways of life, i.e. retain authenticity and foster socially sustainable historic districts.

In the April 18, 2017 report to Vancouver City Council recommending 105 Keefer be referred to public hearing and approved, the section on public input states, "others noted that there are 'intangibles' which also contribute to the unique Chinatown character, such as the people and activities." We are disturbed that staff and the report fail to note the significance of "intangibles" in arriving at its recommendation despite their prominence in planning documents.

These "intangibles" -connecting to ones' culture, loss of affordable retail, losing critical connections- are noted in the Downtown Eastside Social Impact Assessment. The words "spiritual", "social", "cultural meaning", "non-physical", "intangible values", and "intangible heritage" appear throughout the Downtown Eastside Plan. "A neighbourhood whose heritage value lies... also in its cultural activities and social networks" and "to remain economically competitive, it must do so without losing its culture and heritage assets that define its identity and set it apart from other neighbourhoods" stand out in the Chinatown Neighbourhood Plan.

The City's plan and policies indicate that Chinatown needs to be more than a mere collection of historic buildings (i.e. dead artefacts) but rather a rich cultural area where the tangible and intangible work together to sustain an authentic historic place that is distinct from other neighbourhoods. If this is truly the City's purpose, then Council and staff must move beyond empty policy statements and their lack of implementation. The City must focus on sustaining these qualities that are integral to why Chinatown is significant through better policies, and real commitment to apply them in development applications. The City needs to question how developments such as 105 Keefer contribute to the whole beyond economic measures and engages living human beings in the way they perceive and inhabit the area. We call upon the City to return to an approach to city-building that is humanist. Humanism has deep roots in urban design theory and practice (e.g. Kevin Lynch), and the City's own planning history of people-first urban and social development in the 'City Plans' era.

Our last point concerns community buy-in. One of the strongest points in the Vienna Memorandum is that decisions should be made through participatory planning and the consent of the local community. City staff, and Urban Design Panel, have approved this project and deemed it appropriate for the Chinatown community. This is despite the intense opposition for the past two years (the volume of arguments against the development are well-documented in the report) expressing that many community members feel this project does not meet their needs. Making a decision without support of people sustaining the social, cultural and historical values of Chinatown, simply through living their everyday lives, is not best practice for cultural landscapes, nor best practice in community planning.

Perhaps people understand place differently. People who have their livelihoods and homes in the area do not make sense of place as HA-1 and HA-1A, 7.04 FSR, LEED Gold, CD-1, Public Art Policy for Rezoned Developments, elevations, vertical façade elements, and "the massing concept and architectural language should reflect the dominant north south grain of the built form of Chinatown" in Appendix E. If people

see Chinatown as where they feel comfortable and safe, where they can eat affordably, where they can experience Chinese-Canadian culture, where young and old interact, and where they have access to culturally- and language-specific shops and services, then these perspectives need to be included. This is not simply inclusion through consultation, but through access to planning and inclusion in decision making.

This level of inclusion and participatory planning is not a radical concept. They are an integral part of a values-based approach to heritage. "Enhancing inclusive and sustainable urbanization and capacity for participatory, integrated and sustainable human settlement planning and management" is part of Goal 11 of the 2016 UN Sustainable Development Goals, and inclusivity is a key theme of the 2016 UN Habitat III New Urban Agenda.

Our view is that "heritage" and continuous evolution of historic places through development can and should be mutually reinforcing. By respecting and protecting the way of life of people in a particular place, development can enhance historic districts as built and human environments which are equally essential to sustain, and build upon, the valued sense of place. However, we do not see these merits in this proposal, and at worst, that severe and irretrievable harm to the fragile integrity of Chinatown's cultural landscape will be done.

Unfortunately, as I have been out of country, I had not kept abreast of this development project & the meeting schedule.

My regrets and apologies for not personally contributing at the hearing. My further apologies for the hastily conceived & produced writing to follow in lieu of attendance:

As a descendent of a century's old Chinese Canadian family who have made Vancouver it's residence and eventually allowed to truly make it it's beloved home and as an UBC graduate who's studies focused on Urban change, it is with considerable dismay that I survive to witness the insensitive destruction of a (perhaps, though inconvenient) history of community who personally pioneered within institutionalized racist politics and de facto personally directed hostility & prejudice while almost solely driven by simple survival and hope for my own and future generations to have the opportunity to flourish in & contribute to this community and country. To that, we will forever be indebted. Our "multicultural & diversity" banner is Vancouver's post hoc jewel, though perhaps seemingly reluctantly and conceded by default for some, the new Tourism Vancouver buy line.

Our forefathers were brave, proud, resourceful, humble, self-sacrificing and stoic fighters & survivors. Because of their own sense of dignity and pragmatism (if not fear) they chose to keep a stiff upper lip and fly under the radar. As a result, so did their legacy.

That can be a convenient opportunity to forget, but in respect to them and as well, the diversity of communities that followed or resided in parallel, we cannot forget. We now have the economic & political clout to re-present and acknowledge them without shame or self-consciousness. Chinatown is not not a transitory collection of buildings, it is the last opportunity to communicate, educate, honour and revise perceptions & re-profile people that deserve to be considered distinctly heroic. I understand that re-development is a mandate, market forces unstoppable & gentrification inevitable. But, please be pre-emptively thoughtful and respectfully selective in your erasure of history.

Without some thought to determining the buildings of significant heritage value to respectively and accurately narrating this (though perhaps embarrassing to some) proud and rich history. It is saddening to witness so little value given to our place in Canada's history and to see that there is so little basic knowledge of the Chinese Canadian story in our own city. How many native Vancouverites even know of the simple facts: Of Canadian Citizenship denial, systemic oppression, exclusion from professions, the "Unwanted Soldiers" story, the men who left their communities, family, wives & children behind for painful years by Canadian legislation ...? Ask a few people yourselves. I think you will be surprised by the lack of knowledge. The emblematic head tax issue - arguably reluctantly acknowledged and certainly latently "settled" - at best, raised some consciousness and achieved some closure. But at worse, it facilitates the glossing over of the extent & intensity of the crime(s) and seemingly exonerates Canadian Society at large and our long gone ancestors and simply allows putting it all behind them as a historical footnote now off the table. In the emotions & discourse currently arising out of the social economic impact of today's new immigrants - whether seen as the new distinct Chinese peril or simply just another event ethnically distinct continuum, albeit with a reversal of fortune- we have greater responsibility to further the awareness of history and perhaps possibly eventual further synthesized in our sensibilities as people within a common nation. This is history that the new wave of Chinese should also know & have the opportunity to appreciate and respect as well. We are at another inflection point in race relations and there are few tangible, accessible opportunities of scale left to respectively build upon the Headtax efforts, if Chinatown and it's artifacts are gone.

Current planning processes displayed in the priorities, criteria & requirements of this project are evidence of little awareness, sincere concern & respect in either the city's politicians, bureaucrats or planning technocrats in an understanding of our heritage and history.

Designating Chinatown as a heritage site is looking like an empty gesture made in order to leverage the fast tracking of it's incumbent community's and legacy in it's built form's wholesale demise. At worst, an unmitigated passport for facilitating transformation to a melange of cookie cutter buildings amenable to city design guidelines, further boutiquing, token gestures or vulnerable to a return to Disneyland stereotyping?

Please consider a moratorium on Chinatown re-development until an inventory of heritage sites by their cultural institutional significance that potentially respectfully curates the real & full story. The revitalization process needs a comprehensive agenda of specified heritage template that is not simply driven by built form objectives/ and developers' pro formas considerations with token gestures, but one that is sensitive and reflects a deeper understanding of our history and our ability to tell the story that needs to be told.

Please facilitate the creative community of the many smart & informed members, authors, architects, historians, business leaders, academics etc particularly, but not solely, of the Chinese Canadian community that built Chinatown. With their sincere and altruistic motives you could author this story. through a selective, cost-respectful collection of sites that succinctly & modestly achieves the critical mass required to be impactful yet not inhibiting new development and gentrification wholesale.

Perhaps, add a significant anchoring monument that connects the parts and engages the visitor. In a perfect world, an eloquent invention like Maya Lin's Vietnam Veteran's or Civil Rights memorials. In reality, I'm sure that there are many sculptors & architects, local and otherwise, who could achieve this objective within manageable scale & opportunity costs.

There is a story that needs to be told. A lesson to be learned. A community and generation(s) to be celebrated. Vancouver will be the ultimate beneficiary. Perhaps, it will help change perspectives and bring our city - new & incumbent- closer together. One can hope.

This may be just another development, another irreversible deduction in inventory and lost opportunity or simply another opportunity for adding inventory & economic activity. It is also a critical inflection point in the realization that this city still has a soul. That is where real city building happens.

Dear Mayor and Council,

By Chinese tradition, elders are deeply respected and revered members of society. They are looked to for guidance in life matters and celebrated for their wisdom.

Seniors in Chinatown form a core part of the cultural fabric of the community, yet they represent a vulnerable group requiring protection, as they are at greater risk of poverty and homelessness as compared to seniors living elsewhere in Vancouver (p. 86, City of Vancouver, Downtown Eastside Local Area Profile). Seniors who speak little or no English, face further challenges to accessing appropriate services and especially require culturally sensitive and appropriate housing.

A study conducted at UBC in 2011 concluded that over the next 15 years, up to 3300 seniors in Vancouver will need subsidized affordable housing. The proposed rezoning application at 105 Keefer provides just 25 units of social housing with the 30% requirement of below market rentals. This amounts to merely 8 units of below market rentals, and is grossly insufficient to address the growing housing needs of Chinatown's senior citizens.

Based on their demographic and financial analysis, the authors of the Chinatown Senior Housing Feasibility Study (2015) recommended that the City "prioritize affordable senior housing development as a central revitalization and conservation strategy for Vancouver's Chinatown."

For these reasons I am opposed to the proposed rezoning application at 105 Keefer St. I urge Mayor Robertson and Council to develop the site with the Chinatown community in mind and prioritize culturally sensitive, affordable senior housing.

- The social housing that will give Beedie their additional height and density is funded by taxpayers like me. They are also paying reduced DCL and no CAC. Beedie has not truly provided any community benefits to warrant the rezoning.
- Like the retail businesses in recent developments, the retail units in this project will be unaffordable to seniors.
- The small family businesses that make up Chinatown's character will not be able survive due to increased taxes.
- The Keefer Triangle is a culturally significant site that should not be used for condos.
- It was rejected by a City committee, Chinatown Historic Area Plann Committee.
- The seniors housing units being proposed in this project is not enough to warrant extra density.
- Approval of this project will result in developments like this becoming the norm in Chinatown, ignoring the fact that it is a historic neighbourhood.
- It is a disgrace to treat the Chinese Veterans Memorial as a private front yard.
- The reduction in family units is regrettable.

Instead of market condos, I would like suggest the following alternatives for the site:

The 105 Keefer rezoning application is not suitable for Chinatown. Staff should not recommend City Council to approve it.

I am aghast of the cultural insensitivity of the Beedie Group to design a glass condo tower that is superbly designed to fit into the beautiful Yuppie community of Yaletown, yet it is absolutely appropriate to blend into the unique cultural and architectural heritage of Chinatown. A facade should more harmonious with the architectural heritage of Chinatown. Your job as Mayor and Councillors of Vancouver is to preserve and protect the most unique Chinatown in North American, not to destroy its unique charm and history. Approving the present Beedie application which I approve on the condition I set below, without would be like inserting a Tim Horton's franchise in the middle of Rideau Hall's dining room in order to give the guests of the Governor General a flavor of Canada.

The Beedie Group has the right idea. My husband Dean Chun Kwong Leung and I were the former owners of this site and its buildings for many years. Mayor Volrich and his Council Members approved our proposal for a 29 storey residential and commercial building as housing for Chinatown's citizens was and still is desperately needed. We've demolished the buildings ready to develop in 1980s (see architect's renderings in www.fayeleung.com; which was presented to Your Worship & Council during the Westbank and Bosa Rezone Public Hearing on Main & Keefer Streets, where my husband Dean & I built Chinatown largest commercial complex in 1970 the Mandarin Trade Centre after, we've expanded Chinatown commercial area from Pender to Prior Streets). However, interest rates in 1983 rose to 29% economic unfeasible to develop. We sold to Rickshaw Drive-in owner Yip who stipulated his heirs should not sell, so my Pender Realty & Insurance

Agencies business were to my brother Ken Leong, Oceanridge Realty (across street on Columbia from Beedie now own site) managed this property for Yip as a parking lot until it was sold to Beedie

This site was a rich center of Chinatown culture with historic stories of the people's heritage stories I've known since a young child that is an important part & parcel of Canada Historical Cultural Heritage stories must be preserved perpetually for posterity. Which I'm prepare to work together with Beedie Group to achieve this site development as part of Heritage Chinatown with Chinese character and the historic stories incorporate into this new building compliment part of the surrounding area in the heart of Chinatown.

I approve Beedie's project on the condition that Beedie Group work together to intertwin as part of Chinatown "blend the modern with the old" Chinese Adage: "Chung Sai Hup Bick"/Chinese & Caucasins together blissfully" in Honor the Chinese Pioneers especially 544 Columbia was the original (then was the only Chinese Pioneers Housing Building in Chinatown) building built for the Chinese Pioneers Housing Building. I recommend "Honor and Commemorate Chinese pioneers by naming the building "The Chinese Pioneer Landmark Building".

It housed the famous Cantonese Opera House and the Mandarin Night Club for many years. Dean's grandfather buried in Oceanview Cemetery in 1944...(Note: Canada and B.C. wrongdoings discriminations to the Chinese in "life & death" that in Oceanview Cemetery then were only allow a very small section/Willow Section for only the Chinese & Blacks burial, also prominent Chinese Pioneer Mr. Cumyow is buried!! B.C. Government May 15, 2015 officially in legislature apologize wrongdoings to the Chinese British Columbians.

Chinatown needs to honor its pioneers and this Beedie building is in an ideal position to do so. I, Faye Leung, am willing to work with the Beedie Group in order to make it a proud Chinatown Landmark Building. I suggest in recommendation of this proposal by have Beedie add the historic heritage in make this development its history stories alive!

I am concerned that the City of Vancouver is presently ruining Chinatown by erasing Chinatown's unique heritage without any meaningful input from its (&/or ignore) Chinese citizens. 

You should not approve the building proposed because of these reasons:

- This project will result in significant increases to taxes, which family owned businesses like historic Tosi's cannot afford.
- This is a critical site in a historic area. It should not be used for market condos.

I am writing to you regarding my non-support for the 105 Keefer St rezoning proposal. The historic area has special significance to my upbringing. This historic area is very important to me, as a first-generation Chinese-Canadian. Chinatown holds special cultural significance for me as a person of colour who lives in this city.

I currently serve on the City of Vancouver's Arts and Culture Policy Council. I believe in arts and culture for the power that they have to not only bring people together, but to connect people from all walks of life. Most importantly, heritage plays a huge part in arts and culture and cannot be seen as existing in different silos. 105 Keefer Street not only affects seniors, families, the cultural health of Chinatown, the DTES, and Strathcona, but also has serious implications for the city's arts and culture. What kind of a city and history do we want our art to represent?

My family immigrated to Canada when I was five years old, and Chinatown has always served as a touch point in keeping me rooted in my culture. Immigrating to a new country when you do not speak the language is a scary experience, and I have my family to thank for doing something so brave so that my sister and I could have a better life. My grandfather, who couldn't speak English, would travel by himself to Chinatown multiple times a week until it was no longer safe for him to do so, to buy groceries and chat with other seniors in the area. He used to work on a cargo freight that ran lines between Hong Kong and Vancouver many, many years ago, and in his old age returned to Chinatown time and time again because it was where he was welcomed all those years ago.

Council and staff should not approve the rezoning proposal for these reasons:

- The social housing that will give Beedie their additional height and density is funded by taxpayers like me. They are also paying reduced DCL and no CAC. Beedie has not truly provided any community benefits to warrant the rezoning.
- It will price low-income local out of the neighbourhood.
- This project will result in significant increases to taxes, which family owned businesses like historic Tosi's cannot afford.
- It is inappropriate to use a culturally important site for development that does not respect Chinatown.
- The current proposal was voted non-support by the Chinatown Historic Area Planning Committee.
- Seniors housing offered does not justify the additional height requested.
- Approval of this project despite community opposition will mean the City does not value Chinatown as a historic neighbourhood.

- The memorial statue is a tribute to the historic contributions of Chinese-Canadians. It is inappropriate to be building luxury condos next to it.
- The number of units suitable for families is dismal.

Here are some of my ideas of what could be on the 105 Keefer site instead of condos:

- More seniors housing and social housing
- A neighbourhood community centre
- A public plaza or a community park
- Smaller buildings that make more sense in the fabric of Chinatown

The 105 Keefer rezoning application is not suitable for Chinatown. Staff should not recommend City Council to approve it.

Just a couple weeks ago, Chinatown celebrated its National Historic Site designation. Mayor Gregor Robertson was even in attendance. Chinatown ranks number three on Heritage Vancouver Society's top 10 watch list of endangered sites in Vancouver and the Top 10 Endangered Places List on the National Trust for Canada. If it were another group coming forward expressing so much concern and opposition, would the city still try to approve developments in the area? Does Chinese-Canadian history not matter, or count, towards Vancouver's history?

This is to register my opposition to the proposed development at 105 Keefer St. Though I now live in Gibsons, I spent the first half-century of my life as a Vancouverite, and the last fifteen years of that time in Yaletown. I was a happy resident of that thriving community, so I'm not a doctrinaire, opposed in principle to development. When it's done sensitively and with vision, it's even desirable. But the proposed building at Keefer St. is unwelcome in many ways. First, the building itself, as rendered by drawing, is, architecturally, brutalism-lite. And the trend, after the by-law changes, towards up-up-up, is abhorrent next to the one-story shops and three-story apartments that characterize the historic vibrancy of the area. Second, the sop thrown to the low-income opposition -- the 25% low-income parcel within the building -- tries to disguise the fact that the main selling point, and feature, is on and for the high-end buyer, thus getting the ball rolling for gentrification in one of the poorest areas in Canada. Third, the placement of this monstrosity adjacent to Memorial Park is spiritually incongruous: the park is a defining oasis, and to have an ugly 115-foot high condo shouldering it would destroy the visual character of the area, jeopardizing visitation and, yes, retail activity because of the subsequent curtailment of charm and character.

I am writing to urge you to reject the application for rezoning of 105 Keefer Street. I do not take this position lightly, as I know there are many competing interests at stake.

The interest I value above all others, however, is that of the neIghbourhood and commity there. Far from being a passive fill-in of an empty site, the propsed development has several consequences for this community.

The consequence I am acutely aware of, as the director of a non-profit and proprietor of a business in Chinatown, is the devastation wrought on existing businesses and residents by an accelerated rate of change and wild inflation of property values. The increase in property valuations increases taxes, in turn inreasing rents, and causing key parts of the neighbourhood fabric -- independent businesses with inexpensive food and goods, the local wholesalers and restaurant suppliers, and informal social spaces -- to fail prematurely.

Every injury to the neighbourhood economy has severe consequences for low income seniors in Chinatown and low income citizens living in the larger Downtown Eastside.

Those citizens are already suffering with largely inadequate housing, and not enough health services and social support. If this site were to be used for new, adequate, affordable housing for these residents, it would be possible to support a rezoning. Clearly, however, it is not.

We have an opportunity to slow the rate of change, and change course, toward projects in the community that create a better life dor the citizens who already live here, and whose work built not just a neighbourhood but a community. These opportunities to change course appear to be becoming increasingly scarce. I urge you to seize this one.

This email is concerning the 105 Keefer proposal. I spent my childhood going to Chinatown. I am Chinese Canadian, an immigrant. When my family first moved to Vancouver, I would accompany my father there as he would sell Chinese dried foodstuffs there to the local stores. Before the rise of Richmond as a hub for Chinese Canadians, Chinatown, and more specifically its residents, was an economic lifeline for my father's fledgeling business. It is a historical reminder of Chinese Canadian history in Vancouver, and of the racism we have endured in this country. Do not let rich property developers slowly dismantle our history through gentrification and destroy the way of life for the many customers, now elderly, whom my father has served and is still serving to this day and who have supported our family business faithfully. They need housing that is actually affordable, they need community.

Council and staff should not approve the rezoning proposal because of these reasons:

- It is not right that taxpayers are paying for the social housing so that Beedie can profit from the rezoning's height and density increases. They are also paying reduced DCL and no CACs. This is not fair.
- Like the retail businesses in recent developments, the retail units in this project will be unaffordable to seniors.
- Recent developments like the one proposed at 105 Keefer will result in increased property taxes that small businesses cannot afford.
- Luxury condos are not an appropriate use of this culturally sensitive site.
- It is completely out of proportion. The average building around the area is two to three storeys tall and this one is twelve.
- The building proposed is out of scale with immediate surroundings.
- The proposed building was not supported by the Chinatown Historic Area Planning Committee, comprised of diverse community representatives.
- One floor of seniors housing is not adequate and not worth the million dollar condos moving in.
- Approval of this project despite community opposition will mean the City does not value Chinatown as a historic neighbourhood.
- The memorial statue is meant to honour the sacrifices of the Chinese-Canadians who helped build this city and country. Building luxury condos next to it is inappropriate.
- The reduction in family units is regrettable.

Dear Mayor and Councillors:

As a business and property owner in Victory Square Park and Gastown since 1996, I write to register my opposition to the proposed rezoning of the property at 105 Keefer Street.

My objection is based on the height and bulk of the project, and the use. All are out of context with the needs of the area, which suggest a building in-keeping with the scale and character of the existing historic buildings, and a use that supports people - primarily low-income seniors in this case - to access affordable accommodations and services.

I heard recently that good public policy is based on assessing the needs of any particular community and then addressing them. I do not believe that this policy is being applied in this case. It appears to me that in this and most other locations in Vancouver, accommodating extraordinarily high land values and ensuring high returns to speculative investors is trumping the basic needs of our neighbourhoods and communities.

The implications are what we are witnessing in Chinatown: displaced residents and businesses; unaffordable rents for accommodations and smaller scale shops and services; the privatization of public spaces; an overall devaluing of local character; and, the promotion of a common, neutral aesthetic for buildings and public spaces.

Vancouver as an intriguing collection of interesting, inclusive, affordable neighbourhoods gets lost in the race for economic gain for a relatively few people.

I encourage the return to civic policy making that is based on value, in the broadest sense that the term means. That is, civic undertakings that promote and support: health and wellness; belonging; community; affordability; and, helping those who need it most. Value includes modest returns on investment - which means paying everyone along the supply chain properly for what they do - but does not preclude the others.

I encourage Council to evaluate this rezoning application based on its' merits to support the value that it will bring to the community.

I am not seeing true value, and believe that "we" can do much, much better in this regard.

Dear mayor and councillors

I am writing to ask you to please reject the 105 Keefer tower development application tonight when you meet.

I am sure that you are well aware of all the reasons so many people are opposed to the development of that high rise in Chinatown. For me, having lived in the Chinatown area since 1985, the reasons have to do with the preservation of Chinatown as an actual Chinatown and affordable housing for the people living in the area.

Chinatown has been deteriorating and diminishing exponentially over the years. Of course, many people from that area have been retiring or taking their businesses to Richmond, and buildings are getting old and in need of restoration which costs the owners money. I am always shocked at the speed at which gentrification is taking place there and the change in the atmosphere there.

I think it is very important to remember two things:

1) People still actually live in Chinatown who have been there for years and years. Some of them are partly responsible for who wonderful Chinatown has been as an attraction in Vancouver. It is a vibrant, "real" community where people work and live - not just a showplace of what used to be.

With the gentrification and the building of fancy condos, housing is a very real issue for so many of these people, including seniors. Their homes are disappearing and the rents (if there are any rents) are increasing to the point where they can no longer live there. Although Vancouver's Vision has talked about increasing "social housing" for years, not enough has been done which is clearly been evidenced by the number of people on the streets, as well as all the people struggling to afford what developers and officials who are out of touch with what real people earn the "low market rent" they have to pay.

I beg you to consider these people and allow them to stay living in Chinatown, and for that matter, in Vancouver, by not allowing these condo towers to be put up.

2) Chinatown still can maintain its heritage:

Money needs to be put into existing buildings that need a lot of help and not into these condo towers. The 105 Keefer development is completely different from what exists in Chinatown and will not maintain the heritage of that community. It will block views from people in my area who see very little green or mountain in their lives. It will shadow the street. It will be unaffordable to most people who need housing in the area.

Please consider what I and so many other people are telling you.
