### ***RECOMMENDATION***

THAT the projects advanced by petition, presented at the Court of Revision #637 be approved subject to the actions of the Court of Revision and the subsequent actions of Council.

### ***REPORT SUMMARY***

The purpose of this report is to obtain Council approval to proceed with the proposed petition projects presented at the "Court of Revision" meeting on June 22, 2017 as part of the Local Improvement process.

### ***COUNCIL AUTHORITY/PREVIOUS DECISIONS***

Policies governing the Local Improvement process are set out in the Vancouver Charter and the Local Improvement Procedure Bylaw #3614.

### ***CITY MANAGER'S/GENERAL MANAGER'S COMMENTS***

The General Manager of Engineering Services recommends the approval of these projects subject to the actions of the Court of Revision and the subsequent actions of Council.

**REPORT*****Background/Context***

On May 16, 2017 the First and Second Step Report (RTS #12030) was advanced by Council to the Court of Revision under the provisions of the Local Improvement Procedure Bylaw #3614.

The report identified following petition projects and associated funding strategy:

<u>Court</u>	<u>Item</u>	<u>Type</u>
637	1-4	Lane paving
637	5	Lane lighting

Refer to Appendix I for specific project locations.

The lane paving projects are funded by the property owners and the City. The lane lighting project is entirely funded by the property owners.

The total estimated cost of these projects is \$428,961. The property owners' share of the projects is \$294,916. The City's share is \$134,045.

The City share is to be funded from the 2015-2018 Capital Plan (Local Roads Rehabilitation Program CER-00185) and will be managed within the approved capital expenditure budget.

***Strategic Analysis***

The petitions supporting these projects have been certified by the Collector of Taxes as sufficiently signed under the requirements of the Vancouver Charter and the Local Improvement Procedure Bylaw #3614.

***Implications/Related Issues/Risk (if applicable)******Financial***

As per Section 515 of the Vancouver Charter, if the property owners' share of the actual costs exceeds the estimated amount by more than ten percent, the excess amount shall be borne by the City.

PETITION PROJECTS - COURT #637

I. LANE PAVING

1. Lane east of Granville Street from the lane south of Nanton Avenue to Devonshire Crescent and the lane south of Nanton Avenue from the lane east of Granville Street to Cartier Street.
2. Lane south of Napier Street from Cassiar Street to Skeena Street.
3. Lane south of 12<sup>th</sup> Avenue from Camosun Street to Crown Street.
4. Lane south of 17<sup>th</sup> Avenue from Quebec Street to the lane west of Main Street.

II. LANE LIGHTING

5. Lane east of Todd Street from Vanness Avenue to Euclid Avenue
