Dear Mayor and Council,

I'm writing to express qualified support for the proposed rezoning at 870 E Main

I believe a 7 storey building such as this should not require a rezoning process at all, or be subject to a veto by competing land owners. The only considerations should be fire safety, reasonable earthquake safety, and protection or compensation for tenants of the existing building.

While they do not change my support, I do have some comments on how this project, and future projects, could be better:

Original Proposal should have been approved

The original proposal with a slightly higher FSR and lower floor count, was a better project. It's a shame that the community ends up with a taller building with less space.

Locating in RS1 Area would have prevented Displacement

While I understand the location is tied to the land ownership, if a 7 storey affordable rental building was legal in Shaughnessy or Point Grey, this could have been built without displacing any existing tenants.

**Tenants Deserve Compensation or Protection** 

Existing tenants deserve protection in a tight market. The best protection we can give them in the long term is to a "tenants market", one where their landlord has lots of competition and knows they could get a better deal elsewhere. That may take decades, so in the meantime, we owe tenants consideration for the problem we've created through a century of exclusionary zoning.

Larger building would be a better return on investment of community time/patience

Any building project will involve inconveniences for neighbors and waste as the old building is demolished. When we undertake such inconveniences, we should want the maximum return on our investment in terms of additions to the housing stock. The "cost" to our community, in noise/waste/inconvenience of building to FSR 4 or FSR 6 would have been almost identical. Yet instead we get FSR 2.8, perhaps twice what's there already, when the region is in a dire shortage. This is a missed opportunity.

Too much parking has been included

It's admirable that city staff have reduced the minimum requirements, but every additional space increases the costs of building and the increases the time before the space can be occupied by new tenants. If there is a concern about residents using street parking, then that is a sign that we are underpricing street parking and we should fix that. If we can require the builder to include less floor space than they wanted, then we can require the building to include less parking too.

Setbacks are too large

Vancouver streets are already too wide. Requiring large setbacks on new buildings increases housing costs, and forces us to either accept taller buildings, or accept less floor space and thus, higher costs for residential space in our region. We can ensure there is plenty of space in the public realm without requiring that buildings

include large setbacks. Most of the space in the right of way is devoted to the least space efficient usage. Small tweaks to that allocation would generate plenty of public space.

# No Mixed Use is a Missed Opportunity

I believe 1st floor retail should be legal on 100% of lots in the city, in every neighborhood, on every street. Neighborhood stores add to our community and requiring them to be on the edge, on noisy, dangerous, polluted arterial roads does our community a disservice, empowering commercial landlords, increasing travel distances and reducing opportunities for serendipitous community. It's a shame that this building can't be an opportunity to introduce small retail into this area, away from Main and away from Broadway.

In conclusion, I support the project as is and recommend it be approved.
