SUBJECT: Vancouver Civic Theatres Rental Rates 2018-2019

RECOMMENDATION

THAT Council approve the recommended rental rates, as outlined in the Schedule of Rental Rates for Vancouver Civic Theatres (VCT) (Appendix "A"), effective September 1, 2018.

REPORT SUMMARY

This report seeks approval of the proposed fee increases for VCT as outlined in the Schedule of Rental Rates contained in Appendix "A" for the uses of the VCT during the period of September 1, 2018 to August 31, 2019.

COUNCIL AUTHORITY/PREVIOUS DECISIONS

Council approves the Schedule of Rental Rates for VCT on an annual basis as recommended by staff.

GENERAL MANAGER'S COMMENTS

The General Manager of Community Services recommends approval of the new fee schedule.

REPORT

Background/Context

Rental rates are reviewed each year prior to the preparation of the annual proposed operating budget. Adjustments are made effective September 1st of each year in alignment with the performing arts season, September 1, 2018 - August 31, 2019. The rental rates are reviewed primarily in relation to operational cost increases, and are reviewed in relation to those of comparable facilities to ensure that Vancouver's rates are appropriately placed according to local, national and international markets factoring in CPI.

Staff are proposing an increase of 2.0% for all Vancouver Civic Theatres (VCT) rates across all venues (Queen Elizabeth Theatre, Orpheum, Vancouver Playhouse, Annex, QET Plaza). Ancillary space fixed dollar increases range from \$8 to \$191 per event with greater than 2.0% increases for Commercial standalone bookings to allow appropriate recovery to support and continue the ability to include the use of these spaces with large venue performance rentals for organizational development (opening night reception as an example), while still maintaining competitive rates with similar spaces in Vancouver. The VCT Board has recommended approval of the proposed rental increase at the May 24, 2017 board meeting.

In preparation for a potential increase, all booking enquiries received for the 2018-2019 season have been informed of a potential rental increase pending Council approval. A letter has been sent on August 28, 2017, to all Not-for-Profit organizations (including Theatre Rental Grant recipients) and commercial licensees, informing them of the potential rental increase.

If Council approves the rental rate increases, a follow-up letter will be sent to all of these organizations to confirm the increase.

A summary schedule of some of the key rental rates per event for the prior year and the proposed 2018-2019 rates (all labour included unless clients have specific additional needs or requests) are shown below for comparison:

Strategic Analysis

Rental rates are reviewed annually in relation to the specific economic factors, such as labour increases, the City's budget objectives, and in relation to the local, regional and national venues' rental market.

The proposed venue rental rates reflect a CPI increase of 2.0%. The rates allow for the continuing subsidization of the Annex and the Vancouver Playhouse, where the rents are lower than their operating cost.

Facility fees

Ticketing companies charge facility fees directly to patrons and remit this fee to the VCT. The fee, net of external administrative costs, is transferred to the VCT capital reserve fund for maintenance and capital replacement in the theatres. Staff are recommending for 2018/2019 that the higher priced ticket facility fee remain unchanged for the QET, Orpheum, Vancouver Playhouse and Annex, QET Plaza and Ancillary spaces but recommend a facility fee of:

- \$2.00 per ticket sold for ticket values between \$0.01 and \$20.00 (not applicable for Reg Non Profit)
- \$1.00 per person for free and non-ticketed events (not applicable for Reg Non Profit)

Financial

The rental rate increase impacts revenues for the last four months of the 2018 fiscal year and the first 8 months of the 2019 fiscal year. The grant period spans from September 2018 to August 2019, corresponding to performing arts companies' performance season.

The proposed rental rate adjustment reflects the work done on the proposed 2018 budget to achieve a balanced budget, based on current bookings from September 1 to December 31, 2018. The newly approved rates will be used when building the proposed 2019 operating budget.

The risk associated with not implementing these proposed new fees would be a negative impact to the VCT revenue of approximately \$255,000 for the 2018- 2019 season. This impact would be from the increases in labour and other operating costs not being matched by increases in rental rate revenue, combined with the reduced ability of the VCT to continue to subsidize the rates for the Playhouse and the Annex.

CONCLUSION

This report proposes an increase in VCT rental rates over the 2017-2018 Rental rates, with specific increases to the ancillary space to be more aligned with industry standards. These proposed rates will be effective September 1, 2018 to August 31, 2019, which will apply to all of the VCT spaces as detailed in Appendix A.
