

A By-law to amend Vehicles for Hire By-law No. 6066 regarding prorated fees

THE COUNCIL OF THE CITY OF VANCOUVER, in public meeting, enacts as follows:

- 1. This By-law amends the indicated provisions and schedules of the Vehicles for Hire By-law No. 6066.
- 2. Council amends Schedule A to the Vehicles for Hire By-law, under the heading "Pro-rated licence fees" by striking out:

"If a person commences owning or operating a vehicle for hire after January 1 in any calendar year, the license fee is to be pro-rated by dividing the applicable annual license fee by 12 and multiplying the resulting number by the number of whole or partial months remaining in that calendar year."

, and replacing it with:

"If a person commences owning or operating a vehicle for hire after January 1 in any calendar year, the license fee is to be pro-rated by dividing the applicable annual license fee by 12 and multiplying the resulting number by the number of whole or partial months remaining in that calendar year except that:

- (a) annual licence fees that are less than \$80 will not be pro-rated; and
- (b) the minimum licence fee for any vehicle for hire shall be the lesser of \$80 or the full amount of the annual licence for that vehicle for hire."
- 3. A decision by a court that any part of this By-law is illegal, void, or unenforceable severs that part from this By-law, and is not to affect the balance of this By-law.
- 4. This By-law is to come into force and take effect on January 1, 2018, immediately after By-law 11929 takes effect.
