



COURT OF REVISION MINUTES

FEBRUARY 20, 2018

A Court of Revision of the City of Vancouver was held on Tuesday, February 20, 2018, at 4:17 pm, in the Council Chamber, Third Floor, City Hall, for the purpose of hearing from assessed property owners regarding errors in the names of assessed owners in Business Improvement Areas, or the measurements of the property, including the frontage or any other property measurements.

1. DELEGATIONS CONCERNING ERRORS

The Court of Revision had before it special assessment notification letters that were sent on or before Friday, December 22, 2017, to the assessed property owners in the following Business Improvement Areas:

- a) Cambie Village Business Improvement Area
- b) Proposed Cambie Village Expansion Business Improvement Area
- c) Collingwood Business Improvement Area
- d) Proposed Creekside Business Improvement Area
- e) Dunbar Village Business Improvement Area
- f) Hastings North Business Improvement Area
- g) Hastings North Expansion Business Improvement Area
- h) Robson Street Business Improvement Area

Staff from the Business Improvement Area Program advised that no correspondence had been received regarding errors or omissions in the names of assessed property owners, or the length of the frontage or other measurements of the parcels, but advised Council of an error regarding the attachment for a) Cambie Village Business Improvement Area Renewal, noting it should have been a copy of the Special Assessment Letter sent to property owners rather than a copy of the generic property-owner notification letter for the proposed Cambie Village Expansion Area. This does not affect the notification process, as the correct letters were originally sent to the property owners in question.

The Mayor called for speakers relating only to the above-noted errors or omissions, and none were present.
