Dear mayor and council,

I am writing to you in support of this rezoning application. I live nearby, in Fairview, and often visit the Main Street neighbourhood to visit friends in the area and shop/dine in the local stores and restaurants.

I support the proposed development on the grounds that it will add 13 new homes to the area without removing any existing housing. It seems to offer the exact sort of "gentle density" that the city planners and residents seem to desire, and the homes appear to be of a decent enough size to provide family housing. It also preserves the historical building and a part of the city's heritage.

That being said, the provision of 20 parking spaces for 13 homes seems excessive. The fact that (according to the plans) a car elevator is required to make this work is even more so. This location is in a very walkable neighbourhood which is well equipped with transit (And will be even more so after the addition of the Broadway Skytrain) and right next to a bike route into downtown. Vancouver currently has one of the lowest driving mode shares in North America and this is only heading downwards, so these spaces are likely to end up mostly underused over the life of the building. Removing or reducing the amount of complex engineering needed to build underground parking can only result in cheaper homes and is something I think the city should consider.

I would also like to see the city pursue a wider rezoning policy rather than reviewing each development individually. Allowing townhouse/low rise apartment developments in a wider range of neighbourhoods (or the whole westside) would remove some of the pressure on the existing small slices of the city that permit this kind of building.

While I support it this project, I want to note the missed opportunity on this site. It could have provided much more, rental, accommodation on a bike path. Instead, once again, the City is "protecting" single-family neighbourhoods from density and renters, and pushing renters to the busy streets. I fall asleep to the sound of trucks and traffic every night, like tens of thousands other renters in the city. We deserve quiet places, and this would have been a good, quiet place for some of us.

Further, the wildly expensive inclusion of a parking garage and 20 spaces could add \$100,000 in construction costs for each of the 13 units. Forcing new housing to bear the cost of parking provision is a poor choice, and conflicts with both affordability, and Greenest City goals. That is money that could have gone into CACs for social housing, or into affordability targets for rentals. Instead, it goes to parking.

Finally, the project is not nearly dense enough. We built larger, denser buildings in Mt Pleasant 100 years ago. They are quite beautiful. Surely we have the means to do so today. Four floors and corner stores, my friends. Four floor and corner stores.
