SUBJECT: 2018 Social Grants - Childcare Enhancement and Other Grants

RECOMMENDATION

- A. THAT Council authorize 44 Childcare Enhancement Grants to 27 non-profit childcare providers totalling \$971,151, as described in Appendix A. Source of funding is the 2018 Social Policy Grants Operating budget.
- B. THAT Council authorize one Neighbourhood Access Grant of \$45,000 to the YMCA Woodwards Children's Centre as described in Appendix A, for the period January 1, 2018 to December 31, 2018. Source of funding is the 2018 Social Policy Grants Operating budget.
- C. THAT Council authorize three Direct Social Service Grants totalling \$103,472 as described in Appendix B. Source of funding is the 2018 Social Policy Grants Operating budget.
- D. THAT Council authorize one Organizational Capacity Building Grant of \$5,604 to Vancouver Community Network as described in Appendix B. Source of funding is the 2018 Social Policy Grants Operating budget.
- E. THAT Council authorize three Social Responsibility Fund Grants totalling \$92,500 as described in Appendix C. Source of funding is the Edgewater Casino Social Responsibility Reserve.
- F. THAT Council authorize a grant of \$309,228 to the Collingwood Neighbourhood House Society for the period January 1, 2018 to December 31, 2018. Source of funding is \$269,228 from the 2018 General Government Operating budget and \$40,000 from the Social Policy Grants Operating budget.

- G. THAT, pursuant to Section 206(1)(j) of the Vancouver Charter, Council deems any organization listed in Appendices A to B which is not otherwise a registered charity with Canada Revenue Agency, to be contributing to the culture of the City.
- H. THAT Council authorize the General Manager, Arts, Culture and Community Services to negotiate and execute agreements to disperse the grants described in Recommendations A to F on the terms and conditions set out herein or such other terms and conditions as are satisfactory to the General Manager, Arts, Culture and Community Services and Director of Legal Services.
- I. THAT no legal rights or obligations will arise or be created by Council's adoption of Recommendations A through F unless and until all legal documentation has been executed and delivered by the respective parties.

Recommendations A to F require 2/3 affirmative votes of all Council members per Vancouver Charter S. 206(1).

REPORT SUMMARY

This report recommends 53 grants totaling \$1,526,955 (see Table 1) that correspond to five of the Healthy City Strategy goals: A Good Start; Feeding Ourselves Well; Healthy Human Services; Being and Feeling Safe and Included; and, Active Living and Getting Outside.

COUNCIL AUTHORITY/PREVIOUS DECISIONS

Community Services (CS) Grants: On March 7, 1978, City Council established the Community Services Grants program. On October 9, 2003, City Council approved revisions to the Community Services Grants program, including the creation of three funding streams: Neighbourhood Organizations, Direct Social Service, and Organizational Capacity Building.

Childcare Enhancement Grants: Council established the annual Civic Childcare Grants Program on October 23, 1990 to assist licensed non-profit childcare programs serving a high proportion of vulnerable children.

Collingwood Neighbourhood House Gymnasium: On December 15, 1994 Council provided Collingwood Neighbourhood House Society funding for gymnasium/recreational programs and approved an operating agreement. On February 19, 2002, Council approved a five-year lease (the "Lease") with the Society, which commenced on May 1, 2002. The City and the Society entered into a Gymnasium License and Operating Agreement with the Board of School Trustees of District No. 39 on January 1, 2002, governing the shared use of the Gymnasium by the Society and the School Board. On November 7, 2002, Council approved an operating agreement with the Society to formalize funding and operating commitments for the Gymnasium through a modification to the Lease dated November 26, 2003 (the "Lease Modification").

Edgewater Social Responsibility Fund (SRF) Grants: On July 20, 2004, as part of the rezoning conditions for the Plaza of Nations, Council accepted a public benefit offering from Edgewater Casino, including a donation of \$200,000 annually, towards the Social Responsibility Fund. Council approved funding guidelines for the SRF in October 2006.

YMCA Woodwards Neighbourhood Access Grant: On July 10, 2013 Council approved a new annual grant of up to \$45,000 to reduce fees for low income parents at the Woodwards Childcare Centre.

Healthy City Strategy: On October 29, 2014, Council approved goals, targets and indicators of the Healthy City Strategy 2014-2025 Phase I. On July 8, 2015 Council approved the first four-year action plan for the Healthy City Strategy.

REPORT

Background/Context

This report recommends social grants totalling \$1,526,955 in five grant areas:

- 1. Childcare Enhancement Grants:
 - Childcare Enhancement Grants support licensed group child care, preschool, schoolaged care and occasional child care programs serving high need families. The grants can be applied to reduction of parent fees, providing food programs (e.g., hot lunch and breakfast) and/or to enhancing staff ratios to better serve high-need children.
- Neighbourhood Access Grant:
 - Negotiated as part of the operator selection process for the Woodwards Childcare
 Centre, this City grant covers up to half the cost of licensed spaces for families in the
 DTES who qualify for the full Provincial childcare subsidy.

- 3. Direct Social Services Grants:
 - These grants support non-profit organizations that are working to address specific social conditions and issues and bring about positive social change.
- 4. Edgewater Social Responsibility Fund (SRF) Grant:
 - SRF grants are intended to provide one-time funding for projects that build community capacity and address public safety issues in the Downtown, Downtown Eastside, Strathcona and Mount Pleasant neighbourhoods, and/or to address citywide priority issues that may have direct or indirect impacts in the targeted communities.
- 5. Collingwood Neighbourhood House (CNH) Gymnasium annual operating grant:
 - CNH operates a City-owned gymnasium and provides affordable, accessible recreation programs to residents in this highly diverse community.

Social grants are investments that contribute to a healthy city for all. They support non-profit community-based services that facilitate the physical, spiritual, mental and emotional well-being of people, and:

- Are co-developed and governed collaboratively with and by the communities and individuals they serve.
- Respond to dynamic community needs;
- Reduce the impact of systemic factors that create conditions of vulnerability;
- Facilitate partnerships and networks between the city, other levels of government, business; and
- Inform and respond to Council priorities.

Strategic Analysis

Advancing the Goals of the Healthy City Strategy and Related Council Priorities

The Social Policy grants in this report are informed by the Healthy City Strategy and related Council strategies and priorities, as illustrated in Table 3.

The grants recommended in this report will particularly help support the HCS goals a Good Start and Healthy Human Services.

A. Childcare Enhancement Grants (Recommendation A) - \$971,151

Childcare is the second highest expense for many families after housing. While this major expense affects families across income levels, lower income families are particularly challenged to find quality, affordable care. While trying to keep fees as low as possible to allow for affordability, the non-profit childcare providers face rising costs for wages, food, rent and other expenses.

The change in provincial government in 2017 heralded a shift in the provincial childcare environment, and it is clear the province views the City as an important partner as they move ahead with implementation of universal childcare.

A Shifting Landscape - Major Provincial Changes in Child Care

The 2018 Provincial Budget introduced significant childcare investments for both families and childcare providers that aim to take the first steps toward universal, affordable childcare. The first investment was the Child Care Fee Reduction Initiative (CCFRI) that amounts to a direct reduction in monthly fees for parents enrolled in programs that voluntarily "opt-in" to the CCFRI. Fee reductions are based on the type of program and are paid to childcare providers, who then directly pass on the fee savings to parents. It is important to note that this investment will not create a net budget increase for childcare operators, since the CCFRI simply offsets the cost of parent fees. While most centres appear to have opted in, there remain questions about the possible longer term impact of the initiative, including the restrictions on a centre's ability to raise parent fees.

The following table illustrates the maximum fee reduction and the impact on parent fees in Vancouver-based centres.

Implementation of the CCFRI is currently taking place. Additional Provincial changes will include increases to the maximum childcare subsidy rate for low-income families and the rollout of a workforce investment strategy.

City staff will monitor the direct impact on Vancouver's childcare programs, and whether these three provincial strategies will lead to an increase in the number of children and families with key vulnerability factors able to access licensed care.

The Childcare Enhancement grant program is intended to enhance childcare accessibility and quality. Enhancement grants are intended to support children, ages 0-12, in licensed non-profit childcares in Vancouver by:

- Enhancing quality through increased staff-child ratios in programs with higher needs children;
- Aiding affordability through reduced parent fees;
- Achieving integrated child development services (hub model) by supporting neighbourhood coordination; and.
- Increasing food security with food supplement programs

A sample of 37 City-funded childcares surveyed showed that they spend a cumulative total of almost \$400,000 on food each year (averaging ~\$11,000 per childcare), and each childcare spends an average of 20 hours per week on food purchasing and preparation. Despite the importance of healthy food provision within their programs, most childcares rely on grants or donated food, as this is not provincially funded.

Eligibility Criteria for Childcare Enhancement Grants

The maximum grant per program is \$27,000 and organizations operating multiple childcare centres are limited to a maximum of three enhancement grants. Grant amounts are based on the number of licensed spaces in each program and a staff ratio formula (see Appendix A). To be eligible, applicants must demonstrate sound administration and charge monthly parent fees that are at or below the city-wide averages.

Organizations must also demonstrate that a significant portion of the children and families are at risk due to various systemic or potential risk factors (e.g., low income, refugee and new immigrant families, single parents, etc.).

Of the applications received, five were deemed not eligible for funding (Appendix A) as they did not meet the program criteria.

Phil Bouvier Childcare Centre – Vancouver Native Health - \$42,000

Vancouver Native Health operates a 49 space licenced childcare program at 717 Princess Street which serves a number of Indigenous families and children. The current licence is for 24 infant and toddler spaces and 25 - 3 to 5 year old spaces. The program recently announced its closure due to funding challenges. Affordability is a challenge for many families as is covering costs for operators. As such, the Provincial Government, City and Central City Foundation are working together with Vancouver Native Health to stabilize operations. The Province is implementing new initiatives to help address affordability burdens experienced by families, and to help offset costs for operators. The enhancement grant will exceed the maximum infant/toddler grant by \$15,000 to support the implementation of a transition plan so that the existing licensed child care spaces will remain operating, and provide a bridge until the new provincial initiatives are implemented. Central City Foundation will cost share the transition plan implementation costs with the City.

B. Neighbourhood Access Grant (NAG) to YMCA's Woodwards Childcare - \$45,000

On October 30, 2012, Council selected the YMCA as the operator of Woodwards Childcare and committed to working with the YMCA to ensure that 50% of the 37 childcare spaces would be offered at no cost to low income DTES families. Council approved an annual City contribution of up to \$45,000 to cover up to half the cost of the 19 dedicated spaces for families in the DTES who qualify for the full Provincial childcare subsidy. The City's funding leverages more than double that amount from the YMCA to help meet this accessibility target.

The YMCA has been operating Woodwards since July 2013 and serves a high number of children and families experiencing conditions of vulnerability. At present, the centre offers:

- Additional staff support and enhanced teacher ratios to work with the very high number of children enrolled with extra support needs.
- Coordination and participation in meetings with families, consultants and support agencies that work with children with developmental concerns.
- A hot lunch program for all families at no charge, as well as extra supplies such as clothing, and referrals to other YMCA programs and supports that aid children, parents and families.

Staff recommend continuing to provide a grant of up to \$45,000 to cover half the cost of the 19 dedicated spaces at the Woodwards Childcare. Staff will also continue to seek opportunities through potential partnerships with senior government and other funding agencies to expand the Woodwards model to other childcare centres in Vancouver.

C. Community Services Grants - \$109,076

The Community Services Grants (CSG) is the largest of the Social Policy grant streams. CSG funding helps to address both the impacts and the causes of marginalization by supporting programs and services that reduce conditions that create or exacerbate vulnerability. Many of the organizations, programs and services funded through CSG have received grants for years reflecting both the City's commitment to the sector and the 'core' nature of the type of funding provided via the CS grants.

E. Collingwood Neighbourhood House Gymnasium/Recreational Programming (Recommendation E) - \$309,228

The City has provided Collingwood Neighbourhood House (CNH) funding for a gymnasium and recreational programs since 1994, with modifications made to the Lease in 2003 to formalize funding and operating commitments. This is a unique arrangement, which allows for reduced operating costs and for more community input into the operation.

Based on these commitments, CNH operates a City-owned gymnasium and provides affordable, accessible recreation programs to residents in this highly diverse community.

Significant growth in gym participation since 2010

Since 2010, CNH has reported a 102% increase in gym utilization, from 20,100 visits per year by community members in 2010 to 40,595 visits in 2017. In the same time period, the operating grant to run the gym has only increased by 12%, from \$235,059 in 2010 to \$263,949 in 2017.

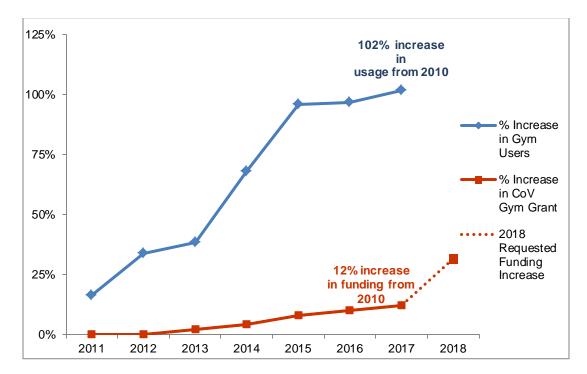


Chart 1: Gym Usage and Funding Increase by Year

Recommended one time grant increase of \$40,000

Both the 2004 Renfrew Collingwood Community Vision and the 2016 Joyce Precinct Plan recommend additional supports to CNH to meet growing community needs. This report recommends a base grant of \$269,228, which represents a 2% increase over the 2017 grant, and an additional \$40,000 to help address growing pressure on the gym's operations, for a total 2018 grant of \$309,228.

As indicated in Recommendation F, the \$40,000 increase for 2018 would be supported by a **one-time** allocation from the 2018 Social Policy Grants budget. Social Policy staff are currently exploring options for future management of this contract, including collaborating with the Park Board to determine which department is best positioned to oversee the annual operating grant for the Gymnasium in the future.

The formula used to calculate grant amounts is called the Full Time Equivalent Space (FTES) measure. The measure uses full-day, 3-5 care as the baseline for comparison, assigning each 3-5 space a FTE factor of 1. A full-day infant/toddler space is approximately twice as expensive to deliver as 3-5 year old space and, therefore, each infant/toddler space is assigned a factor of 2.

To illustrate:

- the FTES measure for a typical infant/toddler program with a licensed capacity of 12 children would be calculated as 12 x 2 = 24 FTES.
- the FTES measure for a preschool program with a licensed capacity of 20 children would be calculated as 20 x .33 = 6.7 FTES.

^{*}In order to account consistently for the various preschool programs, the baseline (FTES factor of 0.33) reflects a licensed capacity of 20, with morning or afternoon sessions five days per week, 2 ½ hours per day. This baseline results in 6.7 FTES (20 licensed capacity X 0.33).

While the FTES measure is calculated on licensed space capacity, in cases where a childcare program has consistently (at least two years) run at 75% or less of licensed capacity, the licensed space total used for the FTES measure will be set at 75%.
