I am in support of both aspects of this initiative. Given the ongoing housing shortage in Vancouver, the proposal for a new mixed-use commercial/residential building I feel should be welcomed with open arms.

Further, the concept of retaining the Hollywood Theatre as a Heritage performance centre is also to be commended. I have been a Vancouver resident since January 1990, and for all that time until my retirement at the end of December 2016 have been employed in the concert business. First as a talent buyer for Timbre Concerts, next as a talent buyer for the Starfish Room (located at 1055 Homer until that building was demolished to make way for housing), and finally for Monqui Presents, a Portland, Oregon concert production company. I remained resident in Vancouver even while working for Monqui. I'm writing in support of Marianne Amodio Harley Grusko Architecture Inc.'s proposal for the renovation and addition to the Hollywood Theater. I have seen many films at this theater and was saddened by its closure (along with most other independent theaters in Vancouver).

I believe efforts to save these spaces and find new uses for them is important to retain parts of Vancouver's soul that will otherwise be lost to slick new developments devoid of culture. For example, consider the plight of the Ridge Theater which has been summarily replaced with a bleak condominium. Another example is the Van East Theater now also renovated (at least) into multi-family residential.

If efforts aren't made to save parts of Vancouver's cultural and architectural past as the city is in the midst of massive changes, we risk becoming a resort city full of banal luxury shops and big box stores. I hope instead that we can retain our unique, regional character and resist being overwhelmed by bleak corporate sameness.
