I am writing with regards to the public hearing about the Hollywood Theatre development, taking place on July 17th.

First of all, I want to stress how important I feel renewing the Hollywood Theatre is to our community. I live in Kits and had enjoyed the theatre very much before it closed and so reviving it as described in the plans would be a wonderful asset, not only for Kits, but all of Vancouver. I cannot stress this enough and so I am absolutely in favour of making an agreement with the developer to make this happen.

Having said that, I wish the proposed new building could be more sympathetic to the local environment than this design, which I feel is very heavy and overpowering to the streetscape. Broadway in that area is more of a village feel and this just doesn't fit that notion. The design of the Shoppers Drug Mart building and the new building just east of Balaclava are more suitable examples. I am all for bold and exciting architecture, but less so in a residential neighbourhood where human scale is a priority.

Further, the heavy horizontal lines are very much at odds with the dominant vertices of the theatre. It feels entirely incongruous the design feel of the theatre and really overwhelms it.

I'd like to consider whether or not the building fits the stated remit.

Restore & Revive the Hollywood Theatre. YES

Maintain The Theatre Use as a Neighbourhood Cultural Amenity. YES

Respect and Enhance the Broadway Streetscape. NO. It boldly asserts a very different look and in particular, does not respect the current streetscape. If the stated plan was to challenge and bring a new feeling to the neighbourhood, this design would likely fit, but this is not the stated plan, which is clearly to respect and enhance the current streetscape

Minimize Impact on the Residential Neighbourhood to the North. Achieve the Owner's FSR Requirement. Not sure. It seems pretty big, so does it minimize the impact to the north?

Create New Architecture within a 6 Storey Massing that Complements & Responds to Existing Theatre. NO. This is perhaps the most dramatic statement which the building ignores. In no way does this design complement or respond to the existing theatre in any way. It is the polar opposite of the heritage feel and style of the theatre.

As I say, I really want to encourage a resolution to allow the restoration of the theatre, but I hope there can be a more suitable rethink of the design to make it more suitable. So I would ask the developer to provide a different type of building. Something which fits in better to the streetscape and complements rather than fights the Hollywood theatre itself and actually respects the stated remit, as posted on the city's website.

My name is Ann Marie Fleming. I am an independent filmmaker, writer, artist, cinephile and historical building buff and I am very happy to support the heritage designation application of the Hollywood Theatre and look forward to its new life as a multi-use arts facility that includes continued use as a cinema house.

I live near the Rio Theatre, which has become an integral creative hub in East Vancouver, while respecting its roots as a cinema. I am fully behind their efforts to buy that building and thereby control their future.

In light of all the new housing developments Vancouver we need to maintain places that make neighbourhoods vital, that speak of a continuity. People like it! (Think Brooklyn, not Brazilia). It is a privilege to be able to have these historical buildings stay relevant as cultural houses, not just as facades to malls or condos. (I am thinking the Ridge here!) and to support cinema.

I fully support the higher density development, which would facilitate saving and refurbishing the Hollywood. Although I am not a Kitsilano resident (I have frequented the Hollywood many many times over the year) I lived many years in the Kensington, a heritage building in the West End, which is- although a different vintage-6 stories tall... like suggested in this development plan on 3123 West Broadway. The Kensington was the first building of its size in a single family residential housing area ... and this was 1911 (predating the Sylvia by a year, I think). A building that is still appreciated over 100 years later for its (modest) design. And an Art Deco cinema just a short walk away!

Unfortunately, the variance for the development at 935 Denman meant that while the Starlight theatre got to keep its building, lost its cultural status. The West End (and every wave of development, really) has taught us what we value most, often in hindsight.

Living in East Vancouver now, I am lucky to have the Rio just down the street:-). We need to save these precious vestiges of our past, and see their relevance in our future.

Anyway, I am encouraged, after many years of discussion, that this option for saving the Hollywood exists. And I think a 6 story development along a transportation corridor is appropriate, would be a boon to local merchants, and increase street life in a positive way.
