RECOMMENDATION

- A. THAT Council authorize payment for Councillor Jim Green to extend a trip to London, England, to meet with London officials on a number of mutually important issues.
- B. THAT Council authorize a Leave of Absence for Civic Business for Councillor Green on Tuesday, November 18, 2003.

CITY MANAGER'S COMMENTS

The City Manager submits the recommendation for Council's CONSIDERATION.

COUNCIL POLICY

Current City Business Travel Policy, approved July 31, 1992, requires Council's approval for travel outside North America.

PURPOSE

This report requests approval for Councillor Jim Green to incur accommodation and other miscellaneous travel expenditures while in London.

DISCUSSION

Councillor Green will be traveling to London, England to attend a conference entitled Urban Regeneration and Quality of Life – Lessons from Canada and will be speaking at London School of Economics on the Vancouver Agreement. The airfare and ground transportation will be paid by the conference organizers.

This is an excellent opportunity to meet with officials in London to discuss issues such as transportation, cultural and economic policies as well as social issues. Councillor Green's proposed agenda includes several meetings with local representatives as follows:

Because the trip is already paid for, the costs will be limited to local expenses such as accommodation and per diem. The benefits associated with this rare opportunity far outweigh the relatively low cost.
