OPENING CELEBRATION - BLACK HISTORY MONTH 2005

The Black Historical and Cultural Society of British Columbia is planning to once again produce the inaugural event of the traditional celebration of Black History Month, Tuesday, February 1st, 2005 in Vancouver. The organization plans to expand the concept of our previous productions held in 2000 to 2004. Whereas we have previously highlighted the history of Black Canadians in British Columbia and Canada, we now want to present a production which encompasses a much wider appreciation of the diversity of the African, Caribbean and South American diasporic cultures.

We have centred our focus on dance as the cohesive artistic medium linking the various cultural organizations. Vancouver is fortunate to have a newly emerging number of dancers and groups who have brought to this region the historical traditions of their cultural past. Capoiera Ache Brasil and Masabo Culture Company represent two groups who have spread the cultures of African dance and celebrations in Brazil and West Africa. Dance is used in African societies to tell the history of their community, celebrate harvests, announce the arrival of dignitaries and a multitude of other social purposes. We hope to illustrate a few of these notions, woven into a series of performances that are educational as well as entertaining. However, an element that draws upon the past but endeavours to create new and unique forms of interpretation is modern dance. We plan to utilize sources of funding to create original pieces for the opening.

In addition, music is an integral part of the communicative process of the cultural art forms in African and Black societies. Instruments are made from local areas, are used in religious rites and worship, and form the foundation and connection between performer and listener, merging the boundaries. Music and song tell the history of communities- educating, informing, and entertaining.

The challenge we face is to present a number of different performers in a way which weaves them together into a cohesive form...in effect, tell a story. Intermittent educational presentations are planned to "fill in" the dance and musical performances. And spoken word has emerged as an art form among a wide cultural spectrum of youth which both unites, excites and educates. It is the social, cultural and political voice of hip hop and we hope to build upon the success of last year to incorporate this medium into the "story".

The Black History Market & Cultural Showcase organized by The Centre of Integration for African Immigrants (CIAI) will be held on Saturday, February 26, 2005 at the Roundhouse Community Centre, 181 Roundhouse Mews, Vancouver, V6Z 2W3. The Showcase will run from 11:00am to 8:00pm (not including set-up and take-down time).

The Black History Market & Cultural Showcase is one of several events being held to celebrate Black History Month. This showcase will invite many cultures, along with the African/Black community, to recognize the presence and contributions made in Canada by the African/Black community.

The Black History Market & Cultural Showcase will act as a medium to educate, promote and celebrate the African/Black culture through dance, theatre, music and food. African/Black culture is not evident in the lower mainland on a regular, available and accessible basis. The Vancouver community is still relatively unfamiliar with the contributions & cultural roots of Africans. Attendees will be able to see experts from various cultural groups modeling black cultural fashions, hear native performers play African/Caribbean ethnic music and sample African/Caribbean foods, rich with the spices of the culture.

The Black History Market & Cultural Showcase brings together all aspects of culture: music, dance, literature, arts & craft, food and most of all people. The educational and sharing component of the showcase will be demonstrated through teaching various art forms: dance, drumming. Attendees will be able to further participate by learning how to wear traditional African fashions, including how to tie extravagant headdresses. Attendees can take away a piece of the culture with them, through purchases made.

Grant Funds will be used to assist in the costs related to Programming: Performers' honorariums; Equipment costs: P/A system, stage lighting; Rental: Roundhouse Community Centre Exhibition Hall; Site Decoration: Ribbons, African Cloths, Flowers; Staff & Admin. Costs; Publicity & Marketing: Design & Production of advertising for print/radio/television/web site; Advertising in Mainstream & Ethnic Media.

The Chinese New Year parade/celebration in Chinatown has been an annual event for the past 31 years. The 2005 Parade to celebrate the Year of the Rooster will take place on Sunday, February 13, 2005.

In the past few years, the Parade has become a multi-cultural event with over 50 entries and more than 2,000 participants from various cultural, ethnic and community groups. Last year 25,000 spectators from all walks of life lined up along the parade route. The Parade has enjoyed tremendous coverage from local media due to its popularity. In 2004, Channel M produced a one-hour program on the parade for the television audience and is thinking about doing the same for the 2005

CBA has been the lead organizer of the Parade for close to 25 years. For the past several years, CBA has joined force with 3 other groups to share financial and organizational responsibilities for the Parade. They are Chinese Cultural Centre of Greater Vancouver (CCC), Vancouver Chinatown Merchants Association (VCMA), and S.U.C.C.E.S.S.

We are seeking both service grant and cash grant under the Celebration Grants program.

- 1. A service grant that covers 50% of the total cost of services provided to major parades by the City for police and engineering services. This total cost is estimated to be \$10,000 for 2005.
- A cash grant to cover costs of programming, staff/administration, and publicity/marketing. Some special reasons for the cash grant are:
- To expand participation by non-Chinese cultural groups;
- To boost advertising in the English media including a dedicated web site;
- To enter a new float to mark the 20th anniversary of the twinning of Vancouver and Guangzhou cities;
- To form a separate non-profit society for the Chinatown parade to attract more volunteers and funding.

The Eastside Culture Crawl is an annual event in which artists and craftspeople in Strathcona, Chinatown, the Downtown Eastside and Grandview/Woodlands open their studio doors to the public for a three-day celebration of the arts. It is an opportunity for the public to meet many diversely talented artists and view their creations in the studios in which they work. In the beginning the Crawl was about a weekend show and sale, however, in recent years it has expanded beyond a craft fair to become a community arts festival. This year's festival is scheduled for November 19th to the 21st.

For the past three years we have undertaken outreach projects to try and have more artistic representation of the cultural diversity in our community. These projects have included providing display and demonstration space for First Nations carvers, a series of performances by Strathcona Chinese Dance, installation pieces at the Strathcona Community Centre, and exhibits, performances, and spoken word activities at the Brittania Community Centre and the Firehall Arts Centre. We are also very pleased that St. James Community Service Society's Victory House Arts Program will be back this year after a brief hiatus. In addition to our sponsorship of St. James, we are also sponsoring outreach projects with the Kettle Friendship Society and the Purple Thistle Society.

Almost the entire Eastside Culture Crawl's budgeted expenses fall within the eligible categories under the Celebration Grants Program. The budget for this year's Crawl is estimated at \$26,940 which is higher than in previous years as we need to put additional resources into publicity and marketing and into staff and administrative costs. Our Board of Directors is working towards a long-term sustainability plan for the Crawl which will require increased funding towards these two categories. We are requesting a City of Vancouver Celebration Grant in the amount of \$9,000 to help defray these costs. We would be pleased to meet with the Office of Cultural Affairs to discuss specific budget items to which you would want these funds targeted, if necessary.

In 2001, Evergreen and the Everett Croweley Park Committee held the first large-scale Earth Day event in Everett Crowley Park. We were overwhelmed by the popular support for this planting and stewardship event and with the commitment of our partners have turned Earth Day Vancouver Celebration in Everett Crowley into the largest annual Earth Day event in British Columbia. Over 3,500 people have participated as community volunteers to date. This year's event is schedule for Saturday April 23, 2005.

With a City of Vancouver Celebration Grant, last year we were able to expand the event's program to include a strong cultural element with participatory art work, roving musicians and costumed characters. Facilitated by Secret Lantern Society artists, members of the public helped create a mandela with natural materials gathered on site. The evolving artwork becomes a creative expression of group engagement. Stories of children creating their own mandelas at home weeks and months later are common. Family-oriented and fun, musicians and characters provide comic moments during the important work of the day. Entertaining, interactive and educational, these playful characters engaged the imagination of the children who are in the process of becoming the stewards of the planet.

We are seeking funding from the City of Vancouver through the Celebration Grants to support the cultural program for Vancouver's hallmark Earth Day public event.

The goals of the event are to:

- *celebrate the natural and soci-cultural heritage of Everett Crowley Park and the surrounding community.
- *raise awareness of Earth Day among all people in Vancouver as a day to celebrate positive solutions to environmental concerns
- *raise awareness of the need to preserve and restore ecologically significant ecosystems in urban spaces.
- *involve city people of all ages, backgrounds and abilities in a shared experience of civic leadership, corporate leadership and environmental stewardship.

Program Objectives

This program is for community-based festivals, cultural celebrations and large parades, in recognition of the entertainment they offer and their contribution to a sense of community among residents of diverse cultures, ages and interests.

Assistance with specific costs is available to help community-based not-for-profit societies to present these events, which may include programs of music and performance, crafts, exhibits, culinary and other cultural expressions of the community.

Who can apply?

Applicants must be:

- ☐ registered as not-for-profit societies in British Columbia for at least six months
- □ located in the City of Vancouver (not in other Lower Mainland municipalities or the University Endowment Lands)
- □ have a cultural mandate which includes organizing festivals, celebrations or large scale parades in Vancouver

Examples of organizations that can apply include neighbourhood houses, resident associations, community service groups, ethnocultural societies, or arts and cultural organizations. Although Business Improvement Associations are not eligible on their own, community events they cosponsor with not-for-profit community organizations are eligible.

The following are ineligible to apply:

- □ civic departments or branches (i.e. community centres, libraries)
- organizations receiving City of Vancouver cultural grants.

What types of events are eligible?

Three types of events, organized for the purpose of building and celebrating a sense of community and held primarily for the benefit of Vancouver residents, qualify for assistance:

- □ Festivals: annual or biannual events of at least two days, actively programmed around a theme related to cultural expression in the broadest sense, for example, through music or other performances, crafts, displays, cooking, or demonstration of cultural traditions.
- ☐ Celebrations: one-day events, generally held outdoors, and actively programmed around a theme, anniversary, or other occasion, with a significant cultural component in the broadest sense.

Program Information

Major parades: generally one-day events with a large audience and a significant cultural component, broadly defined to include music and other performances, costumes, floats, banners, arches and installations, or other pageantry elements.

Please note: To qualify as "major" a parade must have an event budget of over \$15,000; attract, or have the potential to attract, an audience of over 10,000; and have 20-25 organizations registered as entrants.

Ineligible activities and expenses:

- □ sports and athletic events, runs, walks
- □ competitions
- demonstrations, marches, rallies
- □ block parties, picnics, garden shows, street markets, carnivals
- ☐ religious rites and ceremonies, small parades and processions
- events for marketing, promotional, or commercial purposes
- events whose purpose is primarily fund-raising
- ☐ retroactive expenses or accumulated deficits
- ☐ city services costs of festivals or celebrations
- □ capital projects

What can grant funds be used for?

The Celebration Grants program has two components. The first provides for cash grants to festivals, celebrations and parades. Funds may be applied toward one or more of the following:

- Programming costs: for example, performers' fees; display and exhibit costs; equipment rental; production technician's fees; costume creation, rental or cleaning; site decoration; parade floats and other pageantry elements.
- □ Staff and administrative costs: for example, planning and co-ordination, fundraising, and event management.
- Publicity and marketing: for example, development of marketing strategies; press kits; design and production of advertising for print, radio, television, and web sites; and purchase of advertising in mainstream and/or ethnic media.

Please note: Individual grant amounts will range from \$1,000 to a maximum of \$10,000, depending on the scale of the event. Events with significant city-wide audiences, collaboratively organized by multiple community partners, may receive a larger grant.

The second component of the program provides for service grants to major parades. Up to 50% of the cost of services provided to major parades by the City is eligible for a grant. Service grants apply to police or engineering services such as traffic signs, barricades, and sanitation. The cost of Park Board, Coast Mountain Bus Company, or BC Ambulance services are not eligible.

Please note: The total annual budget for service grants to parades is \$25,000. Major parades may request up to 50% of their anticipated City service costs; requests may not exceed \$10,000.

How to apply

To obtain an application form, please contact Office of Cultural Affairs (OCA) staff, who manage the Celebration Grants program. Organizations must establish their eligibility for funding with OCA staff well in advance of submitting an application.

- □ To be considered for a grant, an organization must complete and submit the appropriate, signed, original application form, together with two copies, and three sets of the required supplemental documents indicated in the application form.
- Organizations planning events on city streets or in parks must apply through the FEST Committee or Park Board for approval to hold their event in these locations.
- Under normal circumstances, the application, review and decision process takes seven weeks. Cash grants will generally be paid out within three weeks of Council approval. Service grants approved by Council for major parades will be applied to the cost of eligible City services up to a maximum of 50% following the event.

How will applications be evaluated?

Since funds are limited, not all organizations meeting the eligibility criteria can be supported. This is a competition, based on the following:

Revenues

Applicants are expected to generate revenues from sources other than the City of Vancouver. These may include earned income from tickets and concessions, sponsorships, donations from individuals, businesses or community groups, memberships, inkind donations, and support from foundations and government agencies.

Review process

- ☐ Cultural Affairs staff ensures that applications are eligible. City staff on the FEST committee and/or Park Board are consulted on operational impacts, site issues and permits.

 Interviews with applicants are arranged as needed.
- ☐ A grant program advisory committee of community members and individuals with event management experience reviews the proposals and provides comments. Staff then submit a report with recommendations for Council's approval, and notify applicants of the recommendations and the Council meeting date on which grants will be considered.
