# ADMINISTRATIVE REPORTS

- 1. Application for a Provincial Grant, in support of the Discovery Education Centre development at the Vancouver Aquarium February 2, 2005 (File 4155)
  - A. THAT Council approve the submission of an application to the Province for a one-time, unrestricted grant of \$8.2 million to fund the development of Phase 2 of the Discovery Education Centre at the Vancouver Aquarium.
  - B. THAT Council, subject to approval of the unrestricted grant from the Province, approve a grant of the same amount to the Vancouver Aquarium for development of the Phase 2 of Discovery Education Centre at the Vancouver Aquarium, and THAT Council delegate responsibility to the Park Board to manage disbursement of the grant by entering into a partnership agreement with the Vancouver Aquarium to oversee the development of the Discovery Education Centre at the Vancouver Aquarium; the agreement to be drafted to the satisfaction of the General Manager of Parks and Recreation and the Director of Legal Services.

- 2. Parking Meter Equipment Purchase January 20, 2005 (File 5654)
  - A. THAT Council approve the purchase of replacement parking meter equipment at an estimated cost of \$310,000, with funds provided from the Parking Meter Replacement Fund.
  - B. THAT Council approve the purchase of new parking meter equipment, for installation in approved meter areas, at an estimated cost of \$100,000, with funds provided from increased parking meter revenue estimated to be \$200,000 annually.

- C. THAT Council approve an increase in parking meter maintenance costs of \$48,000 to increase parking meter maintenance staffing, and \$15,000 for additional clerical staffing (Clerk 3 level subject to classification review), with funds provided from increased parking meter revenue.
- D. THAT Council approve an annual increase of \$15,000 to the Parking Operations budget to enhance parking meter security. In 2005 these funds will be used in partnership with ICBC, which matches City funds, to increase Crime Prevention patrols. The City funding is to be provided from increased parking meter revenue.
- E. THAT Council approve an annual increase of \$7,000 to the parking meter replacement fund to ensure the future replacement of the new meters added in B above.

- 3. Building Rehabilitation Program Façade Grant 124 Powell Street January 26, 2005 (File 2005)
  - A. THAT Council approve a façade grant of up to \$35,000 for the principal façade at 124 Powell Street in association with the Development Application Number DE408252, the source of funding to be the 2003 2005 Capital Plan.
  - B. THAT prior to issuance of the building permit, the Owner shall grant to the City a section 219 covenant by which professional oversight of the rehabilitation is required and by which the Owner is required to maintain the Powell Street façade in good appearance and good repair for the life of the building. The covenant shall be to the satisfaction of the Directors of Current Planning and Legal Services and registered in the Land Title Office in priority over all financial charges.

FURTHER THAT Mr. Tom Timm, General Manager of Engineering Services, remain as Deputy Approving Officer, with the authority of this position when both the Approving Officer (Mr. Scobie) and the Deputy Approving Officer (Mr. Judd) are absent from work.

B. THAT pursuant to the Development Permit Board and Advisory Panel By-law, Mr. Peter Judd, Deputy City Engineer, is an alternate member on the Development Permit Board to Mr. Timm, General Manager of Engineering Services, and Mr. Ian Adam remains as an alternate member on the Development Permit Board to the General Manager of Engineering Services.

- 5. Proposed Licence Agreement over a Portion of the Canada Place Viaduct, between Howe Street and Burrard Street; to the Vancouver Port Authority January 25, 2005 (File 1203)
  - A. THAT Council authorize the Director of Legal Services to enter into a Licence Agreement (the "Licence") for those portions of the Canada Place Viaduct, west from Howe Street and east from Burrard Street, the same as generally shown in heavy outline on the plan attached as Appendix "A" (the "Licence Areas") to the Administrative Report *Proposed Licence Agreement over a Portion of the Canada Place Viaduct, between Howe Street and Burrard Street, to the Vancouver Port Authority* dated January 25, 2005, subject to the following conditions:
    - 1. The Licence to be granted to the Vancouver Port Authority (the "VPA");
    - 2. The term of the Licence to be 10 years;
    - 3. The fee for the term to be a nominal sum of \$10.00;
    - 4. The Licence Areas to be used only for the installation of security cameras;
    - 5. The minimum clearance to be maintained shall be 4.9 metres (16 feet) measured from the road surface of Waterfront Road, below Canada Place;
    - 6. The VPA to provide an as-built survey after completion of all installations to the satisfaction of the General Manager of Engineering Services;
    - 7. The VPA to be responsible for all relocation costs of the cameras, even if required by the City;
    - 8. The cameras to be removed upon 90 days notice of the General Manager of Engineering Services;
    - 9. Upon expiry or termination of the Licence, the VPA is to be responsible for restoration of the Licence Areas to the satisfaction of the General Manager of Engineering Services;

- 10. The VPA to assume full responsibility for liabilities, loss and damages from their occupancy or use of the Licence Areas, and to carry comprehensive general liability insurance to the satisfaction of the Director of Risk and Emergency Management; and
- 11. The Licence to contain such other terms and conditions satisfactory to the Director of Legal Services, Director of Real Estate Services and the General Manager of Engineering Services.
- B. THAT the VPA be responsible for all costs associated with installations on the Licence Areas.
- C. THAT no legal rights shall arise and no consents, or permissions, are granted hereby and none shall arise or be granted hereafter, unless and until all contemplated legal documentation has been executed and delivered by all parties.
- D. THAT once the form of all legal documentation and plans has been approved by the General Manager of Engineering Services and Director of Legal Services, that the Director of Legal Services be authorized to execute and deliver such documentation and plans on behalf of the City.

- 6. 1353 East 1<sup>st</sup> Avenue Exterior Repairs Award of Contract February 2, 2005 (File 1805)
  - A. THAT Council approve exterior repairs to three-storey apartment building at 1353 East 1st Avenue at an estimated project cost of \$465,000; source of funding to be Property Endowment Fund (PEF).
  - B. THAT Council award the contract for repairs to Columbia Restoration Company Limited, in the amount of \$304,000 based on the best value for the City.

 CD-1 Text Amendment - Vancouver Community College (King Edward Campus), 1155 East Broadway February 1, 2005 (File 5303)

THAT the application by Rainer Fassler, Stantec Architecture, to amend CD-1 By-law No. 5407 for Vancouver Community College, to permit an additional 63,639 m<sup>2</sup> (685,027 sq. ft.) of floorspace for School and related uses, as well as limited Cultural and Recreational, Institutional, Retail and Service uses, be referred to a Public Hearing together with,

- (i) plans received January 14, 2005;
- draft CD-1 By-law amendments, generally as contained in Appendix A of the Policy Report *CD-1 Text Amendment - Vancouver Community College (King Edward Campus) 1155 East Broadway* dated February 1, 2005, and;
- (iii) the recommendation of the Director of Current Planning to approve the application, subject to conditions contained in Appendix B of the Policy Report;

FURTHER THAT the Director of Legal Services be instructed to prepare the necessary CD-1 By-law generally in accordance with Appendix A of the Policy Report for consideration at Public Hearing, including a consequential amendment to the Sign By-law to establish regulations for this CD-1 in accordance with Schedule B (C-2) as set out in Appendix A of the report.

# 2. CD-1 Text Amendment: 375 East Pender Street and 485 Dunlevy Avenue February 3, 2005 (File 5307)

THAT the application by Y.M. May Lee Architect, on behalf of the Menonite Church of B.C., to amend CD-1 By-law No. 7230 for the site at 375 East Pender Street and 485 Dunlevy Avenue (Lot D, Block 71, DL 196, LMP 12929, Plan 10698) to increase building height from 4 to 5 storeys to permit retention of a roof top amenity room built without permit, be referred to a Public Hearing, together with:

- (i) plans received January 9, 2004;
- (ii) draft CD-1 By-law amendments, generally as presented in Appendix A of the Policy Report *CD-1 Text Amendment: 375 East Pender Street and 485 Dunlevy Avenue* dated February 3, 2005; and
- (iii) the recommendation of the Director of Current Planning to approve, subject to conditions contained in Appendix B of the Policy Report;

FURTHER THAT the Director of Legal Services be instructed to prepare the necessary CD-1 amending by-law generally in accordance with Appendix A for consideration at the Public Hearing.

- 3. Chinatown Revitalization Program (Phase II): Chinatown Community Plan and Ongoing Community Development January 27, 2005 (File 8102)
  - A. THAT Council approve the development of a Chinatown Community Plan as the second phase of the Chinatown Revitalization Program, based on the work program outlined in the Policy Report *Chinatown Revitalization Program (Phase II): Chinatown Community Plan and Ongoing Community Development* dated January 27, 2005.
  - B. THAT Council instruct staff to begin organizing the Chinatown Community Plan at a cost of \$57,680, without offset, which will be added to the Community Services Group's 2005 operating budget, subject to 2005 budget considerations.
  - C. THAT, subject to 2005 budget considerations, Council approve staffing resources for the development of a Chinatown Community Plan, including:
    - i. A temporary Policy Planner for a 32 month period, to develop policies and manage the overall work program, subject to classification by the General Manager of Human Resources, at an approximate cost of \$57,680 for 2005, \$88,685 for 2006 and \$90,905 for 2007 including benefits.

- A temporary half-time Heritage Urban Designer (Development Planner II) for an 18 month period, to examine complex development projects and develop an overall urban design strategy for Chinatown, at an approximate cost of \$28,840 for 2005 and \$36,955 for 2006 including benefits. If necessary, the funding will be converted into a consultancy.
- iii. A temporary Social Planner for a 32 month period, to continue and build on the community development work in Chinatown and the Downtown Eastside area, subject to classification by the General Manager of Human Resources, at an approximate cost of \$57,680 for 2005, \$88,685 for 2006 and \$90,905 for 2007 including benefits.
- D. THAT, subject to 2005 budget considerations, funds in the amount of \$140,750 be allocated, without offset, for program development, public consultation, communications and research.
- E. THAT the Director of Current Planning, in consultation with relevant departments and the Manager of Special Projects, report back at least once a year on the progress of the Chinatown Community Plan, including the following strategies as priorities:
  - i. A strategy for the rehabilitation of the buildings owned by the family association and benevolent societies in Chinatown;
  - ii. A strategy for residential intensification and land use for Chinatown;
  - iii. A parking strategy for Chinatown; and,
  - iv. An update on the community development initiatives in the Chinatown and Downtown Eastside area.
- F. THAT Council direct staff to continue to work with the senior governments through the Vancouver Agreement to leverage funding for the implementation of the Chinatown Community Plan.

# A. Administrative Motions

1. Closing portions of lane east of Fir Street and south from West 8<sup>th</sup> Avenue (File 5753)

MOVED by Councillor Woodsworth SECONDED by Councillor Louie

THAT WHEREAS:

- 1. The City of Vancouver is the owner of all the streets and lanes lying within the limits of the City of Vancouver;
- 2. There is a proposal to redevelop privately-owned Lot 4, Block 330, District Lot 526, Plan 8781;
- 3. The building currently under construction on said Lot 4 encroaches onto a portion of the lane east of Fir Street, south from West 8th Avenue adjacent to said Lot 4;
- 4. The said portion of lane encroached upon is a portion of PID: 015-205-720 That Part of Lot 4 in Explanatory Plan 14380, Block 330, District Lot 526, Plan 590;

- 5. The said Part of Lot 4 in Explanatory Plan 14380 was established as lane by deposit of DF 20673 on February 18, 1931;
- 6. The owner of said Lot 4, Plan 8781 has made application to purchase the said portion of lane encroached upon;
- 7. The said portion of lane encroached upon is no longer required for municipal purposes;
- 8. The subdivision plan to consolidate the said portion of lane encroached upon with said Lot 4, Plan 8781 will dedicate as lane the balance of That Part of Lot 4 in Explanatory Plan 14380, Block 330, District Lot 541, Plan 590 still required for municipal purposes;
- 9. The said subdivision plan will also dedicate as lane other portions of the Cityowned lane east of Fir Street, south from West 8th Avenue and the lane south of West 8th Avenue and east of Fir Street which were established as lane by deposit of said DF 20673 on February 18, 1931 and DF 20934 on May 12, 1931, more particularly described as:
  - a) Parcel Identifier: 015-205-401 The East 8 feet of Lot 3, Block 330, District Lot 526, Plan 590 Established as Lane, See DF 20934;

- The City of Vancouver is the largest employer of fire fighters in the province of British Columbia, and therefore the largest stakeholder.
- City Councils of Vancouver, Surrey, Burnaby, Richmond and Delta have voted to support the fire fighters going forward for Presumptive Cancer Legislation based on the scientific works of the 1994 Ontario Industrial Disease Standards Panel (IDSP), Baris (2001), and the work of Doctor Tee Guidotti.
- The GVRD Labour Bureau is not a proportional representation of employers of fire fighters.
- The major stakeholders of the GVRD Labour Bureau are in favour of supporting adoption of Legislation and Regulations acknowledging the relationship between fire fighting and cancers identified by Doctor Tee Guidotti.
- Certain voting members of the GVRD Labour Bureau do not employ fire fighters, and are therefore not stakeholders.

THEREFORE BE IT RESOLVED THAT:

- Vancouver City Council, as the largest employer of fire fighters in the province of British Columbia, express directly to the Workers Compensation Board and to the Provincial Government their continued support for the presumption that a number of cancers, as identified by Doctor Tee Guidotti, be adopted as soon as possible. These cancers include cancer of the brain, bladder, kidney, testicle, and lung (in nonsmokers) and myeloma and leukemia.
- Vancouver City Council will continue supporting fire fighters by replying to the WCB Discussion Paper - specifically (page 16) Section 6.1 (Disease Recognition Options) firmly calling for Schedule "B" to be amended as identified in Option 2 - Sub-option (d).
