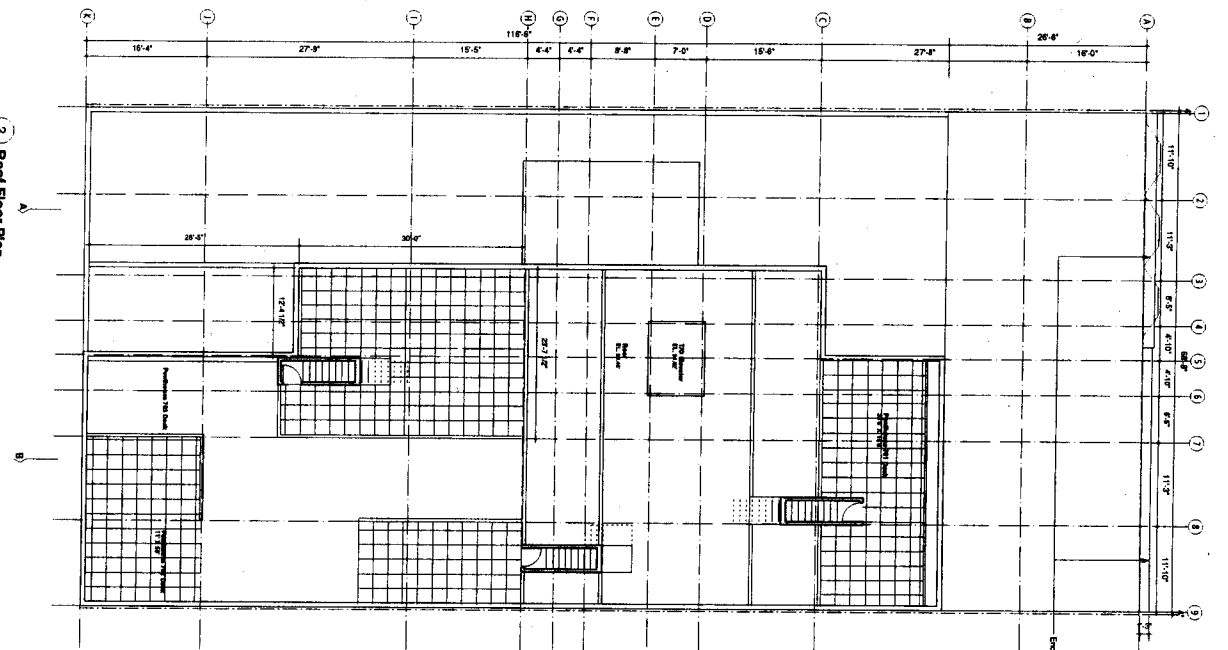
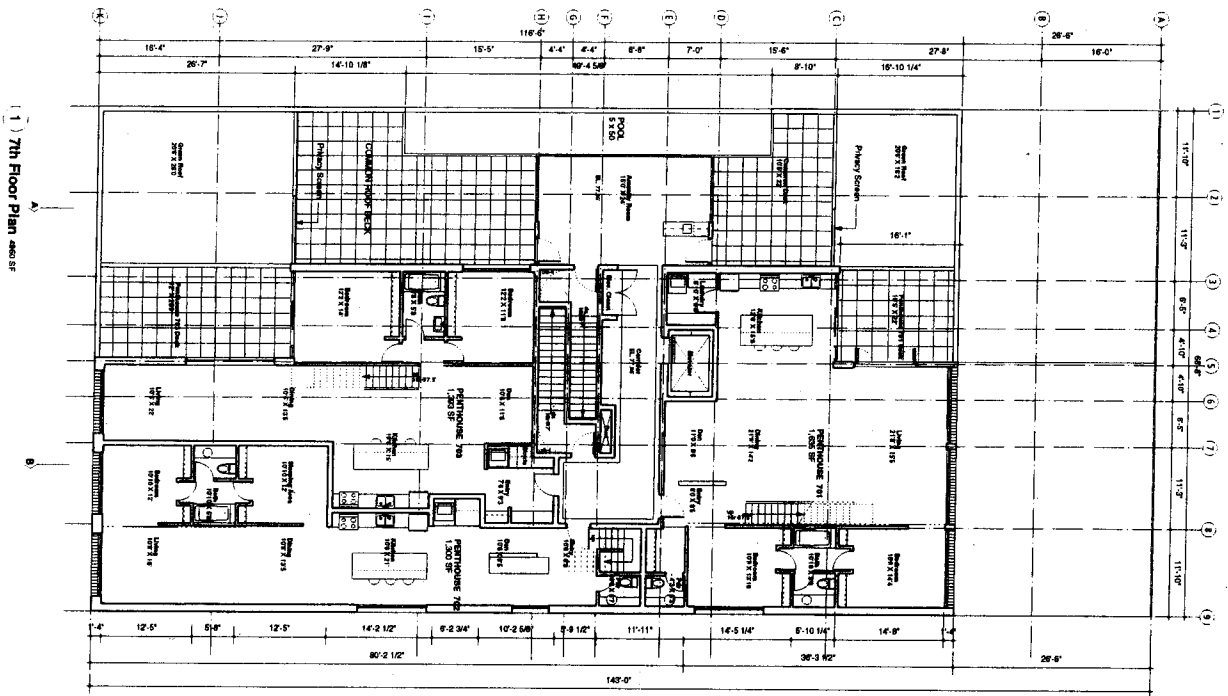
GROUND FLOOR / 2nd FLOOR PLAN

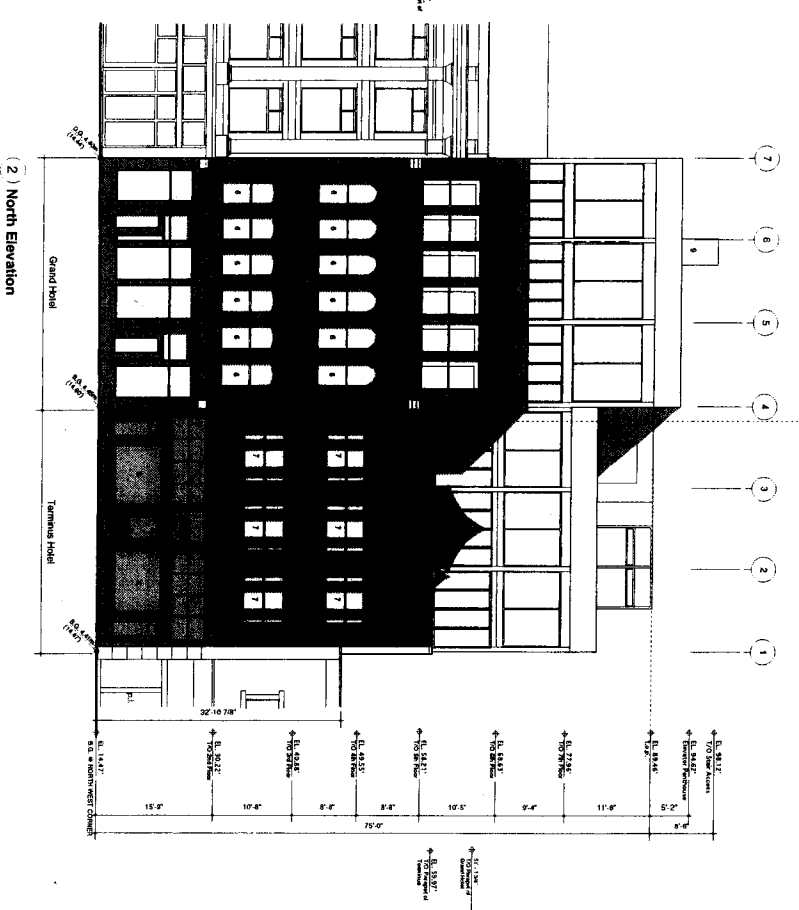
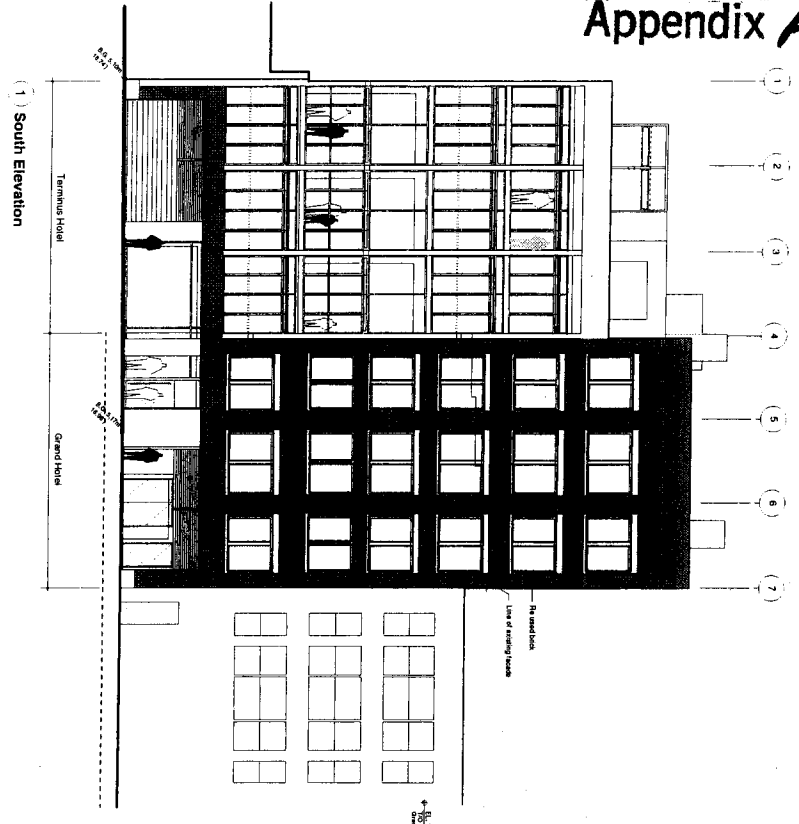

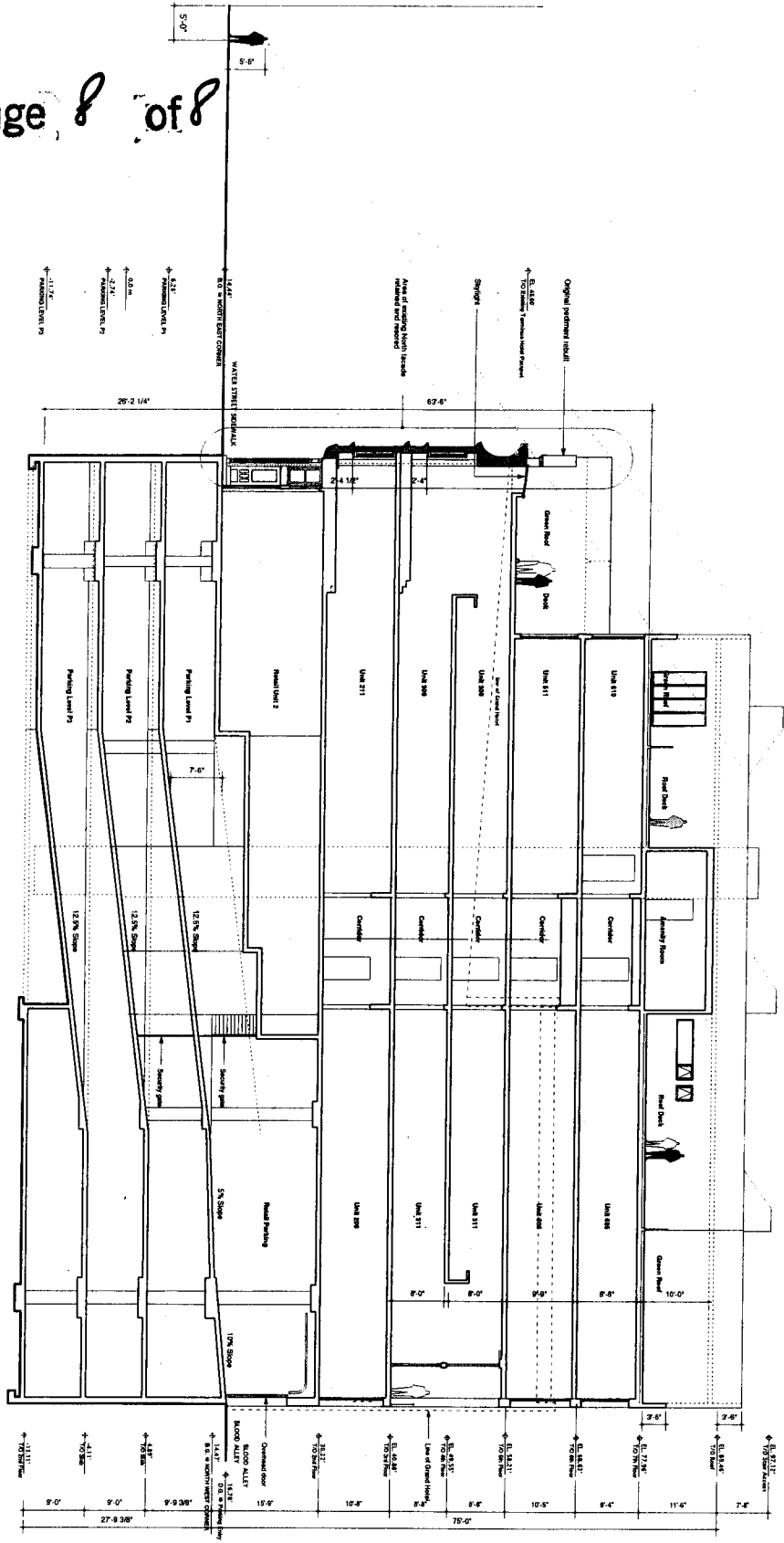
