SUBJECT: Local Improvements by Petition - June 8, 2005

First and Second Step Report

RECOMMENDATION

- A. THAT petition projects listed in Appendix I be brought before a Court of Revision on June 8, 2005.
- B. THAT the reports of the City Engineer and Director of Finance be adopted together with details of the Second Step Report as summarized in Appendix II. Source of funds for the total City's share of \$514,911 is \$114,821 from existing Engineering Basic Capital Accounts and \$400,090 is subject to approval of the 2005 Streets Basic Capital Budget.
- C. THAT sidewalk project Number 20, as described in Appendix I, be designated as "pedestrian collector route" so that the abutting residential property owners' rates are reduced by the required 25%.

COUNCIL POLICYPolicies governing the Local Improvement process are set out in the Vancouver Charter and Local Improvements Procedure By-law.

PURPOSE

A Court of Revision is scheduled for June 8, 2005, at 7:30 p.m. to review a number of petition and initiative projects. This is the "First and Second Step" report for the petition projects. The report for initiative projects was approved by Council on March 29, 2005. The purpose of this report is to begin the formal Local Improvement process by advancing the petition projects to the Court of Revision and to report on the financial arrangements for the projects. Approval of this report does not commit Council to undertake the projects.

First Step

As required by the Local Improvement Procedure By-law, projects for the following categories and detailed on the attached schedule (Appendix I), are advanced to Council by Petition for review at a Court of Revision, which will be held at 7:30 p.m. Wednesday, June 8, 2005.

- I. Pavement & Curbs, Higher Zoned
- II. Pavement & Curbs, Local Residential
- III. Lane Pavement, Higher Zoned
- IV. Lane Pavement, Local Residential
- V. Speed Humps
- VI. Pedestrian Collector Sidewalk
- VII. Lane Lighting
- VIII. Traffic Circle

FINANCIAL IMPLICATIONS

Local Improvements is estimated at \$1,073,507. The City's share is \$514,911 funded as follows:

- \$114,821 for the City's share of projects is available from existing Streets Basic Capital Account as shown in Appendix II. Of this amount \$108,641 will be provided from Drainage Prior to Paving funding.
- \$400,090 is subject to approval of the 2005 Streets Basic Capital Budget. Of this amount \$75,375 will be provided from Drainage Prior to Paving funding.

Second Step

The Director of Finance reports as follows:

In accordance with the Local Improvements Procedure By-law, I am submitting the attached City Engineers Report. The estimated cost of these projects is \$1,073,507. The property owners' share of the projects is \$558,596. The City's share is \$514,911. I have to report that the necessary financial arrangements can be made to carry out this work subject to approval of the 2005 Streets Basic Capital Budget.
