# Speakers' comments included:

commended staff for report which is comprehensive and credible;

- reviewed February 8, 2005 motion passed by Advisory Committee on Disability Issues which makes specific recommendations relating to disability issues and Plan;
- recommended swift action from all levels of government;
- necessary to work with Ministry decision-makers regarding children/family development;
- reviewed statistics regarding homelessness and children; numbers are increasing;
- homeless almost always clients of public systems and assistance programs;
- foster care system must provide better discharge planning; not move children in system except back to well-supported families; large turnover of homes increases risk of children becoming homeless adults;
- extended families must be helped to provide care for children at risk;
- welfare rates, El and income assistance levels must be increased;
- child and daycare funding must be restored;
- coordination with Ministry of Human Resources must be improved;
- youth housing/staffing must be provided in the same manner as seniors' housing;
- City's Child and Youth Advocate should assist in integrating child welfare issues into Plan;
- United Nations mandate regarding rights of children and adequate standing of living must be considered by all levels of government;
- concerns expressed relating to inadequate care for youth including limited range of residential/mental health services, lack of alternative schools space, limited drug and alcohol related services and institutionalized age discrimination;
- due to poverty/abuse/neglect/domestic violence, and other reasons, many youth are forced or choose to be on the streets where they find a sense of family;
- the younger a child becomes entrenched in a street life style, the more difficult it becomes to integrate them back into society and health risks increase;
- number of homeless women is increasing; gender specific data should be gathered;
- gap between income and affordable housing has reached crisis proportions;
- moving people inside and providing longer term stability is cost effective;
- services/housing/special needs facilities required throughout Vancouver, not just in DTES;
- Provincial and Federal governments must resume housing development;
- persons with incidents of repeat homelessness need immediate assistance;
- subsidized housing units are being lost at an alarming rate;
- do not relax 320 sq. ft. standard unit size; smaller suites are not long-term answer;
- livability is key to housing, along with affordability;
- 400 units already lost to Olympics fallout;
- by-laws/standard business license standards must be enforced (hire more inspectors);
- complete renovations to SROs with as little disruption to residents as possible;
- 450 sq. ft. should be standard for all new units of low income housing stock;
- City should encourage private sector to create more rental housing through zoning changes and preserving existing rental stock;
- City should purchase two SROs/year, not one;
- part-time workers find it increasingly difficult to find housing;
- stronger enforcement tools required for SROs;
- provide incentives to SRO owners, e.g. performance contracts;
- Council must stand up to provincial/federal governments and act immediately to take advantage of proposed federal housing funding;

- TransLink should provide transportation free of charge for homeless; cold/wet weather funded programs exist in Toronto, Winnipeg and Calgary;
- supported community forums, but suggested regular report card process and continued community involvement;
- local planning office should be initiated in the DTES asap;
- homelessness is not restricted to the DTES, but throughout Vancouver;
- working poor numbers are increasing;
- house surfing is becoming prevalent;
- communities help with lower cost stop-gap measures but there is lack of funding, resources, and time; these measures are neither solutions, nor sustainable;
- City should not be seduced by lower cost stop-gap measures; Triple A credit rating is achieved by reducing liabilities to the City and the Plan is a good step;
- 'temporary' food banks are now accepted as part of society this is unacceptable;
- staff commended for connecting community organizations and service providers;
- public education is a major component in achieving successful implementation;
- report must specify it is meant to serve homeless and ensure their respect and dignity;
- Council should ask Ministry of Tourism to allocate portion of hotel tax to fund implementation of the Plan;
- Council should contact those responsible for Residential Tenancy Act and request that appropriate personnel be given enforcement powers;
- alleviating homelessness will lessen problems relating to sex trade and sanitation;
- Council should build city-wide coalition and contact other organizations, including Federal
  and Provincial bodies and the media, to emphasize need for immediate implementation to
  fix broken system;
- report is so broad that resources might be spread too thin to implement properly;
- need targeted street outreach to identify population and work to connect them to specifically designed housing;
- purposeful interventions required; create destinations to continue stabilization;
- Council should proclaim "Homelessness Week" (3<sup>rd</sup> week of November); suggested events include free meals (nominal fee for those able to pay) and inter-agency forum; all Vancouver should be encouraged to participate;
- report should be broken up to determine short and long-term realistic possibilities;
- Vancouver can showcase ability to work together and take leadership role;
- report does not include aboriginal concerns and should address the following:
  - traditional values;
  - o why so many aboriginal children live in 3<sup>rd</sup> world conditions;
  - o aboriginal communities suffer the poorest social and health status;
  - o research and statistics relating to aboriginal homeless women;
  - o services/training required to break the cycle of poverty;
  - o designated shelters for aboriginal homeless and mentally ill;
  - o staff should meet with aboriginal community; representation is insufficient;
- report should address effects of Provincial budget cuts on women, particularly seniors;
- Council to urge the Province to make supported housing for mentally ill a priority throughout British Columbia, so individuals can remain in their own communities;
- assistance eligibility requires degree of literacy/computer/orientation; training required;
- transportation, phone/computer access and training are critical to job searches;
- detox and recovery programs should be available on demand to all people;

- housing is a form of treatment; treatment should be implemented assertively take it to those who need it;
- police require training relating to psychotic episodes;
- environmental health concerns affect homeless;
- mature women in particular are missed in homelessness count (hidden homeless);
- Architectural Institute of BC should be a partner in this initiative;
- some seniors, specifically women, fear being in the same shelters as youth; senior women require designated transitional housing.

The following spoke in opposition to the recommendations:

Anton Pilipa Kim Kerr, DERA

Speakers' comments included:

- report back in 2 years will show that homelessness will have increased;
- report does not indicate action will take place, it is a policy report only;
- City should not rely on other levels of government, but fund services directly;
- City should not create homelessness by closing down problem buildings and evicting residents who require immediate housing relocation assistance;
- hotels being closed for conversion/RAP grants will have rooms available for \$450/month
  which is not affordable to current tenants who have \$325 for rent, resulting in
  homelessness; owners who are willing should be allowed to comply with by-laws, repaint,
  and rent at affordable rates; this process is planned gentrification
- Vancouver Police Department plays a role in creating homelessness.

Ms. Davidson advised staff is reviewing possible incentives and ways to work with hotels to encourage better management; performance contracts are being considered in this process. She further advised the Province would be engaged in the discussion.
