A Business License Hearing of the Council of the City of Vancouver was held on Thursday, May 26, 2005, at 7:30 p.m., in the Council Chamber, Third Floor, City Hall.

## 1. Akbar Derazollah Moradi (File 2711-96)

A Business License Hearing of the Council of the City of Vancouver was held to determine whether or not a City of Vancouver business license for the year 2005 should be granted to Akbar Derazollah Moradi (the "License Applicant"), for business premises located at 410 Columbia Street, Vancouver, British Columbia (the "Premises).

Catherine Kinahan, Law Department, was present on behalf of the City of Vancouver. The License Applicant was represented by Stafford D.R. Alliston, William J. Hamilton Law Corporation. Kian Ghaffari, Interpreter, was also present to assist the License Applicant.

Ms. Kinahan advised the matter had been referred to City Council by the Deputy Chief License Inspector of the City of Vancouver pursuant to a Council Resolution dated February 24, 2005, a copy of which was attached to the Notice of Hearing.

Ms. Kinahan referred the Panel to evidence before it as set out in documents which were considered by the Deputy Chief License Inspector, a letter from the Deputy Chief License Inspector and the evidence of witnesses.

Ms. Kinahan referred the Panel to the following additional documents, referring to 410 Columbia Street and 419-421 Abbott Street, which were distributed at the hearing (on file in the City Clerk's office):

Mr. Alliston also asked questions of witnesses.

The hearing recessed at 9:05 p.m. and reconvened at 9:10 p.m. to continue hearing the testimony of witnesses.

Following the recess, Councillor Louis asked a question regarding the necessity of hearing police witnesses when the details of their police reports had already been referred to in the

evidence of the Deputy Chief License Inspector. Counsel for the City explained the rules of natural justice apply to a business license hearing, and that the applicant is entitled to cross-examine the police officer. Subsequently, Council for the City asked brief questions of each officer and the Applicant was given the opportunity to fully explore each officer's evidence in cross-examination.

Counsel for the License Applicant explained license applicant submitted his client has no criminal record, the evidence against him in terms of his involvement in illicit activities at the various premises is marginal, and he is being treated unfairly. Mr. Alliston then called Mr. Moradi as a witness. In answering questions, Mr. Moradi submitted he had limited knowledge about illicit activities that had occurred at the various premises, and that he had not revealed to any police officer that he was aware of drug trafficking in any of the premises.

The Panel also asked questions of Mr. Moradi, to clarify the timeline for the leases of the various premises, the level of accessibility of the various premises by previous lessees, and security cameras.

Mr. Alliston submitted closing remarks (*distributed - on file in the City Clerk's Office*), and requested the Panel consider granting a license with restrictions or a probationary license.

Mr. Moradi, with the aid of the interpreter, indicated that a few months previously, he had signed the lease for 410 Columbia Street, and there had been no problems since at those premises. Mr. Moradi assured the Panel if the license was granted, there would be no problems on the premises at 410 Columbia Street.

#### PANEL MEMBERS DISCUSSION

Prior to making a decision, the Panel requested clarification from Counsel for the City of Vancouver as to their powers in this situation. They expressed a concern that Mr. Moradi could continue to apply for business licenses in the City of Vancouver, and that such applications would cause a drain on City resources. Counsel for the City noted that Mr. Moradi was entitled to make such applications, and that there would have to be a hearing in each case. The Panel also noted the evidence at the hearing indicated that Mr. Moradi had no control over any of the premises discussed in this and previous hearings, that he allowed and encouraged drug trafficking, and it was questionable whether a legitimate business ever existed at any of the premises for which Mr. Moradi had applied for business licenses in the past.

# MOVED by Councillor Ladner

- A. THAT a City of Vancouver business license for the year 2005 not be granted to Akbar Derazollah Moradi (the "License Applicant") for premises located at 410 Columbia Street, Vancouver, British Columbia, (the "Premises") because the License Applicant is unlikely to manage the Premises properly due to his history of:
  - i. causing a drain on police and City resources;
  - ii. carrying on business to the detriment of the safety and well being of the neighbourhood; and,
  - iii. demonstrating an inability to control businesses for which he holds the lease.
- B. THAT any future business license applications submitted to the City of Vancouver by Akbar Derazollah Moradi be referred to Vancouver City Council by the Chief License Inspector.
- C. THAT the building owner of any premises for which there is a Business License application by Akbar Derazollah Moradi be required to accompany the Business License Applicant, and to appear before Vancouver City Council, in order to ensure that any business license issued to Akbar Derazollah Moradi in those premises does not cause a drain on police and City resources, or a detriment to the safety and well being of the neighbourhood.

#### **CARRIED UNANIMOUSLY**

The Business License Hearing Panel adjourned at 10:23 p.m..
