RECOMMENDATION

That Council approve 20 Project Grants totalling \$47,600 as listed in Appendix A, source of funds to be the 2005 Cultural Grants budget.

GENERAL MANAGER'S COMMENTS

The General Manager of Community Services recommends approval of the foregoing.

COUNCIL POLICY

City Council established the annual civic grant programs, including Cultural grants, in March 1978. Operating, Project, Organizational Development and Theatre Rental grant categories were approved on December 14, 1989. A second deadline for Project grants was established in 1999.

On November 22, 1994, Council approved a two-step grant approval process whereby undisputed staff recommendations are approved first (and are the subject of this report), while applications under reconsideration are given a second review and are presented to Council at a later date.

Approval of grant recommendations requires eight affirmative votes.

PURPOSE

As listed in Appendix A, this report presents recommendations for Project grant requests received for the May 16, 2005 deadline.

BACKGROUND

Project grants are intended for developing organizations; for organizations that work on a project to project basis; and for one-time events and other initiatives. Staff review applications based on criteria that include: artistic merit, the distinctiveness of projects in the context of comparable activities in Vancouver; organizational competence, including ability to deliver on plans; diversification of revenue sources; demonstrated need for financial assistance; and community impact, including public access to the work and the ability to connect with an audience. See Appendix C for program guidelines and criteria.

Requests for Reconsideration:

Applicants who meet certain criteria have the opportunity to formally request reconsideration. The Reconsideration process, approved by Council in 1994, ensures consistency in reconsidering grant recommendations. A request for reconsideration entails a written request by the applicant, a formal review by a staff committee and a report to Council presenting the applicant's case and staff recommendations.

Grants referred to the process are assessed on the basis of two established grounds: a) that eligibility criteria have not been properly applied and/or b) that the financial situation of the applicant was not properly evaluated or understood at the time of the grant review.

For the current round of Project grants which are reviewed and reported on in a short timeframe, any applicants requesting reconsideration are identified in a subsequent memo rather than in this report.

DISCUSSION

For the second project deadline this year, 31 project grant requests were received for a total of \$214,350 in requests.

Of the total requests, ten were from newly formed organizations, attesting to the continual growth in the arts community. Several new groups were from the theatre, inter-disciplinary and literary arts sectors, who are trying to establish themselves and present a unique voice within their respective communities. While many groups demonstrated potential, further development in organizational infrastructure and artistic vision was needed for some of these emerging organizations. As these groups evolve, several will return to the City for funding.

Staff assessed each application in the context of the evaluation criteria appended to this report, striving to balance support between established organizations and new voices. Based on the criteria, staff are recommending support to 20 organizations which include 4 grants to first time applicants. Detailed information on the applicants, their proposed projects and staff recommendations are presented in **Appendix B**.

Table 1 summarizes the total grant requests and recommendations from both Project grant deadlines this year.

FINANCIAL IMPLICATIONS

On March 29, 2005 Council approved Project grants totalling \$111,000, leaving a balance of \$47,600 for the second Project grant deadline. Approval of the 20 projects recommended in this report totalling \$47,600 for the second deadline leaves no balance in the Project grants component of the Cultural Grants budget.

CONCLUSION

Staff note the increasing number and quality of applications to the Project Grants program. The grant review committee was particularly challenged to allocate the balance of the Project Grants budget, given the demonstrated growth in the sector and the demand on the budget. As such, several recommendations do not adequately meet the requested amounts and at times, only portions of projects could be recommended for support. Several of these successful project applicants may be eligible to apply for supplemental assistance arising from the \$1M increase to the Cultural Grants budget in 2005, subject to Council approval of the City Creative Task Force recommendations which have been forwarded to Council under a separate report.

The Crafts Association of British Columbia (CABC) is a non-profit arts service organization. Its mandate reads: "The Crafts Association of British Columbia is a network of craft professionals dedicated to the development of excellence in crafts." The CABC fosters and supports the creation and promotion of fine craft by providing programs and services to the crafts community and to the general public. It coordinates educational opportunities, maintains a Resource Centre & Library, offers awards scholarships, operates a gallery and retail outlet, and keeps the community abreast of current practices, issues and opportunities pertaining to craft via a newsletter, resource guide, and a website. The majority of the CABC's programs and services take place in Vancouver, where 155 or 35% of its 450 members reside. A total of 276 or 66% of CABC's members live in the Lower Mainland. 2005 projects and activities include:

- a) 10 contemporary fine craft group and solo exhibitions featuring emerging and established craft artists working in wood, glass, jewellery, fibre, and ceramics. 16f these craft artists live in Vancouver.

Incorporated in 1990, Felix Culps is a Vancouver-based theatre company which produces original works and provocative plays from the world repertoire. The company is known for vibrant, intelligent productions that deal with difficult subject matter in unexpected ways. Recent productions include Colleen Wagner's Governor General's Award winning play The Monument, the North American premiere of Howard Barker's Und, and the acclaimed The Designative Monument by Wallace Shawn. Our productions also include benefit performances for different charities, including fluidrainers last year for both the Literacy Program at the Carnegie Centre in the Downtown Eastside, and for the Rad Cross relief efforts in the Sudan. In April of 2004, Felix Culpa received a special award in recognition of our creative fluidrainers for the Canadian Red Cross relief efforts during the early days of the Iraq war.

This coming season we will be laying the groundwork for the long-awaited production of Revenge, David Bloom's adaptation of the Jacobean play The Revenger's Tragedy. We will also be developing a new play with Touchstone Theatre (working title: The Poetry of Public Life), and planning an international theatre festival and symposium entitled Back to the Source.

The final stage of development work on Revenge is being completed this season. During this time the work will be exposed to the public, including a staged reading as part of Playwrights' Theatre Centre's New Play Festival in May 2006. The Poetry of Public Life is a new script created from the public utterances of Canadian political figures, presented in a highly stylized and dynamic theatrical form, thus combining the company's fascination with language with an ongoing investigation of the social and political fabric of modern life.

A flows of this coming season is the floatering of important creative partnerships. Revenge is a co-production with Theatre at UBC stated for the 2006/2007 season, with development support by Playwrights' Theatre Centre and the Langara Research Council. The Poetry of Public Life is being developed with Touchstone Theatre. The Back to the Source international theatre conference will present both academic and practical lectures, readings and workshops in association with UBC and other local institutions.

In addition to the work listed above, though not within the scope of this grant request, we will present two evenings of theatre as a fund-raiser for the immigrant services organization MOSAIC.

From 1989 to today, Flamenco Rosario has been Vancouver's only provider of professional Spanish dance presentations. Artistic Director Rosario Ancer offers audiences annual productions in three distinct forms: 1) Cuadro Flamenco (cafe-style flamenco), 2) classical and traditional Spanish dance, and 3) contemporary cutting-edge mainstage productions. Every performance is supported by live music led by Music Director Victor Kolstee. Performances by Flamenco Rosario are among the rare presentations that appeal to both dance and music audiences.

As one of Canada's best professional Spanish dance companies, Flamenco Rosario is proud to perform for Vancouver audiences. All of the company's activities are met with a warm and enthusiastic response; the most often heard comments are: "This is the best show yet!" and "I always look forward to your shows because you always surprise us — you always give us something different!" Our recent highly successful seasons have featured sell-out or near-capacity crowds (our average annual Vancouver audience of 2500 to 3000 is second only to Ballet British Columbia). We also have a very culturally diverse audience including the Latino, Japanese, East Indian, Middle Eastern, and other Asian constituencies.

We are requesting funding for one project. GUADALQUIVIR will be produced on November 11, 12 and 13, 2005 at the Norman Rothstein Theatre. Named for the most important river in Andalucia, Spain, the audience will be invited to take a journey with Flamenco Rosario to see new and traditional dance works inspired by the river and the different regions that it touches. These dances will include Tarantas, Serranas, Tangos, Sevillanas, Trianas, Fandangos, Rocieras, Bulerias and Tanguillos. This performance will feature new Canadian choreographies by Artistic Director Rosario Ancer, flamenco guitar by Musical Director Victor Kolstes, dance by renowned Spanish guest star Antonio El Pipa, and song by young Spanish singing sensation Manuel de Tane.

Screaming Flea Theatre is a non-profit society that produces original Canadian work as well as published plays that may live in obscurity. Our founding members are alumni of the BFA Theatre program at Simon Fraser University. We have worked together for over eight years, developing a style of creation and performance inspired by the methods of well-known Theatre artists such as Tadashi Suzuki, Anne Bogart, and Jerzy Grotowsky, to name but a few.

The project for which we are requesting a City grant is a production of a published, full-length Canadian play, entitled Fragments Of A Farewell Letter Read By Geologists, by Montreal playwright, Norman Chaurette. Fragments will open in August 2005 at a site-specific venue in downtown Vancouver and run for a period of two weeks. We have already received an Emerging Artist grant from the Canada Council, and have applied for a BC Arts Council grant last month.

Following this production, we intend on participating in the 8th annual Theatre Under The Gun festival, held every fall at the Vancouver East Cultural Centre. Theatre Under The Gun is a great opportunity for local emerging companies to work side-by side while creating short 15minute pieces of Theatre in 48 hours, drawing on 'inspiration packages' provided by the other companies. This will be our fourth consecutive year at the festival.

In the spring of 2006, we intend to participate in the See Seven Theatre Festival. This is an annual festival that showcases local emerging and established companies who have a mandate to produce challenging, and experimental work. The festival has been in existence for over eight years. We hope to gain valuable insight from the more established companies in this festival in terms of administration and promotion of our own organization. This experience will teach us about how to plan a season of Theatre, and how to execute this plan in an efficient and artistically sound fashion. Our See Seven production will be an original full-length play. We will be developing a fifteen minute play that was first created for the Theatre Under the Gun Festival 5 in 2002. Our initial performance of *Tie The Knot* at the Cultch was well received. From our discussions with audience members after the show we decided the play's content resonated with the audience in a way that warranted further exploration of its themes.

Established in 1992 and incorporated in 1998, we are a company of rebellious theatre professionals who choose and mount our own productions on original and important themes. Following our artistic mission statement, we search for works that provoke a deeper understanding of women's past, present and potential. In serving this mission our company produces established scripts and creates new plays collaboratively for our audiences in North America.

Below is our current and proposed projects for the next twelve months.

Spin Girl Phase 2: Spin Girl is a revised version of Woman Idiot Lunatic Criminal produced by shameless hussy in 2001. The original title was taken from legislation describing people who were not allowed to vote. The show presented a series of vignettes from the history of the suffragettes with lively music. It was well received.

When we realized how little teenagers knew of this history, we developed a new version called *Spin Girl*, with funding from Canada Council for the Arts and the Hamber Foundation. *Spin Girl* tells the story of a female DJ who gets inspiration from her grandmother's old pictures of the days when Granny was an active suffragette. These pictures come alive, with the use of video, and suck our spin girl into the past, giving her an up close and personal education in the suffrage movement.

We propose to turn Spin Girl into a full-scale professional production designed to make the story of women's suffrage relevant to today's teenagers. This project will proceed in orderly stages to improve the Spin Girl script, get professional and technical advice, and produce a video.

- 1 Summer 2005 workshop with professionals, review evaluations and make revisions

- 3 Fall 2005 workshop revised script for a selected school audience
- 4 Fall 2005 incorporate student evaluations into the Spin Girl script

Solo Collective is a Vancouver-based theatre company that specializes in commissioning, developing and producing original work by Western Canadian playwrights. In operation since 1999, we have now premiered 17 new pieces by 13 writers. Our productions have received a number of Jessie Richardson Theatre Awards and nominations for writing, acting and direction, including nominations each year for our playwrights. Most recently, Amiel Gladstone received the Outstanding Original Script Jessie for last year's Lena's Car. All of our scripts except one have been monologues.

We employ professional actors, directors and stage managers under the "Independent Theatre Policy" of CAEA, and commission either professional writers or those who are making the transition from another discipline such as acting, directing, or poetry writing. We are an Associate Member of the Greater Vancouver Professional Theatre Alliance and a long-standing participant in See Seven, Vancouver's highly successful subscription package for independent theatre. In 2004, Solo Collective was granted designation as a Registered Charity.

After six seasons of producing monologues, we're now planning to expand our scope to producing full-length, multi-character plays. Both the company and the artists we work with need this growth. This Project Grant application is for the development and production of Landscapes of the Dead, our planned full-length production for 2005/06. Other activities for the coming year include the 2005/06 Emerging Writers' Program as well as the development of the full-length play All the Dead Voices, and three new monologues, for production in 2006/07. Together, these activities represent a "three-tiered" approach to working with Solo Collective: from our Emerging Writers' program to monologue commissions to full-length plays. This structure allows for development of the writers and of the producer/writer relationship. Not all writers we work with will come via this route, and not all our Emerging Writers will wind up being commissioned. But this approach gives us, and the writers who want to work with us, a starting place and a clear methodology.

We are also planning a Professional Development initiative for 05/06 to upgrade staff's skills in graphic/web design, bookkeeping, and administration. The cost of this program is reflected in the operating budget.

Theatre In the Raw is a grassroots theatre company that has been in operation for over 11 years. We have produced over 160 Original One-Acts, 13 Radio Plays and 9 mainstage productions. We are a theatre company that provides an open, creative, and supportive atmosphere for struggling artist and gives exposure to tried and untried playwrights.

Our proposal is to offer Vancouver and outlying communities a series of One-Acts plays and Radio scripts to be given live staged performances before audiences; as well as broadcast on the air, with the background theme: original Multicultural BC Myths for the spring/summer of 2006. The Turning Point Ensemble is a large-sized chamber ensemble (15-25 musicians) with a mandate to broaden the appreciation and understanding of concert music composed during the past hundred years, linking the music of earlier times to the music of today. The ensemble champions deserving works of Canadian composers, especially those who live or at one time resided in British Columbia, and places them in context with their international peers. We are also excited to collaborate with artists and thinkers of other disciplines and reach out to diverse audiences. Some of our 2004/5 collaborative partners included the Vancouver Art Gallery, the University of British Columbia, The Canadian Music Centre, Vancouver Pro Musica, and the Association of Canadian Women Composers. We will also be touring out of province in September 2005, with special guest Judith Forst, performing the music of long-time Vancouver resident composer Barbara Pentland (1912-2000), with concerts in Ontario and Manitoba.

Vancouver audiences gain a new appreciation for local talent through seeing Vancouver artists in tandem with prominent national and international artists. Networking with national and international artists and presenters enhances the touring opportunities for Vancouver artists and heightens the profile of Vancouver in the international dance community. A unique feature of the VIDF is that nearly half of the presentations are free to the public.

In 2006, the VIDF will take place March 7 - 25 at the Roundhouse Community Centre and will again feature established and emerging Vancouver dance artists together with renowned national and international dance companies. The VIDF will also feature exhibitions of dance related painting and photography as well as daily drawing sessions for artists using dancers as models.

The Vancouver Society of Storytelling was incorporated as a not-for-profit organization in 1991. Since that time, the VSOS has presented thirteen annual storytelling festivals as well as a range of other events; it has also produced the storytelling and music 3 CD set: How Music Came to the World. in 2000-2001, the VSOS incorporated Cric? Cracl, a monthly storytelling swap, which had been in existence independently, into the organization. In 2002, Cric?Cracl North Shore was inaugurated with monthly events as well. For 5 years, VSOS has been producing an annual Epic weekend where an epic poem from a particular culture is performed over a weekend. Contacts with the various cultural communities form part of the experience. The VSOS produces a newsletter 3 times per year sent to all members. The society currently operates with a 9 member Board of Directors, part time and contract staff and has a membership of approximately 200.

In mid- November 2004, the VSOS presented the 13th Annual Vancouver International Storytelling Festival. Festival 2004 featured 80 tellers many of them having emigrated from the Middle East. The festival also featured stories of small town Canada, Women's Stories, those of Children Around the World and other tales to enchant the listener. All of the artists came from the Lower Mainland, other parts of Canada, and the US. This approach offered us opportunities to connect with a new cultural community and to make use of Artistic Directors to help with programming. This festival did not benefit us financially, however, and we have lessons to learn from this experience.

Plans for 2005 include the presentation of the 14th Annual Vancouver International Storytelling Festival (Nov. 3-5, 2005). This festival will be smaller than previous ones but no less inclusive. Our intention this year will be to refocus and streamline the artistic structure, production and promotional aspects in order to return to a financially viable festival. This year the VSOS returns to its roots in many ways. The theme: Storyquest in the Northwest-focuses on myths that surround us in our lives whatever our cultural tradition. Wen Wei Dance Society was formed in 2003. The mandate of the company is to create dance performance events for the general public that honestly reflect the personal style and voice of Chinese Canadian choreographer Wen Wei Wang; to teach workshops and other educational activities in dance; and to cooperate with other organizations that share the Society's values.

Artistic Director Wen Wei Wang was born in mainland China, where he trained and performed as a professional dancer. He spent 12 years in Canada as a professional dancer, teacher, and choreographer before forming Wen Wei Dance Society. The Society supports creative projects that are informed by the artistic director's experience living and dancing professionally in two cultures and his interest in the multicultural society in which he now lives. Wen Wei Dance offers a fresh voice in dance, one that is inspired by our evolving Canadian cultural context, which is made up of many experiences from many cultures. The long-term goal of Wen Wei Dance is to develop the infrastructure necessary to sustain an on-going operation and undertake international exchange and touring projects.

Wen Wei Wang has been commissioned by CanDance (The Canadian Network of Dance Presenters) to create a major new work to be premiered at the Canada Dance Festival in Ottawa, June 2006, followed by a featured performance as part of Dancing on the Edge in Vancouver in July, and a tour of major theatres across Canada in fall 2006.

Wild Excursions Performance is a physical-theatre company whose artistic purpose is to research, develop and present performance works in which movement and original or adapted text are meaningfully inter-related. Our productions range from works that are text-based (with a significant movement component) to pieces that are dance-based (but traverse the borders with theatre) to plays from the standard repertoire staged in innovative ways. The work explores issues concerning relationship, gender and power, as well as the nature of the performance event itself. The company also specifically addresses subjects concerning gay male experience. Actors and/or dancers are hired, depending on the nature of the project. Founded in Vancouver in January of 1995, Wild Excursions has enjoyed considerable success over the years, establishing an enviable reputation locally and nationally for high artistic achievement and integrity. Among others, the company's major works included *The Wines of Tuscany*, which toured across Canada and received numerous awards; and *Dance, Little Lady*, a satirical cabaret about women, dance and the patriarchy. The grants can be applied to a specific project or toward the costs of several initiatives planned within a year of the application deadline.

General Eligibility Criteria

All applicants for Project grants must meet the following criteria:

0	An applicant should be registered as a non-profit society in British Columbia and active for at least a year. Groups that have been active for a year, and have applied for, but not yet acquired, registered society status, may be able to apply under the auspices of an existing non-profit cultural organization willing to act as a sponsor. Details must be discussed with OCA staff at least a month before the application deadline. All such applications must be signed by both parties and also include a sponsorship agreement between the parties.
	Project grants are not available to organizations that receive operating funding from the City in the form of Theatre Rental, Operating or Major Exhibiting Institution grants.
0	The grants are available to arts organizations engaged in creation, production, presentation or exhibition activities related to the performing, visual, literary or media arts. All applicants must have professional artistic leadership and administration, and must pay principal artistic contributors for their services in accordance with generally accepted professional standards. Eligible activities include creative collaborations between professional artists and community members (see Specific Grant Criteria section).
	Service organizations with designated administrative staff and a mandate that provides for a range of services to professional artists and/or non-profit arts organizations based in Vancouver may also be eligible for Project funding (see Specific Grant Criteria).
-	Cultural grants are not available to civic departments or branches (e.g. libraries or community centres). Nor are they intended for social service, religious or sports organizations. Educational institutions (schools, colleges, etc.) do not qualify for cultural grants, but "stand-alone" arts organizations that provide professional and preprofessional training for children and youth may be eligible for assistance with the costs of public presentations (see Specific Grant Criteria).
	Applicants must be based and active in Vancouver. Projects must take place in Vancouver (not in other Lower Mainland municipalities or University Endowment Lands), be open to the public and be publicized city-wide.
	Applicants must receive revenue from several sources other than the City of Vancouver. These may include ticket sales, memberships, donations from individuals or businesses, in-kind contributions or support from foundations and other government funders.

Process

There are two Project grant deadlines: one in December and one the following May. Staff from the Office of Cultural Affairs review the grant applications and, conduct interviews with applicants as appropriate. Following the review process, recommendations are made by a staff committee and presented to City Council. Written notice of these recommendations is sent to all applicants, together with information about the Request for Reconsideration process, and notice of the Council meeting at which the grants will be considered. Under normal circumstances, successful applicants generally receive grant payment within two and a half weeks of Council's approval.

Ineligible Activities Given budget limitations, some activities are simply beyond the scope of this grant program, regardless of their merit. The following activities do not qualify for Project grants: club or community centre programs travel and tours outside Vancouver contests and competitions creation and production of films, recordings, П conferences books or magazines workshops, courses and other forms of training capital projects scholarships **Specific Criteria** Additional guidelines apply to service organizations, performing arts facilities, training organizations, and artist and communities projects, which must also meet the general eligibility criteria for Project grants. Service Organizations: Organizations whose main objective is to support the development of one or more art forms through a range of services to professional artists and/or non-profit arts organizations may qualify for Project assistance. Guilds, trade unions, and professional associations are not eligible. To qualify, an organization must: Have designated administrative staff and a high standard of professionalism in its operations Have a membership that is broadly representative of its mandate and that includes artists and/or non-profit organizations based in Vancouver Provide a range of services and resources for members, including a number of the following: research and information, advocacy, human resource development, administrative services and audience development Performing Arts Facilities: Professionally equipped performing arts facilities zoned for public assembly and managed by independent non-profit arts organizations may qualify for Project funding. Clubs, schools, churches or community/cultural centres are ineligible. To qualify for a grant, a facility must: Provide a professional level of facility services (box office services, technical equipment, etc.) Provide a balance of curated arts programming and presentations that involve multiple users, not just one or two resident companies Provide equitable rental access to Vancouver's artists and arts organizations at reasonable rates Primarily serve professional artists and arts organizations Engage in ongoing umbrella marketing Training Organizations: "Stand-alone" arts organizations whose primary mandate is to provide professional quality training for children and youth may be eligible for assistance with the costs of annual public presentations (but not with training costs). The following eligibility criteria apply: Only professionally directed/curated public performances and exhibitions (not including competitions) qualify for assistance Work must be created and/or performed by children and youth Activity must take place in a facility regularly used by professional artists in accordance with accepted professional presentation standards (e.g. technical support and paid admissions) Only costs directly related to artistic presentation and promotion activities are eligible Artist and Communities Projects: Arts organizations can apply for Project grants to assist with the costs of

Artist and Communities Projects: Arts organizations can apply for Project grants to assist with the costs of partnerships between professional artists and community members engaged in a collaborative creative process that will result in the public presentation of art expressing community interests and issues. In addition to the general evaluation criteria for Project grants, this type of proposal will be evaluated for:

Clear articulation of the artistic and community interests/issues the project will address
Strength of the proposed collaborative process between artist(s) and community participants
Artistic merit of the artist(s)' previous collaborative work
Overall merit of the project as a vehicle for collective experience and public expression
