2005/06 Theatre Rental Grants

#### RECOMMENDATION

- THAT Council confirm its previous approval in principle of rental grants to 13 A. organizations for use of the Civic Theatres in Spring 05, including adjustments to four grants to reflect reduced actual use, for a total of \$903,910, as listed in Table 1; source of funds to be the 2005 Theatre Rental Grants budget.
- THAT Council approve 11 rental grants totalling \$744,690 for uses of the Civic В. Theatres in Fall 2005, within base levels or reserve uses, as listed in Table 2; source of funds to be the 2005 Theatre Rental Grants budget AND THAT subject to approval of the 2005/06 Theatre Rental Rates Report (RTS#5275), an additional \$51,525 be provided in grants to offset the cost of the increase rental rates; source of funds to be the 2005 Theatre Rental Grants budget.
- THAT Council approve, in principle, 12 rental grants totalling \$1,067,763 for C. uses of Civic Theatres in Spring 2006, within base levels or reserve uses, as listed in Table 2, subject to the 2006 Operating Budget Review process.
- THAT Council approve a grant of \$100,000 to the Vancouver Symphony Society D. to offset the rent payable under the lease with Civic Theatres for the period of January 1 to December 31, 2005; source of funds to be the 2005 Theatre Rental Grants budget.

#### **GENERAL MANAGER'S COMMENTS**

The General Manager of Community Services recommends approval of the foregoing.

#### **COUNCIL POLICY**

In 1979 and again in 1983, City Council affirmed the principle that Theatre Rental Grants are available to cultural organizations that use the Civic Theatres annually and have been assigned annual "base level" uses of the Civic Theatres by Council.

Council approved the current process for Theatre Rental Grants in 1995, providing for seasonally based grants allocated in July of each year for the coming "Fall" (the second half of a given year) and "Spring" (the first half of the following year). Recommendations for Spring of the following year are approved in principle, subject to the Operating Budget Review for that year:

Council policy provides for an increase in the annual Theatre Rental Grants budget to accommodate the impact of increases in the Civic Theatre rental rates on rental grants provided after September 1<sup>st</sup>, when new rates go into effect.

On September 12, 2000, Council approved the establishment of a "reserve pool" of theatre rental uses to assist established performing arts organizations that do not have designated "base level" uses of the Civic Theatres. Reserve uses may also be applied to additional uses by regular Theatre Rental Grant applicants.

Approval of grant recommendations require eight affirmative votes.

#### **PURPOSE**

In accordance with the process Council established in 1995, this report recommends:

- confirmation of Spring 2005 rental grants approved in principle on July 20, 2004;
- Theatre Rental Grants for the 2005/2006 season; and
- a grant to cover the Vancouver Symphony Society's lease of office space in the Orpheum.

#### **BACKGROUND**

### Spring 2005 Grants

The Theatre Rental Grants budget for 2005 is \$1,892,000 which includes the \$100,000 annually designated for the VSO's office space rental in the Orpheum. From this budget, staff recommend that the 13 Theatre Rental grants for Spring 2005, which were approved in principle by Council last year, be formally approved in the amount of \$903,910. This amount provides for decreases in the grants to the Vancouver Bach Choir, the Vancouver Opera, the Vancouver Playhouse and the Vancouver Symphony to reflect actual uses (Table 1).

Confirmation of these grants will leave an unallocated balance of \$888,090 in the 2005 Theatre Rental Grants budget, the allocation of which is discussed later in this report.

#### Reserve Uses

While the core group of not-for-profit organizations with base level uses has remained stable in recent years, their actual uses of the Civic Theatres varies. In 2000, Council approved the transfer of "surplus" base uses to a "reserve pool" of rental grant uses for performances by frequent users of the theatres that have not been assigned base uses because they have not had a long-term, consistent level of annual performances. As a second priority, the reserve may also be used to provide regular Theatre Rental Grant applicants with additional performance uses over their base levels.

The reserve pool gives the City greater flexibility in responding to shifting patterns of use among applicants. Grants from the reserve are subject to available funds, and do not cover rehearsal uses. At present the reserve provides for up to four uses of the Orpheum or Queen Elizabeth Theatre, and up to seven uses of the Vancouver Playhouse Theatre.

#### Requests for 2005/06

For the 2005/06 season, 14 theatre rental grant requests totaling \$1,776,135 have been received, as listed in **Appendix A**. These include a request over base levels from Ballet BC, the Vancouver Opera, a request for a "holdover" week from the Playhouse Theatre Company, and requests for reserve uses from two applicants without base levels.

#### DISCUSSION

Vancouver Symphony Society Lease

On October 24, 1989, Council approved the lease of the Orpheum basement to the VSO for offices. The annual rent was set at \$100,000, to be offset by a City grant in the same amount. This arrangement allows the society to use the City contribution as leverage in its fund-raising efforts. The lease has been renewed annually, subject to approval of the grant from the City.

Staff recommend that this lease be renewed for the period of January 1 to December 31, 2005 inclusive, and the rent for the period be set at \$100,000. It is further recommended that a grant of \$100,000 be approved to cover the lease cost; the source of funds to be the Theatre Rental Grants category of the 2005 Cultural Grants budget.

As summarized in **Table 2**, 11 grants totaling \$744,690 are recommended for Fall 2005, and 12 grants totaling \$996,605 are recommended in principle for Spring 2006, subject to an additional \$51,525 for Fall 2005 and \$71,158 for Spring 2006 being provided if the proposed 2005-06 Theatre Rental Rates are approved by Council. These recommendations are within base levels and utilize 5 of the 11 reserve uses available.

Details on each application are provided in **Appendix B** which consists of the front pages of the applications, with staff comments and recommendations.

\*\*An additional \$51,525 for Fall 2005 and \$71,158 for Spring 2006 in grant funding will be required to offset the increase rental rates if the proposed 2005-06 Theatre Rental Rates are approved by Council. Therefore the total requirement for Recommendation B for Fall 05 is \$796,215 and Recommendation C for Spring 06 is \$1,067,763, subject to Council Approval.

#### FINANCIAL IMPLICATIONS

Council policy provides for an increase in the annual Theatre Rental Grants budget to cover the impact of increases in the Civic Theatre rental rates on rental grants for Fall of a given year, when the rates are implemented. The adjustment is only made if the request level in any given year requires a budget increase.

The approved 2005 Theatre Rental Grants budget was \$1,892,000, and following Council confirmation of Spring 2005 grants (Recommendation A), and approval of the lease-related grant to the VSO (Recommendation D), the balance in the 2005 Theatre Rental Grants budget will be \$888,090. For Fall 2005, the cost implications of the proposed 2005/06 rental rates increase on the rental grants is \$51,525 and staff propose that this increase be absorbed within the existing grants budget, due to an unusual year for some of the Prime Performers where fewer than normal uses were used. Therefore the total Fall 2005 allocation is \$796,215 (Recommendation B) leaving an unallocated balance of \$91,875.

The proposed rental rate increase has a cost impact of \$71,158 on the Spring 2006 grant allocation and therefore Staff are recommending that \$1,067,763 be approved in principle for Spring 06, subject to the 2006 Operating Budget Review process.

A balance of \$91,875 in Fall 2005 could accommodate the rental rate increase impact of \$71,158, however these funds cannot be carried forward to offset the shortfall. Instead, staff are proposing to re-allocate on a one-time basis, up to \$75,000 of the remaining balance of the 2005 Theatre Rental Grant budget to a new theatre rental grant program to replace the now defunct Baxter Fund which is detailed in a companion report *City Creative Task Force Planning Process & Allocation of Increase to 2005 Cultural Grants Budget* scheduled for Council Committee on City Services and Budgets July 21st.

#### CONCLUSION

In keeping with the process approved by Council in 1995, this is one of two reports dealing with Theatre Rental Grants for the 2005/06 season. Recommendation C, which relates to Spring 2006 grants, will need to be reconfirmed by Council next year after the 2006 Theatre Rental Grants budget is approved and the actual uses are confirmed.

Ballet British Columbia (BBC), established in 1986, is a contemporary ballet company of professional, soloist-caliber dancers. BBC commissions, purchases, and remounts ballets that it performs to a consistently growing audience in the city. In addition BBC is a presenter of dance in Vancouver through its danceAlive! series. danceAlive! is comprised of four or five programs that include 3 Ballet British Columbia presentations and one or two other presentations featuring national and international ballet companies of artistic excellence. BBC is also engaged in collaborations with several other arts organizations, participates in community and school outreach performances and programs, provides a unique educational opportunity for pre professional ballet dancers through its mentor programme and new Summer Dance Intensive, which is run in collaboration with Arts Umbrella. Beginning in 2000, BBC has increasingly invested in the creation process by commissioning full-length and theme ballets with extensive, quality production values for its audiences. Our subscription numbers have consequently increased and we consistently exceed our single ticket sales and revenue goals for the company's fall, winter and spring performances at the Queen Elizabeth Theatre.
