BUSINESS LICENSE HEARING MINUTES

JULY 19, 2005

A Business License Hearing of the Council of the City of Vancouver was held on Tuesday, July 19, 2005, at 7:30 p.m., in the Council Chamber, Third Floor, City Hall.

At the Regular Council meeting immediately following the Standing Committee on Planning and Environment meeting on July 14, 2005, Vancouver City Council approved the following:

A Business License Hearing of the Council of the City of Vancouver was held to determine:

- whether or not the 2005 City of Vancouver business license granted to Nasser Sakiani doing business as Rose Food Market (the "Licensee"), for business premises located at 927 Seymour Street, Vancouver, British Columbia (the "Premises") should be suspended or revoked; and,
- to determine whether or not a 2005 City of Vancouver business license should be issued to Sima Sakidezfuli and/or Milano Market Ltd. (the "License Applicants"), for business premises located at 927 Seymour Street, Vancouver, British Columbia (the "Premises").

Catherine Kinahan, Law Department, was present on behalf of the City of Vancouver. Mr. Sakiani was not present to make representation although he had been notified well in advance that a hearing would be taking place. The Licensee's lawyer had written a letter to the City indicating Mr. Sakiani did not wish to make any representations regarding his license for the premises. Ms. Kinahan advised Mr. Sakiani had not surrendered his license and therefore the Panel would have to make a decision on whether to suspend or revoke his license. Ms. Kinahan also advised Ms. Sakidezfuli, the License Applicant, was present and that the Applicant was the wife of the Licensee. Ms. Kinahan advised that the evidence to be called was relevant to both the existing license and the license application, and the Panel could make rulings in regards to both issues at the hearing.

Ms. Kinahan advised the matter had been referred to City Council by the Chief License Inspector pursuant to section 278 of the *Vancouver Charter*, and section 277.1 of the *Vancouver Charter* which confers on Council the authority to delegate the holding of business license hearings to one or more Council members.

Ms. Kinahan referred the panel to evidence before it as set out in documents which were considered by the Chief License Inspector in suspending the license, and the evidence of witnesses, which set out allegations that the Licensee and the License Applicant had failed to properly manage the Premises in the past by:

- (a) carrying on business to the detriment of the safety and well-being of the public;
- (b) creating unfair competition for local business which operate in a legitimate manner, by purchasing and re-selling stolen property;
- (c) unlawfully keeping for sale or selling or giving liquor to persons on the Premises without a license, in contravention of the *Liquor Control and Licensing Act*;
- (d) selling tobacco to minors, in contravention of the *Tobacco Sales Act*; and
- (e) selling tobacco that does not bear the prescribed mark or stamp indicating that tax imposed on the tobacco has been accounted for, in contravention of the *Tobacco Tax Act*.

Ms. Sakidezfuli also asked questions of the witnesses.

Ms. Sakidezfuli submitted that she is currently separated from her husband, and that she had no idea her husband was involved in illegal activities at the store. She requested Council grant her the business license to give her a new start. She promised nothing bad would happen in the store in the future should she be granted a license.

Ms. Sakidezfuli then responded to questions from Panel members and Counsel for the City of Vancouver regarding her knowledge of the presence of stolen property in the store, the testimony that she had ordered property from an undercover officer, the sale of drug paraphernalia, including crack pipes, brillo and hypodermic syringes, and the issue of whether she, or Mr. Sakiani, had applied for a new PST number in order to circumvent a 6-month Provincial tobacco license suspension.

PANEL MEMBERS DISCUSSION

Prior to making a decision, Panel members indicated concerns about the timing of the applications by Ms. Sakidezfuli for a new business license and a new PST number, which appeared to be an attempt to avoid responsibility for the consequences flowing from the history of poor management of the store. The Panel was also concerned about whether or Ms. Sakidezfuli was truthful in claiming that she was no longer associated with Mr. Sakiani. The Panel questioned the credibility of the License Applicant and indicated that Council had an obligation to the neighbourhood from the impact of this business, which had facilitated the activities of drug dealers and addicts. Finally, the Panel indicated support for Ms. Sakidezfuli's attempt to make a new start and advised that if she were to disassociate herself from Mr. Sakiani and from this neighbourhood, there was a possibility of her receiving a business license for another location in Vancouver in the future.

MOVED by Councillor Louie

- 1. THAT the 2005 Business License issued to Nasser Sakiani doing business as Rose Food Market (the "Licensee") for business premises located at 927 Seymour Street, Vancouver, British Columbia (the "Premises"), be revoked because the Licensee has failed to properly manage the premises by:
 - a) carrying on business to the detriment of the safety and well-being of the public;

- b) creating unfair competition for local business which operate in a legitimate manner, by purchasing and re-selling stolen property;
- c) unlawfully keeping for sale or selling or giving liquor to persons on the Premises without a license, in contravention of the Liquor Control and Licensing Act;
- d) selling tobacco to minors, in contravention of the Tobacco Sales Act; and
- e) selling tobacco that does not bear the prescribed mark or stamp indicating that tax imposed on the tobacco has been accounted for, in contravention of the *Tobacco Tax Act*.

FURTHER THAT any future business license applications submitted to the City of Vancouver by Nasser Sakiani be referred to Vancouver City Council by the Chief License Inspector.

- 2. THAT the application for a 2005 Business License by Sima Sakidezfuli and/or Milano Market Ltd (the "License Applicant") for business premises located at 927 Seymour Street, Vancouver, British Columbia (the "Premises"), be refused because the License Applicant has failed to properly manage the premises by:
 - a) carrying on business to the detriment of the safety and well-being of the public;
 - b) creating unfair competition for local business which operate in a legitimate manner, by purchasing and re-selling stolen property;
 - c) unlawfully keeping for sale or selling or giving liquor to persons on the Premises without a license, in contravention of the *Liquor Control and Licensing Act*;
 - d) selling tobacco to minors, in contravention of the Tobacco Sales Act; and
 - e) selling tobacco that does not bear the prescribed mark or stamp indicating that tax imposed on the tobacco has been accounted for, in contravention of the *Tobacco Tax Act*.
