1. 2006 - 2008 Capital Plan Draft Allocation (File 1611)

Vancouver City Council, at its meeting on June 28, 2005, received a Report Reference on staff recommendations regarding the 2006 - 2008 Capital Plan and referred this matter to a Special Meeting of City Council on September 13, 2005, in order to hear from members of the public.

Accordingly, Council had before it the following:

- a) Extract from the Regular Council Minutes June 28, 2005; and
- b) Administrative Report dated June 20, 2005.

Brent MacGregor, Deputy City Manager, and Ken Bayne, Director of Financial Planning & Treasury, provided an overview of the 2006 - 2008 Capital Plan Draft Allocation, reviewed the capital plan priorities and the planning process.

The following urged Council to include in the 2006 - 2008 Capital Plan the \$13 million requested by the Vancouver Public Library for the proposed DTES/Strathcona Branch Library:

Comments provided by the foregoing speakers included the following:

- the Vancouver Public Library Board and Friends of the Vancouver Public Library urge Council to include the full funding needed for the DTES/Strathcona Branch Library;
- a full service branch in this neighbourhood would offer families and individuals of all ages and backgrounds free, equal and fair access to the information and resources housed within the library;
- people in this neighborhood are enthusiastic about getting a new library because many residents don't drive either by choice or circumstance so having a full-service local library is critical;
- the Strathcona neighbourhood is the only one which has no facilities such as a library, skating rink or pool; we would take a library with a leaky roof any day, just give it to us;
- there has to be a creative way for the city to come up with the funds for this library; and
- a full-service library in the Strathcona neighbourhood would be a great anchor tenant to help revitalize the area of East Hastings Street near Strathcona School.

Comments provided by the foregoing speakers included the following:

- ask that Council allocate funds to save Mount Pleasant Pool and keep this resource which has been in the community for nearly 40 years; have 5,420 signatures on a petition representing the goal to save this pool;
- one memory that sticks out, growing up in the 60's, is the time spent at the neighbourhood outdoor pool - want to see other children have the same; most of the neighbourhood outdoor pools are closed and now Sunset and Mount Pleasant are the only ones still open - it's not too late to save Mount Pleasant Pool;
- envision creating a full Aquatic Centre at the Mount Pleasant Community Centre site; why do we have to leave Vancouver when our kids want to have fun in the water?;
- demolition of the Mount Pleasant Community Centre will have a huge impact on Simon Fraser Elementary School as this centre has child care facilities used widely by the students of the school; urge Council to allocate specific funds for a new facility that contains all the existing services;
- demolition of this facility will result in the loss of 200 child care spaces and currently all
 these spaces are full and there is a waiting list we want to ensure that sufficient funds
 are allocated to replace the existing facility with the new space which contains at the
 very least the same capacity as the current facility;
- we at Mount Pleasant Community Centre Association will have to shut our doors to all of the child care facilities and programs offered at the existing centre because the new centre won't offer the same; it's not sensible to tear down a recreation facility and replace it with green space; and
- a dysfunctional parks planning process has begun in this city and also within the civic government; it's absolute folly to demolish a building like this to create 4500 square feet of grass in an area that has lots of it already.

Comments provided by the foregoing speakers included the following:

- the present on deck change room was supposed to be a temporary solution but with all these cuts it has become what we are stuck with, there's no privacy, it's not safe and it gets drafty from the pool area which can provoke severe muscle spasms in some people with disabilities; would like to see a family change room that is totally accessible;
- call on Council to reinstate the Renfrew Community Centre upgrades back into the Capital Plan; this is one of the fastest growing communities with one of the largest numbers of children;

- the Renfrew/Collingwood community asks that the additional funds of 2.5 million be added to the Capital Plan for the required upgrades to the Renfrew Community Centre and change room renovation;
- urge that this program be put back on the Capital Plan the Renfrew Community Centre is not structurally sound;
- was involved with a project to make Renfrew Community Centre more child and youth friendly and the Vancouver Foundation provided \$48,000 towards this project but when we came up with the best renovation it was determined seismic work had to be done and the funds had to be returned - the youth were very disappointed and disillusioned.

The following expressed the need to include more funding in the 2006 - 2008 Capital Plan for the Vancouver Bicycle Network:

Comments provided by the foregoing speakers included the following:

- the Bicycle Advisory Committee recommends "THAT the cycling routes identified in the 1999 Bicycle Plan and in the 2001 Downtown Transportation Plan be completed by year-end 2008, at the latest, as a first step towards attaining a 10% cycling mode share and that funding be provided in the 2006 2008 Capital Plan to complete these routes (\$17 million) and for up-coming needs (\$3 million).";
- urge Council to increase investment in the bicycle network suggest \$10 m over the next 10 years; and
- if the goal of 10% mode share is met, there will be over a 140,000 trips per day or 51 million per year by bicycles, compared to the RAV line which is expected to be 100,000 trips per day the popularity of bicycle facilities more than justifies.

- request adequate capital funding to renew and expand aging community centres as it is essential to sustain a healthy, safe and prosperous city;
- urge Council to take appropriate steps to include full parks, recreation and legacy capital plan borrowing questions on the November 19th Civic Election; park statistics tell us visits to the city's 23 community centres exceeds 5 million per year;
- will vote against the November 19th referendum on this capital plan because the tax increases are not fair;
- urge Council and the Park Board to maintain the present allocation in this Capital Plan of 3 million for the redevelopment of Van Dusen Gardens - the new garden facility will allow us to contribute to the public significantly when the world is here in 2010;
- this Capital Plan should really be called the 2010 Capital Plan instead of focusing on gradual, continued improvements and the gradual growth of our parks, bike routes, pedestrian walkways and utilities, a lot is focused on completing projects for the 2010 Olympics;
- supplementing the Olympic Committee Fund for the Olympic curling venue, replacing Percy Norman Swimming Pool and getting new ice rinks at Killarney and Trout Lake make economic sense; however, many streets on the east side are not getting their share of funding and it is recommended a greater share be directed there;
- Trout Lake Community Centre is a beautiful location, comparable to Stanley Park, and this Olympic Legacy Fund will allow the upgrades to the centre and ice rink - lets use these funds properly;
- Council should request that the Park Board review and resubmit their Capital Plan to
 ensure more ice rinks are constructed in the city rather than demolishing then replacing
 existing facilities under the current proposal millions of taxpayer dollars will be spent on
 new facilities with no new ice rinks being built;
- we need more ice rinks in this city to allow our children to continue to grow and enjoy all the ice sports available to them;
- request a traffic signal at the intersection of West 49th Avenue and Southwest Marine Drive be included in the Capital Plan - installing this signal would address some of the problems there, provide a safe crossing for pedestrians and provide a break in traffic which would address the speeding issues; and
- the city's animal shelter needs a new building as a veterinarian have seen hundreds of people's lives changed due to animal companionship so why not provide the animals in need of shelter with a better environment in an updated facility which is more centrally located.

Messrs. MacGregor and Bayne, together with Piet Rutgers, Director of Planning & Operations, Park Board, responded to questions concerning points raised by the foregoing speakers.

Having heard from all the speakers on the 2006 - 2008 Capital Plan Draft Allocation, Council agreed to refer discussion and decision to the Regular Council meeting on Tuesday, September 20, 2005.
