### **REPORT REFERENCE**

1. 2006 - 2008 Capital Plan: Final Allocation (File 1611)

Brent MacGregor, Deputy City Manager, and Ken Bayne, Director of Financial Planning and Treasury, presented a Report Reference on the final allocation of the 2006 - 2008 Capital Plan

and referred to the Administrative Report *2006 - 2008 Capital Plan: Final Allocation* dated September 16, 2005.

Ms. Jami Koehl, representing the Mustel Group, presented the results of the public opinion survey undertaken by the Mustel Group seeking the opinions of Vancouver residents on Capital Plan options. Mr. Bayne reported on the results of the Capital Plan information flyer and questionnaire distributed to residents by the Vancouver Courier, the Chinese Language Ming Pao, and available on the City's website and in the City's libraries and recreation and community centres.

Also before Council was a letter dated September 20, 2005 from the General Manager of Parks and Recreation on Park Board Capital Plan allocations regarding pools.

MOVED by Councillor Green

- *A.* THAT Council confirm funding for the 2006 2008 Capital Plan as follows:
- \$135.57 million from plebiscite-approved borrowing authority
- \$74.43 million from Council approved Sewer borrowing authority
- \$ 54.87 million from Council approved Water borrowing authority
- \$55.60 million from Capital from Revenue
- \$ 33.57 million from City-wide DCL funding
- B. THAT Council approve the allocation of funding to specific programs and projects in the 2006 - 2008 Capital Plan as detailed in the "2006 - 2008 Capital Plan Draft Allocation" report considered on June 28, 2005 (summarized in Appendix A).
- *C.* THAT Council confirm additional funding from plebiscite borrowing authority of \$35 million above the financial limit of the 2006 2008 Capital Plan to allow the City to advance capital projects from future Capital Plans to take advantage of opportunities to access cost-shared funding from senior governments and the Vancouver Olympic Organizing Committee.
- D. THAT Council establish the Strathcona/DTES Branch Library is a priority project for the City and instruct staff to work with the Library Board to acquire an appropriate site and, once acquired, to report back with a development plan and, if necessary, an interim source of financing, that would see completion during the term of the 2006 - 2008 Capital Plan.
- E. THAT the Director of Finance be instructed to report back on October 4, 2005 with a financial plan to support the 2006 2008 Capital Plan, including the breakdown of funding between borrowed funds, revenue funds and City-wide DCL funds, and on proposed wording for the borrowing questions that will be submitted to the electorate during the November civic election.
- *F.* THAT Council encourages the Park Board to reallocate \$1.4 million of its allocation in the 2006 2008 Capital Plan for the completion of change rooms at the Renfrew Community Centre pool.

*G.* THAT Council encourage the Park Board to review options for keeping the Mt Pleasant outdoor pool open at least until completion of the proposed replacement for Percy Norman Pool at the new Hillcrest Centre and request the Board to report back on the additional costs that would be necessary in the Operating Budget.

AND FURTHER THAT staff explore the possibility of Simon Fraser Childcare facility remaining in operation in the existing facility and to report back on the feasibility and cost.

- 1. Commemoration of the Japanese Canadian experience during the Second World War (File 1051)

MOVED by Councillor Green SECONDED by Councillor Louie

WHEREAS Joy Kogawa's novel *Obasan* is one of the most powerful books ever written about the experience of Japanese Canadians during the Second World War;

AND WHEREAS the story of *Obasan* and its message about the consequences of war and prejudice are as relevant today as they were when the book was first released in 1981;

AND WHEREAS the house of *Obasan* still exists in Marpole, with the cherry tree that Joy Kogawa remembers as a child "propped up and bandaged, but still very much alive";

AND WHEREAS cherry blossoms have deep significance in Japanese culture, and are sometimes offered to other nations as a symbol of friendship;

AND WHEREAS, this year marks the 60th anniversary of the end of the Second World War in Asia;

THEREFORE BE IT RESOLVED THAT the City of Vancouver plant a cutting of Joy Kogawa's cherry tree on the City Hall campus in the fall of 2005 as a way to commemorate the experience of Japanese Canadians during the Second World War.

#### 2. Municipal Ticket Informations (File 1201)

WHEREAS the enforcement of some City bylaws is being complicated by current legal requirements that reduce their effectiveness;

AND WHEREAS a Municipal Ticket Information includes a summons to appear when a bylaw infraction ticket is issued;

#### THEREFORE BE IT RESOLVED THAT:

The General Manager of Community Services and the Director of Legal Services report back to Council on the practical, financial and legal implications of enacting a bylaw to permit Municipal Ticket Informations. The report would recommend which bylaw offences, such as the Anti-Fighting Bylaw, would be suitable for prosecution by Municipal Ticket Information.

3. Sewer Service Charge for Community Gardens (File 1755)

The following motion reflects an amendment to the Notice of Motion.

#### MOVED by Councillor Louis SECONDED by Councillor Bass

### WHEREAS:

- Community Gardens in Vancouver are neighbourhood amenities that provide a valuable public service while contributing significantly to the City's environmental sustainability goals;
- 2. At least 18 Community Gardens are located on property owned by the City or on land under the jurisdiction of the Vancouver Park Board;
- 3. Community Gardens are operated with limited funds on a non-profit basis by local residents, many in economically challenged areas of the City;
- Some Community Gardens pay for sewer services they neither receive nor require; the cost of which can represent a financial burden threatening the continued viability of those gardens;

THEREFORE BE IT RESOLVED THAT as a grant, Council require amendments to leases for community gardens on property owned by the City or on land under the jurisdiction of the Vancouver Park Board to delete the requirement to pay for sewer services where there is no actual connection to the sewer system.

#### **NEW BUSINESS**

#### 1. Telus and Telecommunications Workers' Union Dispute (File 1263)

#### MOVED by Councillor Louis SECONDED by Councillor Bass

#### THAT WHEREAS:

- 1. The dispute between Telus and the Telecommunications Workers Union has been going on for nearly two months; and
- 2. this dispute is disrupting customers' telephone service in Vancouver; and
- 3. animosity between the parties is increasing; and
- 4. tensions between picketing TWU members and security guards hired by Telus are reaching dangerous levels; and
- 5. there is no sign of settlement in sight;

THEREFORE BE IT RESOLVED that the Vancouver City Council call upon the Federal Minister of Labour, Mr. Joe Fontana, to use his powers as laid out in Section 108 of the Canada Labour Code to appoint an Industrial Inquiry Commission to look into the causes of the dispute and to make non-binding recommendations to facilitate its resolution.

## ENQUIRIES AND OTHER MATTERS

### 1. City Response to Bedbug Infestation in Downtown Eastside SRO'S (File 4101)

Councillor Roberts requested staff to provide information on what the City is doing and what can it do about the recent infestation of bedbugs in the SRO's in the Downtown Eastside.

Judy Bader, Assistant General Manager, Community Services, reported the City is meeting with VANDU, Coastal Health, and the Vancouver Agreement to identify strategies for a comprehensive approach to deal with the situation.

### 2. Distribution of Garbage Containers (File 3756)

Councillor Woodsworth requested staff to provide information on how the City is proceeding with the distribution of garbage containers.

Brent MacGregor, Deputy City Manager, agreed to provide a memorandum with the requested information.

3. Emergency Preparedness (File 3601)

Councillor Bass enquired whether the City knew what proportion of households have supplies and equipment to handle an emergency such as Hurricane Katrina.

The Deputy City Manager advised Council will receive a Report Reference on Emergency Preparedness at its meeting on October 4, 2005. The requested information will be included in the report.

### 4. Federation of Canadian Municipalities (FCM) Request (File 3253)

Councillor Green advised the FCM has requested the City to provide information on particular equipment to remove pollutants from water. The FCM wishes to provide the equipment as part of its aid to the victims in New Orleans. Councillor Green passed on the contact information to the Deputy City Manager.
