#### ADOPTION OF MINUTES

The Minutes of the Standing Committee on Planning and Environment meetings of October 20, 2005 and November 3, 2005, were adopted.

1. **Vancouver City Planning Commission (VCPC) - Annual Report for the Year 2005**  
(File 3107-1)

The Committee had before it an Other Report dated November 15, 2005, in which the Vancouver City Planning Commission (VCPC) outlined the work undertaken by the VCPC in 2005. The City Manager recommended approval.

Bob Williams, Chair of the former VCPC, reviewed the report and along with Robert Buller, Commission Manager, responded to questions relating to current VCPC staffing, potential impact of the suspension of advisory bodies on various on-going projects including affordable housing, World Urban Forum, and the Neighbourhood Engagement Task Force.

2. 665 East 30<sup>th</sup> Avenue - Request for Injunctive Relief (File 2701-1)

The Committee had before it an Administrative Report dated November 23, 2005 in which the City Building Inspector sought Council approval to seek injunctive relief with respect to the unapproved additions at the rear of the building at 665 East 30<sup>th</sup> Avenue in order to have the building brought into By-law compliance. The General Manager of Community Services recommended approval.

Peter Sweeney, Manager, Building Inspection Branch, reviewed the report.

Janice Ebenstiner and Paul Vanteenen, owners, spoke in opposition to the recommendations.

Speakers' comments included:

- reviewed the history of concerns relating to this property;
- noted inaccuracies relating to the issues, including development permits and discussions with staff;
- requested that pertinent documents be forwarded to them as requested;
- financial implications;
- stated that staff should have pursued this matter with the original owner and filed a 3336D notice on title at that time; proper procedure has not been followed; and
- Minutes of the May 12, 2005 meeting of Standing Committee on Planning and Environment, indicated that staff would assist owners - this has not occurred.

Mr. Sweeney, along with Carlene Robbins, By-law Administration, responded to questions and made the following comments:

- documents not forwarded to owners as formal request not received - will now forward;
- file not lost, but enforcement dropped for approximately two years;
- status of work/permitting, including electrical, noting the owner was advised by staff to arrange for Electrical Branch to have electrical issues reviewed and this was not done;
- legal options of owners, city and real estate agents at time of purchase;
- concerns related to unapproved work, specifically alterations to bathroom and enlargement of third floor;

- timeframes relating to process to date, injunctive relief and next steps; and
- staff will meet with owners to review procedure to bring building into compliance.

**5. Central Valley Greenway Section 1 - Detailed Design (File 5767)**

The Committee had before it an Administrative Report dated November 29, 2005, in which the General Manager of Engineering Services sought Council approval of the detailed design, an increase to the Operating Budget and a report back on the awarding of the construction contract for Section 1 of the Central Valley Greenway.

Scott Edwards, Structures and Greenways Engineer, and Douglas Scott, Landscape Architect - Greenways, reviewed the report and responded to questions relating to routing patterns, cycling pathways/lanes, pedestrian signaling controls, street and pedestrian crossings, safety issues, sidewalk widths, budgeting process, use of resources, bicycle bridge crossing, and rights of way.

Jack Becker, Vancouver Area Cycling Coalition, spoke in opposition to the recommendations. His comments included:

- report should be redone and presented again;
- proposal does not support City's strategic directions relating to environmental sustainability, transportation priorities, commitment to greenhouse gas reduction and Kyoto Protocol;
- proposal does not support in-line skating/skateboard/wheelchair access;
- Central Valley Greenway should provide key residential pathway, but does not;
- proposal does not meet standards of Showcase Design, can be considered false advertising and funding could be jeopardized;
- safety factors, including lighting, are a concern;
- grade not suitable for disabled or in-line skaters;
- motions of advisory committees should be brought to Council independently from reports;
- provided suggestions relating to the bridge from Grandview Highway North and Clark Drive, sourcing of additional funding, the construction contract, the False Creek Planning process, and proposed bike lanes on 1<sup>st</sup> Avenue; and
- recommended staff proceed with the design of Sections 2 and 3 of the Greenway.

Bonnie Fenton, Chair of the former Bicycle Advisory Committee (BAC), expressed concerns regarding the report. Her comments included:

- BAC does not support path on both sides of Great Northern Way as indicated by staff; BAC response to this aspect of the proposal was lukewarm;
- BAC's June 15, 2005 motion is in contrast to what is being presented for Section 1;
- proposal as presented does not meet what was envisioned; and
- an extension should be agreed upon and request for further funding be made.

Tamim Raad, Project Manager, Sustainable Region Showcase, Project Planning, TransLink, responded to questions relating to granting an extension and availability of more funding. He also acknowledged the proposed grade is not acceptable and is an interim measure.

Tom Timm, General Manager of Engineering, along with staff, responded to questions relating to the Showcase program and financial concerns, timeframes and intent of design, impact of physical constraints, grade and accessibility issues, lighting standards and potential for postponing components.

#### 7. Triple R Review (File 3001/1251)

Speakers' comments included:

- advisory bodies are essential to development of City policies and this avenue of communication should not be disrupted;
- Women's Advisory Committee and gendered lens essential to women's health services, advancing women's equality;
- waiting for establishment of this committee is a disservice to women;
- advisory bodies need to continue with important work on current City projects and scheduled events coming to Vancouver while review is in progress;
- some volunteers/committees feel disrespected by this process, while others do not; many do not have quorum problems and believe their work is valued;
- 2003 review resulted in late start for committees; they received direction and requirements for workplans and annual reports and it is too early for another review;
- committees/sub-committees provide expertise/manhours otherwise not available;
- more public education regarding City services needs to be done;
- public should not have been notified of the review through media; insufficient time to formulate response and attend meeting;
- pedestrian, inline sustainability and transit advisory committees should be added;
- concern expressed about Vancouver liveability and importance of cycling infrastructure;
- concern expressed regarding diversity of the proposed review panel;
- review should not go forward until Council's strategic planning process developed;
- staff-dominated review process is inappropriate;
- open government and transparency not in place with this process;
- successful cities run on partnerships with advisory committees;
- if problems exist with specific committees, staff should help them improve;
- Vancouver Heritage Commission (VHC) working on issues including Evergreen Building, Charles Dickens School, 2006 Vancouver Heritage Awards, Victory Square Guidelines;
- applicants waiting for direction from VHC before they continue with their projects;
- without VHC input, development permit process will back up;
- VHC representatives to re-established advisory bodies will not be in place and valuable input lost;

- setting City's overall goals and objectives must be first step before committees can be aligned with those goals and objectives; and
- budget for review should be presented to Council prior to decision on review.

5. Staff report to the January 17, 2006 Council meeting recommending the terms of reference for the Review Panel, with the goal of completing the advisory body component of the Review by Feb 2006.
6. Staff prepare a strategic planning process for Council early in 2006 in order to establish the directions and work plan for this Council.
7. The Review will consider the strategic directions and work plan of Council in making its recommendations.
8. The Review include the examination of current and alternative methods of input for citizen advice to Council and staff that will be the most effective.

  - (b) should be disbanded;
  - (c) the terms of reference of the advisory body should be varied.
4. The Review will consider whether new advisory bodies should be formed.
5. Staff report to the January 17, 2006 Council meeting recommending the terms of reference for the Review Panel, with the goal of completing the advisory body component of the Review by Feb 2006.
6. Staff prepare a strategic planning process for Council early in 2006 in order to establish the directions and work plan for this Council.
7. The Review will consider the strategic directions and work plan of Council in making its recommendations.
8. The Review include the examination of current and alternative methods of input for citizen advice to Council and staff that will be the most effective.

9. The issue of the composition of the Triple R Review Panel be referred to the Regular Council Meeting on January 17, 2006.

4. The City currently has a variety of recognition programs and awards which highlight the contribution of Vancouver artists to our city, including:
  - i. Vancouver Arts Awards
  - ii. City of Vancouver Book Award
  - iii. City of Vancouver Artist Residency Award
  - iv. City of Vancouver Artist Studio Rental Award
  - v. Starwalk/BC Entertainment Hall of Fame
  - vi. Freedom of the City



THEREFORE BE IT RESOLVED:

THAT in the 2006 operating budget the \$18,000 allocated to fund cultural performances at Council meetings be reallocated to increase general cultural grants.
