# **RECOMMENDATION**

# **COUNCIL POLICY**

The City's Mayor and Council Members' Expenses By-law No 8904 requires that a Council member wishing to engage in an activity that is representing the city, engaging in city business or attending a course, meeting or convention outside British Columbia must request Council prior approval. If Council approval is granted, the council member may claim reimbursement for expenses incurred in accordance with the By-law.

#### **PURPOSE**

The purpose of this report is to seek Council's approval for Councillor Tim Stevenson to attend the Federation of Canadian Municipalities (FCM) March 2006 Board Meeting as a representative of the City.

## **BACKGROUND**

Councillor Tim Stevenson is a member of the following Standing Committees of the FCM:

- Municipal Finance and Intergovernmental Arrangements
- International Relations

The terms of membership to the Standing Committees of the FCM are effective for the period of one year, from Annual Conference to Annual Conference, which generally take place in June of each year.

Councillor Tim Stevenson has been attending these Board Meetings since his appointment to the above Standing Committees at the 2005 Annual Conference.

This is the last FCM Board Meeting of the current term.

## FINANCIAL IMPLICATIONS

The estimated costs to be funded from the 2006 Travel Budget are as follows:
