BUSINESS LICENSE HEARING MINUTES

FEBRUARY 8, 2006

A Business License Hearing of the Council of the City of Vancouver was held on Wednesday, February 8, 2006, at 9:30 a.m., in the Council Chamber, Third Floor, City Hall, to determine whether or not a 2006 City of Vancouver business license should be granted to Davprit Sandhu (the "Licensee"), for business premises located at 162 East Hastings Street, Vancouver, British Columbia (the "Premises").

lain Dixon, Legal Services, was present on behalf of the City of Vancouver. Glenn A. Laughlin, Laughlin and Company, was present on behalf of Ms. Sandhu.

Mr. Dixon referred the Panel to the Notice of Hearing contained within the aforementioned evidence package, which noted the license application had been referred to City Council at the request of the License Applicant, upon refusal by the Chief License Inspector of the City of Vancouver to issue a business license to the License Application pursuant section 4(2) of the *License By-law* of the City of Vancouver.

Mr. Dixon advised that section 275 of the *Vancouver Charter* provides for the granting or refusing of a business license to be at the discretion of Council, and noted in making that decision, the Panel can consider whether the business is likely to be run properly, specifically in terms of its impact on the neighbourhood; whether it will cause a drain on police and city resources, and whether it will be able to comply with applicable municipal, provincial and federal legislation. Mr. Dixon also noted that in making its decision, the Panel must give reasons.

Mr. Laughlin noted Ms. Sandhu had taken over the Premises from another person with whom she has no relationship.

In support of the aforementioned reports and evidence, Mr. Dixon called the following witnesses:

Mr. Laughlin also asked questions of witnesses relating to the aforementioned Evidence Brief.

Mr. Laughlin submitted an evidence brief on behalf of the Applicant (*on file in the City Clerk's Office*). In support of the evidence set out in the submitted brief, Mr. Laughlin called the Applicant, Davprit Sandhu, as witness.

Mr. Dixon also asked questions of the Applicant relating to the aforementioned evidence briefs.

The Panel recessed at 12:00 p.m. and reconvened at 12:30 p.m. to resume questioning of the Applicant by Counsel for the City of Vancouver, and to hear closing statements from Counsel for the City of Vancouver and Counsel for the Applicant.

* * * * *

Mr. Dixon noted:

- there have been ongoing problems with the Premises;
- Mr. Karim Nastoh has always been linked to this property;
- misgivings about the Applicant's ability to manage a store in the Downtown Eastside;
- it is likely the Applicant is a figurehead so a business license can be acquired; and
- the proposed business would, likely, be a drain on police and City resources.

Mr. Laughlin noted:

- the Applicant is willing to work with the City;
- the Applicant has asked for assistance in how to address the City's concerns; and
- the Applicant has shown her ability to deal with people and deserves a chance to run a clean operation.

Mr. Laughlin also suggested the license be granted with the condition that Mr. Karim Nastoh not be permitted to work at the Premises.

Mr. Dixon noted the evidence presented at this Hearing agrees with the allegations set out in the Evidence Brief and sets out the legal test which the Panel must apply in determining whether or not a business license ought to be granted to the License Applicant.

PANEL MEMBERS DISCUSSION

Prior to making a decision, the Panel noted the following:

- connections to the previous occupants of the Premises do exist;
- members were not convinced the Applicant has the skills to effectively run a business in the Downtown Eastside; and
- concerns with the contradictory information presented to both the Panel and the Deputy Chief License Inspector over the course of the past few months.

MOVED by Councillor Deal

THAT a 2006 City of Vancouver business license not be issued to Davprit Sandhu (the "Applicant), for business premises located at 162 East Hastings Street, Vancouver, British Columbia (the "Premises"), because:

- a. The proposed business is in the Downtown Eastside where there are a large number of convenience stores already in operation and a significant problem with illegal activities from those convenience stores, which can result from a lack of control and poor business management practices, and causes a drain on police and City resources; and,
- b. The proposed business location has a history of problems caused by poor management and lack of control, the proposed business does not appear to be commercially viable and the License Applicant has not produced a sufficient business plan.

CARRIED UNANIMOUSLY

The Business License Hearing Panel adjourned at 1:42pm.
