#### **BUSINESS LICENSE HEARING MINUTES**

#### MARCH 9, 2006

A Business License Hearing of the Council of the City of Vancouver was held on Thursday, March 9, 2006, at 7:58 p.m. in the Council Chamber, Third Floor, City Hall to determine whether or not a City of Vancouver business license for the year 2006 will be granted to Hong Nhan Truong (the "License Applicant") for a Limited Service Food operation to be located at 654 Kingsway, Vancouver, British Columbia (the "Premises").

A ten-minute recess was called and the Hearing reconvened at 8:10 p.m.

Ms. Catherine Kinahan, Counsel, was present on behalf of the City of Vancouver. Mr. Hong Nhan Truong, the License Applicant, was present and represented himself, with the aid of Mr. Chanh Bui, a certified Vietnamese Interpreter.

This matter was referred to City Council by the Chief License Inspector pursuant to Section 4 of the *License By-Law* of the City of Vancouver.

Ms. Kinahan advised the Panel of their authority in these proceedings pursuant to Section 275 of the *Vancouver Charter* which provides that the issuance of a business license is deemed to be at the discretion of Council. Ms. Kinahan referred the panel to the evidence before it as set out in police reports, documentation and letters from the Deputy Chief License Inspector which were considered by the Chief License Inspector in referring the business license application to Council, and evidence of witnesses, which set out allegations that:

- (a) the application appears to be a sham to obtain a business license for another individual; and
- (b) the proposed business has a history of problems caused by poor management and lack of control, the proposed business does not appear to be commercially viable and the License Applicant has not produced a business plan.

In support of the allegations set out in the aforementioned reports and evidence, Ms. Kinahan called the following witnesses:

Barb Windsor, Deputy Chief License Inspector Angelo Marrocco, Property Use Inspector

In response to questions, Ms. Windsor noted the City would not permit a social club at that location, and outlined options available to the Panel if a license is refused, to have all future business license applications for the premises come before Council and to require the building owner to also come before Council for any future applications. She further noted building owners are notified of problems occurring on the premises.

Ms. Kinahan submitted that one of the concerns expressed was that the lease appeared to pass from one person to another without someone paying for the purchase of the business.

Mr. Truong questioned Ms. Windsor regarding when a business can open its doors once a license has expired.

Mr. Truong submitted that since he did not have a business license when Mr. Marrocco came by, the front doors were kept locked and, that upon receipt of the Inspector's business card, he made an appointment with Mr. Marrocco. Mr. Truong also expressed frustration with the power he felt the City and police have and that he did not want people to put him down as he tries to open a business. Mr. Truong indicated he works in construction while trying to get the store established.

The Panel questioned the License Applicant to help clarify his understanding of the need for a business plan and the City's need for assurance that a proposed business is viable, legitimate

and not a detriment to the neighbourhood, in order to grant a business license. The Panel discussed concerns regarding the likelihood the License Applicant's coffee shop would be operated as a gambling establishment with the same people involved as when past problems occurred.

Ms. Kinahan advised the following:

- a business plan was required because this location has a history of problems;
- concern regarding the License Applicant's association with the people and similar behaviour referred to in the reports;
- the License Applicant's lack of experience and expertise in managing a food service operation;
- it is not a personal reflection on Mr. Truong; however, the City needs to know someone has a viable plan for the business and that the business would not generate complaints and need for police and inspector visits to the premises;
- a previous restauranteur at that location had gone bankrupt and subsequent operations have been unlicensed social clubs;
- it is not fair to the residential neighbourhood to have a social club there; and
- at some point, the building owner has to take some responsibility for the problems occurring at the premises.

Mr. Truong advised he did not want to continue with this business license application and that he did not know there were so many problems until he received the Evidence Brief for this hearing.

The License Applicant abandoned his business license application.

The Business License Hearing Panel adjourned at 9:20 p.m.
