SUBJECT: 2006 Celebration Grants Recommendations, Spring Deadline

#### RECOMMENDATION

THAT Council approve a total of \$107,500 in Celebration Grants to 29 organizations listed in Tables 1 and 2. Source of funds to be the 2006 "Other Grants" budget.

#### **GENERAL MANAGER'S COMMENTS**

The General Manager of Community Services recommends APPROVAL.

#### **COUNCIL POLICY**

Council approved creation of the Celebration Grants program in October 2002 for cash grants to community-based festivals, celebrations and large scale parades.

In July 2003, Council approved the establishment of a new service grant component of the program, which may provide an offset of up to 50% to the cost of city services (police and engineering) incurred by major parades to a maximum sum of \$10,000.

Approval of grant recommendations requires eight affirmative votes.

#### **PURPOSE**

This report recommends grants to 29 organizations, outlines selection processes, discusses the applications in more detail (Appendix A), appends the evaluation criteria in the Program Information Guide (Appendix B), and includes front pages of the applications (Appendix C).

#### **BACKGROUND**

In October 2002, Council established the Celebration Grants program as a means of encouraging and assisting community-based cultural festivals, celebrations and major parades. Through their provision of cultural interaction and entertainment, these events contribute to building a greater sense of community in Vancouver.

In advance of the March 1, 2006 spring deadline, advertisements were placed in community newspapers inviting the public to an information session and directing readers to the web site for program details. The program continues to attract new interest. In spring 2006, five requests were from first-time applicants and three groups returned to the program after a one-year absence with proposals for new and continuing festivals or major anniversary celebrations. Also, one long-standing organization was referred to the program from the Operating Grants program as the festival programming was deemed to be better matched to Celebration Grants.

There were 34 applications received, totalling a combined cash and city services request of \$287,520. Among the 34 total applicant organizations, one also requested \$15,000 in funding from the city service component of Celebration Grants.

Applicants were first screened for eligibility and then, as available, interviewed by OCA staff. A further technical review for operational issues and permit or site requirements was then conducted by representatives from Cultural Affairs, Park Board and Engineering. Some operational and risk management issues were identified during this process that required revisions to the proposals and one organization was recommended to meet with FEST Committee partners.

Applications were then evaluated by an independent three-member Assessment Committee with support from OCA staff. The Assessment Committee consisted of community members with a broad range of experience and expertise with both professional and community-based cultural events. They were asked to assess the submissions against the Celebration Grants program goals and criteria. This report reflects the consensus recommendations of the Assessment Committee members who included:

#### **DISCUSSION**

#### Celebration Cash Grants:

The Assessment Committee recommended funding in this category to 29 applicants as per Table 1, reflecting those projects which best met the evaluation criteria as outlined in **Appendix B**: Celebration Grants Program Information Guidelines.

#### Celebration Service Grants:

The service grants component is available to help offset up to 50% of the cost of city services incurred by major parades a maximum sum of \$10,000. The Assessment Committee recommended funding to one organization in this category as per Table 2.

This summer, staff will conduct a full review of this grant program. This is part of a periodic review of programs and services to measure effectiveness, ensures that the program meets the needs in the community, is accessible and administratively efficient. Community members as well as past Assessment Committee members will be consulted for input. Staff will report back to City Council with any proposed changes to the program prior to the 2007 Celebration Grant deadline.

#### FINANCIAL IMPLICATIONS

As approved by Council, the 2006 Celebration Grants program budget is \$196,250. If the recommendations for this spring round are approved, there would be an unallocated balance of \$67,250 remaining in the cash grant component of the program and an unallocated balance \$21,500 in the city service component of the program.

#### CONCLUSION

The Celebration Grants program provides support to community organizations holding festivals and celebrations throughout the year and throughout Vancouver's neighbourhoods. The program continues to strive to be flexible enough to allow access to new organizations and events while providing encouragement to more established organizations to build both stronger events and organizational capacity.

The Managing Director of Cultural Services notes the importance of the Assessment Committee's expertise, insight, and carefully balanced recommendations and recommends their approval.

#### 2006 CELEBRATION GRANTS RECOMMENDATIONS: FIRST DEADLINE

#### **Arts in Action Society**

A grant of \$1,650 is recommended in support of artist fees for the In the House Festival, which brings artists and community together in non-traditional venues in the Victoria Drive area.

#### Association of United Ukrainian Canadians/Heart of the City Festival

A grant of \$10,000 is recommended for the multi-disciplinary Heart of the City Festival. Coproduced with multiple community partners, including Vancouver Moving Theatre, it which mobilizes the diverse community of Downtown Eastside residents, artists and organizations during a 12-day celebration in October.

#### **Avalon Dairy Heritage Society**

The proposed September County Fair was seen as a strong community outreach tool to celebrate the 100th anniversary of the commercial dairy, but in a competitive round, no grant is recommended.

#### Cedar Cottage Neighbourhood House

A grant of \$4,500 is recommended for programming, event and publicity expenses for the annual Mother's Day Traditional Pow Wow at Trout Lake Community Centre.

#### Collingwood Neighbourhood House

A grant of \$2,500 in support of artist fees is recommended for the 2nd annual Collingwood Days on May 27th.

#### **CRAB** - Water for Life Society

A grant of \$1,850 is recommended for artist fees and event costs for this July 1st celebration in CRAB Park at Portside, which provides a unique focal point for the neighbourhood on Canada Day.

#### Downtown Eastside Safety Society

A grant of \$4,000 is recommended for Sizzling Saturday, a July 22nd celebration which brings together multiple community partners in Strathcona Park.

#### Dr. Sun Yat-Sen Garden Society of Vancouver

A grant of \$3,500 is recommended for programming and publicity expenses for the annual Chinatown Arts and Cultural Festival in July.

#### **Dragon Boat Festival Society**

A request for funding for the 18th annual Dragon Boat Festival was referred to this program from the Operating Grants program. The Assessment Committee thoroughly evaluated the racing and cultural components of this festival and noted its value in the paddling community. However, the Committee expressed concern that the World Beat Stage was not meeting its potential as the main cultural component of a long-standing festival. In the context of a competitive round, no grant is recommended.

#### **Dunbar Residents' Association**

A grant of \$1,000 is recommended toward the production of the Salmonberry Days calendar, the major promotional tool of the 9th annual community celebration, to be held throughout May.

#### East Vancouver Celebration Society

A grant of \$4,500 for performer fees and event costs is recommended for the June 18th Commercial Drive Community Festival, which celebrates the neighbourhood's diversity, and its pedestrian and family-friendly character.

#### False Creek Watershed Society

A grant of \$1,000 is recommended to this new society toward publicity fees and event costs for the 3rd annual Salmon Celebration held in the South East corner of False Creek on September 24th.

#### Fiji Indian Association of BC

While the impact of the annual Fiji Festival in the Fijian Indian community was recognized, the Assessment Committee had outstanding questions about the clarity of the organization's financial management and liability insurance coverage for the proposed event. No grant is recommended.

#### Frog Hollow Neighbourhood House

A grant of \$3,000 for event costs is recommended for the October 28th Pumpkin Patch in the City celebration, a multi-faceted family celebration serving newcomer residents from surrounding neighbourhood houses and the immediate area.

#### Hellenic Canadian Congress of BC

A grant of \$5,000 is recommended for performer fees and event costs for Greek Day, a free community celebration on June 25th.

#### Hungarian Cultural Society of Greater Vancouver

A grant of \$2,000 is recommended for production and publicity expenses for the society's commemoration of the 50th anniversary of the Hungarian Revolution on October 21-22 at the Hungarian Cultural Centre.

#### **Hungarian Reformed Church of Vancouver**

The Assessment Committee evaluated a proposal to commemorate the 50th anniversary of the Hungarian Revolution as well as the 10<sup>th</sup> anniversary of the organization. As the Committee reviewed two proposals to commemorate a significant anniversary in the Hungarian community and with this request having a more religious focus (religious ceremonies are not eligible), in the context of available funds, no grant is recommended.

#### Latinos in Action Vancouver Foundation

A grant of \$6,000 is recommended towards publicity fees and event costs for this free event on August 20th, which celebrates the diversity of Latin culture through arts, music and food.

#### Little Mountain Neighbourhood House Society

A grant of \$2,000 is recommended for Many Faces: One Community, a multicultural and youth-focused celebration, on June 11th at the Riley Park Community Centre.

#### Main Art Drift Society

A grant of \$2,500 is recommended for the marketing and publicity of The Drift, an annual open studio tour and celebration in Mount Pleasant's Artist Live/Work neighbourhood that showcases artist's work in over 80 local studios and businesses during the first weekend in October.

#### Mount Pleasant Family Centre Society

A grant of \$1,500 towards performer fees and event costs is recommended for the one-time 30th anniversary celebration of Mount Pleasant Family Centre on July 27th at Robson Park.

#### Pandora's Collective Outreach Society

A grant of \$2,000 is recommended towards publicity fees and event costs for the 3rd annual Summer Dream Reading Festival on July 22nd, which showcases grassroots spoken word, poetry, storytelling and musical performances at Robson Square.

#### Philippine Festival Association

While the impact of the festival in the Philippine community was recognized, the Assessment Committee noted the balance between cultural and political activities did not best meet the program objectives. The organization is encouraged to further develop its outreach and programming to reach out to a wide general public. In the context of a competitive round, no grant is recommended.

#### South Asian Family Association

A grant of \$4,500 is recommended for artist fees and event costs for the annual South Asian Sawan Mela celebration on June 25th at the Plaza of Nations.

#### South Vancouver Neighbourhood House/Vancouver Celebrates Diwali

A grant of \$7,000 is recommended for programming and administrative costs of Vancouver Celebrates Diwali, a multi-faceted celebration of the South Asian festival of light held in October at various community venues.

#### Stanley Park Bike Festival Society

A grant of \$2,000 is recommended for participatory workshops and cultural programming expenses of the Stanley Park Bike Festival on June 17<sup>th</sup> including children's entertainment, musical and theatrical groups that incorporate cycling into their work.

#### Still Moon Arts Society

A grant of \$7,000 is recommended for programming costs and publicity fees for the October 7th Renfrew Ravine Moon Festival, which combines a neighbourhood harvest fair with community and professional arts performances and lantern installations in Renfrew Park.

#### **Turtle Island Professionals Society**

While acknowledging the significant potential of the proposed event, the Assessment Committee noted the lack of confirmed partnerships, logistical planning and revenue sources to effectively coordinate and support this event within the short timelines proposed. No grant is recommended.

#### Vancouver Dyke March and Festival Society

A grant of \$4,000 is recommended for publicity and programming costs of the August 5th Dyke March and Festival, which culminates in an all-ages afternoon music festival for queer women, their families and supporters at Grandview Park during Pride weekend.

#### Vancouver Métis Community Association

A grant of \$4,000 for production costs is recommended for the August 12th Celebration Métis, an outdoor celebration of Métis culture and heritage held in the downtown core.

#### Vancouver Multicultural Society

The Assessment Committee noted the society's significant achievement in establishing the inaugural pilot festival with very short timelines and considerable expense. While acknowledging that the proposed Diversity Festival could provide a platform for the society to enact its mandate to promote cross-cultural understanding, the Assessment Committee expressed concerns around festival's sustainability due to the high fees charged to the organizers by commercial production companies to deliver the event. In the context of available funds, no grant is recommended.

#### Vancouver Pride Society

The Assessment Committee recommended a cash grant of \$7,500 towards the annual Pride parade and festival. A service grant to cover up to 50% of police and engineering costs for the parade is also recommended (up to a maximum of \$7,500).

#### Vancouver Wooden Boat Society

A grant of \$4,000 is recommended for artist fees and publicity costs for the 19th annual festival on Granville Island August 24-27th.

#### West End Senior's Network Society

A grant of \$1,500 is recommended for artists fees and production costs for the June 24th Strawberry Festival.

# CELEBRATION GRANTS

### **Program Objectives**



This program is for community-based festivals, cultural celebrations and large parades, in recognition of the entertainment they offer and their contribution to a sense of community among residents of diverse cultures, ages and interests.

Assistance with specific costs is available to help community-based not-for-profit societies to present these events, which may include programs of music and performance, crafts, exhibits, culinary and other cultural expressions of the community.

# Who can apply?

- □ registered as not-for-profit societies in British Columbia for at least six months
- □ located in the City of Vancouver (not in other Lower Mainland municipalities or the University Endowment Lands)
- □ have a cultural mandate which includes organizing festivals, celebrations or large scale parades in Vancouver

Examples of organizations that can apply include neighbourhood houses, resident associations, community service groups, ethnocultural societies, or arts and cultural organizations. Although Business Improvement Associations are not eligible on their own, community events they co-sponsor with not-for-profit community organizations are eligible.

#### The following are ineligible to apply:

- □ civic departments or branches (i.e. community centres, libraries)
- □ organizations receiving City of Vancouver cultural grants or those who would be eligible

# What types of events are eligible?

Three types of events, organized for the purpose of building and celebrating a sense of community and held primarily for the benefit of Vancouver residents, qualify for assistance:

- □ **Festivals:** annual or biannual events of at least two days, actively programmed around a theme related to cultural expression in the broadest sense, for example, through music or other performances, crafts, displays, cooking, or demonstration of cultural traditions.
- □ **Celebrations:** one-day events, generally held outdoors, and actively programmed around a theme, anniversary, or other occasion, with a significant cultural component in the broadest sense.

	<b>Major parades:</b> one-day events with a large audience and a significant cultural component, broadly defined to include music and other performances, costumes, floats, banners, arches and installations, or other pageantry elements.
	Please note: To qualify as "major" a parade must have an event budget of over $\$15,000$ ; attract, or have the potential to attract, an audience of over $10,000$ ; and have $20-25$ organizations registered as entrants.

W	hat can grant funds be used for?

The Celebration Grants program has two components. The first provides for cash grants to festivals, celebrations and parades. Funds may be applied toward one or more of the following:

- □ **Programming costs:** for example, performers' fees; display and exhibit costs; equipment rental; production technician's fees; costume creation, rental or cleaning; site decoration; parade floats and other pageantry elements.
- □ Staff and administrative costs: for example, planning and co-ordination, fundraising, and event management.
- □ Publicity and marketing: for example, development of marketing strategies; press kits; design and production of advertising for print, radio, television, and web sites; and purchase of advertising in mainstream and/or ethnic media.

Please note: Individual grant amounts will range from \$1,000 to a maximum of \$10,000, depending on the scale of the event. Events with significant city-wide audiences, collaboratively organized by multiple community partners, may request a larger grant.

The second component of the program provides for service grants to major parades. Up to 50% of the cost of services provided to major parades by the City is eligible for a grant. Service grants apply to police or engineering services such as traffic signs, barricades, and sanitation. The cost of Park Board, Coast Mountain Bus Company, or BC Ambulance services are not eligible.

Please note: The total annual budget for service grants to parades is \$25,000. Major parades may request up to 50% of their anticipated City service costs; requests may not exceed \$10,000.

### How to apply

To obtain an application form, please contact Office of Cultural Affairs (OCA) staff, who manage the Celebration Grants program. Organizations must establish their eligibility for funding with OCA staff well in advance of submitting an application.

- □ To be considered for a grant, an organization must complete, sign and submit an original application form, together with three complete copies of the application as well as one original and three photocopies of all the required attachments.
- □ Organizations planning events on city streets or in parks must have all required approvals and permits from the Special Events Office or from the Park Board to hold their event in these locations.
- □ Under normal circumstances, the application, review and decision process takes eight weeks. Cash grants will generally be paid out within three weeks of Council approval. Service grants approved by Council for major parades will be applied to the cost of eligible City services up to a maximum of 50% following the event.

# How will applications be evaluated?

Since funds are limited, not all organizations meeting the eligibility criteria can be supported. This is a competition, based on the following evaluation criteria:

- Does the applicant provide evidence of confirmed revenues from sources other than the City of Vancouver? Revenues may include earned income from tickets and concessions, sponsorships, donations from individuals, businesses or community groups, memberships, in-kind donations, and support from foundations and government agencies.
   Does the event provide unique opportunities for the public?
   What is the quality of the programming? Does it demonstrate creativity, the involvement of persons with appropriate expertise, authenticity in presentation of cultural traditions, or uniqueness in expressing the character of a community or neighbourhood?
   How complete is the plan for delivering the event, including site or venue requirements, and engagement of key organizers? How complete is the budget; are there commitments from other sources of support? Is there a demonstrated need for a grant?
   If the application is for marketing assistance, what are the plans, resources and capabilities of the applicant for reaching a city-wide public, including diverse communities? Does the event have the capacity to attract and engage an audience and/or develop a new audience?
- ☐ How successful were previous events?
- □ Is there adequate administration, a functional Board of Directors and financial accountability?
- □ What is the level of community support and involvement, for example, public attendance, number of volunteers, and donation levels?
- ☐ Have impacts on the surrounding neighbourhood been considered and addressed?
- ☐ How effectively have major parade organizers managed their event in the past? What plans are in place to improve management, and control or lower the need for City services?
- ☐ How will grant funds support the growth and sustainability of the event?

### Review process

- □ Cultural Affairs staff ensure that applications are eligible. City staff on the FEST committee and Park Board are consulted on operational impacts, site issues and permits. When possible, interviews with applicants are arranged.
- □ A grant program assessment committee of community members and individuals with event management experience reviews the proposals and provides comments. Staff then submit a report with recommendations for Council's approval, and notify applicants of the recommendations and the Council meeting date on which grants will be considered.

#### Conditions of Assistance

- □ Societies must provide their most recent financial statement within six months of their fiscal year end.
- Uvoting members of the applicant's Board of Directors must not concurrently hold paid staff positions, nor be paid for their services to the society. They may be reimbursed for expenses.
- ☐ The organizers must develop and promote the event and extend its services to the general public in the City of Vancouver in a non-discriminatory way.
- □ Support from the City of Vancouver must be appropriately acknowledged on all promotional materials related to the funded event, including brochures, print ads, programs, posters, signs, and media releases.
- ☐ The term of the grant is one year, and only one Celebration grant application per City fiscal year can be submitted. Previously funded projects must be completed before a new application can be accepted.
- □ Receipt of a grant does not imply funding in the following fiscal year.

The concept of the festival is to have a multitude of performances within people's homes and back yards. Performances consist of music (including folk, hip hop, world, and classical), theatre, dance, spoken word, story-telling, and comedy. The proximity of the audience to the performers creates a warm sense of intimacy that is rarely, if ever found in traditional venues. A relationship is created and both artist and audience come out with a new appreciation for what performance means.

The purpose of the festival is threefold. First, it aims to create an awareness of the immense variety of performing arts that exist in Vancouver through culturally and stylistically varied acts. Second, it aspires to create a community feel, bringing in an audience from all parts of Vancouver and creating non-threatening venues where everyone can connect and appreciate the arts. Third, it seeks to bring recognition and exposure to Vancouver-based artists in a non-traditional way.

Dunbar Salmonberry Days 2006 looks at how we get around!

Dunbar's neighbourhood environment festival is now in its 9th year. This year, as in the past, we will host dozens of small events and activities celebrating spring and raising our community's awareness of the connections between nature and the city. Salmonberry Days is organized entirely by volunteers and all events are offered free or at a nominal charge.

This year we have chosen an overarching theme for our festival. We will consider all the different kinds of "corridors" that exist within a community. For example we will take a close look at boulevards with heritage potential, the Blenheim Street traffic calming project, the proposed Pine Alley Greenway – as well as the Pacific Flyway used by migratory birds (located right over Dunbar) and the buried Head-of-the-Lake creek once used by salmon and trout to get to their spawning grounds in Dunbar. These and many more "corridors" will be highlighted with site visits, interpretive walks, work parties and more.

Another new activity we are introducing this year is "nature journaling." We will hold two workshops early in the month at the Dunbar Community Centre where participants will learn different ways of documenting their nature observations during the nature walks and talks held as part of Salmonberry Days. At the end of the month participants will meet again to chart their nature observations on a large map for a display at the Salmonberry Days Fair on Sunday, May 28th. As a supplementary tool we are producing printed base maps of Dunbar. Our primary objective is to celebrate BC Rivers Day in Vancouver, by recalling our heritage as residents of a once rich wilderness where salmon used to thrive. Thus we are "Remembering our History" by focusing on an area of Vancouver that has lost much of its connection with its natural roots and by paying tribute to the lost streams that once wound through this neighbourhood. One hundred and fify years ago, the SE corner of the present False Creek drained many fish-bearing streams and the eastern part of False Creek was a vast mudflat extending to the present day Clark Drive. Today it is a crowded residential and light industrial neighbourhood with no natural ecosystems. In face of this change, the Celebration strengthens our cultural links to the salmon and their environment.

Our second objective is to emphasize how the choices we make today influence our collective environment in the future. We are "Celebrating the Living" by calling attention to the role people in the urban centres continue to play in the drama of the salmon's life cycle, and helping Vancouverites understand why urban sustainability is very important in the hearts and minds of us all. The Stanley Park Bike Festival is a community cycling event organized by the Stanley Park Bike Festival Society. It is the highlight of Vancouver's city wide Bike Month Celebration (organized by Better Environmentally Sound Transportation BEST) in June each year. It has been taking place at the Brockton Point area of Stanley Park annually since 2003. The mission of the festival is to bring attention to cycling as the heart of an active community: as a sustainable and environmentally friendly form of transportation, a recreational activity, a form of artistic expression, and a sport. Cycling has a long history in Vancouver and has many different forms, all of which the festival wants to celebrate. The festival will include entertainment, education and participatory cycling events for children and adults. The strength of the event is that cycling is an activity that a large number of Vancouverites can relate to. The festival is an opportunity to address cycling as a lifestyle changing activity: from the saddle of a bike one's perception of oneself, the city and the landscape changes. The City Celebration Grant funding will be earmarked for several key areas of the Budget. \$1000 will go to promotions of the event in the form of Advertising in Bus Shelters, on busses and Skytrains. This is part of a \$3,300 total bus shelter printing budget. \$1000 will go towards the pre-festival workshops, ensuring that the facilities and materials and facilitators are available.

The remaining \$3000 will be held for expenses for the cultural programming of the festival.

The cultural programming aims to bring professional groups that incorporate cycling into their work, the expenses would go towards the stage rental and other rentals to support entertainment facilities.

The long term vision is that the festival will eventually operate self sufficiently with all professional services paid for by the festival's own income generating activities such as sponsorships, the criterium race registration, Tee-shirt sales, raffles, membership sales, and expo site rentals.

The Renfrew Ravine Moon Festival arose out of a desire to bring attention to the urban wilderness of Renfrew Ravine, to provide an opportunity for the community to celebrate together and to honour multicultural harvest traditions such as the Fall Fair and the Asian Mid-Autumn celebration. Planning and outreach begin in the Spring and continue into the Summer and Fall with numerous skills-building workshops and work parties such as ravine stewardship, lanterns, stilt-walking, music, choreography, fire spinning, and event management. Children, youth, families, and seniors all participate and some workshops are held in Cantonese. Many diverse community groups support the festival with their outreach networks and special skills.

Based on the success of the Fine Arts Daycamp and the Renfrew Community Performance Project's involvement in the festival in 2005, we will continue developing the participation of our perfoming groups with more original music and choreography performed by community members partnered with and mentored by professional artists. This year we plan to add a choral element and storytelling and visual art elements in a project called "Reflections on Water". We plan to collect stories from residents about their memories of water from their childhood and their home countries. These stories will become part of storytelling sessions, lantern and visual art pieces, lyrics for the choir to sing,and be building blocks to think about our relationship to water and the global issues about access to clean water. Our goal is to make beautiful art and music, enjoy our diverse community together, savour our environment, and start thinking about broader issues - how they affect us, and how we can affect them if we work together. The Library is willing to host some talks on water. On June 13th, 1886 the newly incorporated, bustling City of Vancouver was almost destroyed by the Great Vancouver Fire. A clearing fire in Yaletown blazed out of control and within thirty minutes the young townsite of Vancouver was burnt to the ground, and less than a dozen buildings were left standing.

The Squamish Nation's recollection of 'The Great Vancouver Fire' of 1886 is one of the most captivating and little known true stories of the Pacific Northwest. The Aboriginal people who lived at Ustlawn (Ots-a-lawn) or the 'Mission Reserve' in North Vancouver could see from the smoke and flames of the fire that there would be many people needing help and assistance across the inlet. Heeding the traditional teachings of Squamish (and Aboriginal) culture, in which help is always given to those in need, the community assembled, canoes launched, a sacred prayer song composed which asks the Creator to have pity on all of us human beings, and the dangerous inlet crossed. Many survivors of the fire were paddled to safety on the North Shore by the Squamish, who were also instrumental in keeping the young town going and helped to re-build the City of Vancouver. The sacred 'Paddle Song' is still sung to this day.

The Squamish Nation's assistance to the people of Vancouver 120 years ago will be commemorated by the inaugural re-enactment of the event by Squamish Nation and urban Aboriginal Youth on Sunday, June 18th, 2006, called "Si'em:One Mind One Heart' Sacred Canoe Ceremony & Celebration". 50 Youth will set off from Waterside Park in North Vancouver, where they will be honoured with a traditional Squamish ceremony, songs and drumming before and as they depart in traditional canoes for the City of Vancouver. More than 50 canoes from the region will accompany Youth as they cross Burrard Inlet. Upon arrival at Crab Park at Portside, Youth will be welcomed to Vancouver by Hereditary Chiefs of the Squamish Nation (Musqueam, Kwayhquitlum, Tsawwassen, Tsleil-Waututh and Squamish), elected dignitaries including the Mayor of Vancouver, Premier of British Columbia and Prime Minister of Canada, and Aboriginal & Chinese Canadian Veterans. Crab Park will be transformed into an Indian Village on June 18th, with tipis in the east, a traditional smokehouse surrounded by Aboriginal people in traditional outfits displaying their skills in weaving, smoking fish, carving, storytelling, beadworking, singing, etc. in the south, and a Pacific Northwest dwelling in the west.

The West End Seniors' Network (WESN) Strawberry Festival is an annual outdoor event held in Barclay Heritage Square and Barclay Manor in June, in time for the local strawberries and summer. As an event predominately organized and run by seniors, the Strawberry festival is a unique space where seniors are able to set the agenda for community interaction. The event is meant to raise community awareness and promote intergenerational, intercultural and social opportunities for neighbourhood residents as we welcome the coming of summer.

The West End Seniors' Network (WESN) has been providing support and services to seniors in the West End since 1979. We offer social and recreational programs, information and referral services, educational opportunities, social support, advocacy and an enhanced sense of community for seniors 55+ living in the West End of Vancouver.

This year the Strawberry Festival is scheduled for June 24, 2006 from 1:00 to 4:00pm. The park will be set up with: an information fair composed of West End community groups; craft and bake sales; a bocce and croquet tournament; an entertainment area; a children's activity corner; and an eating area.

Funds from the Celebration Grant would be used for advertising, entertainment, children's activities, sound system rental, tent rental, poster production and to hire extra staff for the day. In past years the festivals' size and atmosphere has depended on donated goods and services. The Celebration Grant that we received in 2005 enabled the festival to grow. Anticipating that a crowd of a similar size will attend in 2006, we have built extra staff wages into the budget. In 2005 we had a crowd of between 300 – 350 people which generated intergenerational interactions, something that is rarely found in the urban context. We hope that this year, if we receive your support, we will be able to improve upon the level of quality that was achieved in 2005.

This is a neighbourhood festival meant to celebrate the diversity of the West End, highlight our seniors, celebrate summer with strawberries and celebrate Barclay Manor and Barclay Heritage Square.
