SUBJECT: 2006 Community Services Grants Allocations - Report 2

RECOMMENDATION

- A. THAT Council approve 65 Cost of Living Inflation Adjustment increases to previously approved Community Services Grants, totalling \$48,009, including any recommended CONDITIONS on the grants, as listed in APPENDIX A-1. Source of funding is the 2006 Community Services Grants budget.
- B. THAT Council approve increases to support additional services to 9 Community Services Grants, totalling \$62,248, including any recommended CONDITIONS on the grants, as listed in APPENDIX A-2. Source of funding is the 2006 Community Services Grants budget.
- C. THAT Council approve Direct Social Services Grants for an additional 6 months, totalling \$30,760, including any recommended CONDITIONS on the grants, to 3 organizations that were previously approved for 6-month termination grants, as listed in APPENDIX A-3. Source of funding is the 2006 Community Services Grants budget.
- D. THAT Council approve 2 new Direct Social Services Grants, totalling \$18,750, including any recommended CONDITIONS on the grants, as listed in APPENDIX A-4. Source of funding is the 2006 Community Services Grants budget.

CITY MANAGER'S COMMENTS

The City Manager RECOMMENDS approval of A to D.

COUNCIL POLICY

On April 6, 2006, City Council approved the final 2006 Community Services Grants Budget of \$3,826,100.

On July 20, 2004, City Council approved some minor revisions to the current policy, which was established in 2003.

On October 9, 2003, City Council approved, as policy, a number of revisions to establish the current Community Services Grants program, including:

- the creation of three categories of Community Services Grants;
- three sets of eligibility criteria which apply to each of the categories of Community Services Grants;
- priorities for the Direct Social Services category of Community Services Grants.

On that day, Council also reconfirmed, as policy, other aspects of the Community Services Grants program, including: Basic Eligibility Criteria, Ineligible Services, Core Funding Guidelines, Rent Subsidy Grants, and the Reconsideration Process.

In June, 1993, City Council decided that rent subsidies to social service or cultural organizations, occupying City-owned property, held in the Property Endowment Fund, will be provided as grants. Rent Subsidy grants must meet the same eligibility criteria as regular Community Services Grants.

Approval of grant recommendations requires eight affirmative votes.

SUMMARY

This report includes recommendations for the 2006 Community Services Grants allocations for the balance of \$178,700 in the 2006 CS Grants budget. Staff are recommending the approval of: Cost of Living increases to 65 applicants, noted in Recommendation A-1, and 9 recommendations for increases to priority applications, noted in Recommendation A-2. Staff are also recommending additional 6-month Direct Social Services Grants for the 3 organizations that were previously approved for 6-month termination grants. In addition, staff are recommending 2 new Direct Social Services Grants.

Groups requesting reconsideration have been removed from this report and will be the subject of a separate report which is scheduled for June 15, 2006.

PURPOSE

This report provides information about the Community Services Grants program, the review process and this year's applications. This report recommends 2006 Community Services Grants allocations for the balance of the 2006 CS Grants budget.

BACKGROUND

The City's Community Services Grants program was established in 1978. The current program has 3 streams: Neighbourhood Organization Grants (NO), Organizational Capacity Building Grants (OCB), and Direct Social Services Grants (DSS). The Neighbourhood Organization Grants support the core staff in organizations which serve all population groups in a neighbourhood, and which can also demonstrate community capacity building and development activities. Organizational Capacity Building grants are for groups whose purpose it is to assist other non-profits to function more effectively. The Direct Social Services Stream has always been the largest component of the CS grants program. It supports the activities of non-profit groups which work with disadvantaged populations to address defined social needs. These groups are expected to engage in active partnerships with other groups and to provide culturally appropriate and accessible services. Council has established eligibility criteria for each stream and also has an approved set of priorities for the assessment of DSS applications.

Based on the information provided by applicants recommended for funding in 2006, CS Grants recipients provide services to more than 194,000 clients who are residents of Vancouver.

Funding Partnerships

All funded agencies also receive grants from other sources and/or their own fundraising activities. The Community Services Grants provide targeted support to strengthen the social infrastructure and to assist services which respond to City priorities e.g. outreach to isolated seniors; the development of culturally appropriate and accessible services; programs which provide information and support to low income/single parent families. Funding partnerships between the City and other government/foundation funders can be on an organizational basis or be cost-sharing of a specific program. In the case of Neighbourhood Houses, for example, City funding and United Way funding support the core positions and the houses are responsible for raising the bulk of their substantial program and project funding from other sources. Alternatively, the City and another funder may join forces to provide a program which both see as high priority e.g. seniors' peer counselling; community capacity building and outreach to isolated residents in the Downtown Eastside. The CS grant never pays the full cost of any program: the funded agency always contributes to the costs, sometimes substantially. These varied partnerships ensure that the Community Services Grants contributed by the City support work that is far broader than the actual dollar amount provided.

Volunteer Involvement

The use of volunteers to support community groups and their programs is essential. The community groups recommended for 2006 Community Services Grants had more than 45,000 volunteers who provided more than 2,000,000 volunteer hours in 2005. The economic contribution of this volunteer work was over \$39 million in 2005. (This figure is calculated using a Department of Canadian Heritage formula of multiplying the number of volunteer hours by the average wage (\$19.24) of British Columbia in 2005.)

Some CS grant applicants specifically request grants to support the recruitment and coordination of volunteers. Agencies are generally finding that it has become increasingly difficult to recruit volunteers and it requires much creativity on the part of community groups

to recruit and retain volunteers. A number of City-funded groups are using their volunteer programs to help marginalized clients develop their skills and gain the confidence to move toward paid employment. The effect of the City's CS Grants funding is magnified by the work of contributions of volunteers.

2006 Community Services Grants Applications and process to date

In 2006, the City received 111 CS grant applications from 93 organizations, requesting \$4,960,420. Table A below, shows the number of applications in each of the 3 grant streams, compared to applications received from 2002 to 2005. The City also received 9 new applications in 2006.

Council approved a 2006 Community Services budget of \$3,826,100 on April 6, 2006. On April 18, 2006, Council approved the first phase of recommendations for the 2006 CG Grants program totalling \$3,647,400.

The April 18th report contained staff's initial recommendations for 6-month grants to 96 applications, plus an additional recommendation for approval of another 6 month's funding to these same groups. Council approved these recommendations. Council also approved 6-month terminating grants to 3 organizations at this time.

The balance remaining in the 2006 CS Grants budget is \$178,700.

In the CS Grants report of April 18, 2006, staff indicated that the applications of all applicants would be reassessed to make recommendations on the remaining funds. This process would include a re-assessment of the terminating grants, requests for Cost of Living Adjustments, increases for high priority applications, new applications, and an emergency reserve.

DISCUSSION

Allocation of the Remaining 2006 Community Services Grants Budget

As of April 18, 2006, the unallocated balance in the CS Grants budget is \$178,700. Staff reassessed the applications of all applicants in order to make the additional recommendations for grants to community groups.

The remaining balance for the CS Grants budget provides the ability to make recommendations that are greater than those that were originally approved. Staff considered the following factors in making the recommendations for the additional allocations to the 2006 CS Grants applicants contained in the report:

- The 2 percent Cost of Living Inflation Adjustment on the 2006 CS Grants budget that was approved by Council, would be passed on to those organizations that requested this increase, allowing them to maintain the real value of their grant.
- Staff reviewed all applications and are making recommendations for increases to 9
 programs which most strongly respond to City grant priorities, including CONDITIONS
 or comments with respect to the purpose of these increases.
- Two new applications which address high priority needs are recommended, including CONDITIONS or comments respecting the purpose of the funding.
- Three community groups that received 6-month terminating grants in the first report are now recommended for additional funding, with CONDITIONS which are intended to ensure that the work of these groups more strongly responds to the City's priorities for CS Grants.
- Should Council approve all the above-noted recommendations, there will be an unallocated balance of \$18,933 in the 2006 CS Grants budget to address requests for Reconsideration or unforeseen emergencies that may arise during the rest of 2006.

Reconsideration process

Five applicants have advised us that they wish to request Reconsideration. They are the Aboriginal Mother Centre, Downtown Eastside Safety Office, Knowledgeable Aboriginal Youth Association (KAYA), Network Two Community Services Society and Philippine Women Centre. These applications have been removed from this report and will be forwarded to Council in a separate report on June 15, 2006. By Council policy, groups may request Reconsideration for only two reasons: that staff have misinterpreted their eligibility for a CS grant, or that staff have misunderstood the group's financial situation. Groups wishing Reconsideration are required to submit a letter outlining the reasons for their request. Social Planning assigns a staff person other than the staff who reviewed the initial application, to review the Reconsideration request. The Council report on June 15, 2006, will contain the applicant's letter plus written comments for staff and a staff recommendation. Applicants may address Council at this meeting. Any funding which staff would have been recommending in the May 18th report is added to unallocated balance of \$18,933 noted above.

Staff note that this year's Reconsideration process is unusual, in that Council has already approved 12 months' funding to one of the organizations now requesting reconsideration. The only element of this grant which can be reconsidered this year is any additional funding that might have been recommended in the May 18th report. The other four groups requesting reconsideration were not recommended for funding.

RECOMMENDATIONS SUMMARY

The following is a summary showing a comparison between 2005 and 2006. The 2006 recommendations include the approved Recommendations from Report 1 and the additional Recommendations for Report 2. The table also shows the number of groups in each stream which are not recommended. The five groups requesting reconsideration are not shown in the table.

FINANCIAL IMPLICATIONS

The recommendations for additions to the Community Services Grants in this report total \$159,767, with the source of funds being the 2006 Community Services Grants budget. This leaves an unallocated balance of \$18,933 for Reconsiderations or emergencies.

CONCLUSION

This report makes additional grant recommendations for the 2006 Community Services Grants program.
