**THAT WHEREAS** the registered owner will be conveying to the City of Vancouver for road purposes lands in the City of Vancouver, Province of British Columbia, more particularly known and described as follows:

All that portion of Lot 12, except the West 7 feet now road, Block 9, West ½ of District Lot 738, Plan 1681, Group 1, New Westminster District, as shown heavy outlined on plan of survey completed July 5, 2006, attested to by Eric I. Kaardal, B.C.L.S. and marginally numbered LB868, a print of which is attached hereto.

**AND WHEREAS** it is deemed expedient and in the public interest to accept and allocate the said lands for road purposes.

**BE IT RESOLVED** that the above described lands to be conveyed are hereby accepted and allocated for road purposes and declared to form and to constitute a portion of a road.

(Establishing Road on the east side of Knight Street, between 49<sup>th</sup> Avenue and 51<sup>st</sup> Avenue, adjacent to 6580 Knight Street, for a widening strip for the installation of left turn bays on Knight Street at 49<sup>th</sup> Avenue, as per June 13, 2006 Council authority)

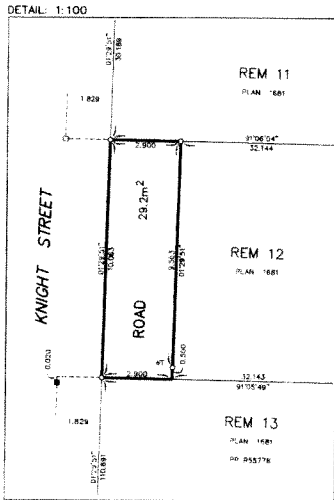
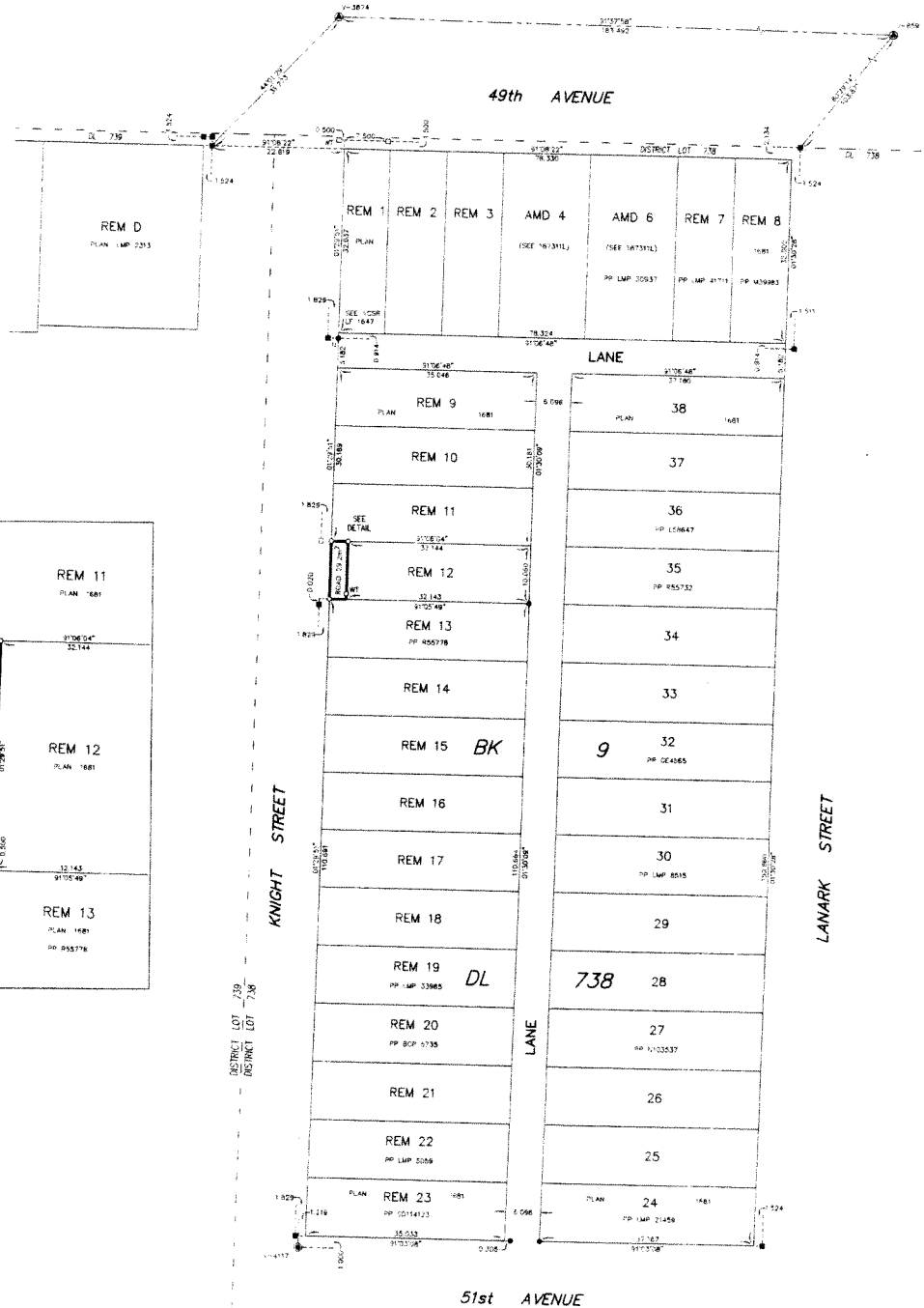
